Continuation of 3. NOTE: proposed amendment including of "the planar protective layer uniformly covers the defects prior to the step of thinning" raises new issues that requires further consideration and/or search.

Continuation of 11. does NOT place the application in condition for allowance because:

- ▶ Rejection using Hak reference can not overcome by Affidavit under 37 CFR 1.131 since Exhibit A with a copy of a "Process, Status and Management Report" for research on "Antinonide Based Compound Semiconductors (ABCs) fails to support the planar protective layer.
- ▶ The claimed invention would have been obvious over Fujisada et al in view of Moshrefzadeh et al since the claimed shaped of the planar protective layer was a matter design choice because of absence that the planar protective layer would yield unexpected result. Moreover, using the planar protective layer to uniformaly cover defects in process removing defect has been known in the art (see Moshrefzadeh et al as an evidence)
