DETAILED ACTION

This Office Action is in response to Applicant's Amendment dated 12/14/2008.

EXAMINER'S AMENDMENT

2. Claims 1-5, 9-12, 18-23 and 33 are allowed.
3. The following is an examiner's statement of reasons for allowance: Recorded Prior Art fails to disclose or suggest combination process steps of method for removing defects from a semiconductor surface as characteristics in base claim 1 comprising: coating the semiconductor surface and the defects with a protective layer, wherein the protective layer has a completely planar top surface covering top portions of the defects, and wherein the semiconductor surface and the defects are composed of the same

material; thinning the protective layer to selectively remove a portion of the protective layer wherein remaining portions of the protective layer partially reveal top portions of the defects.
