DETAILED ACTION

1. This action is in response to the RCE filed on 09/19/2008.
2. The rejection under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention to claim 12 and 15 is moot in view of applicant's amendment.
3. The rejection under 35 U.S.C. 102(b) as being anticipated by Rodriguez (U.S. 6,487,718) to claims 1-2, 4-6 and 9-16 is moot in view of applicant's amendment.
4. The rejection under 35 U.S.C. 103(a) as being unpatentable over Rodriguez (U.S. 6,487,718) in view of Lau (U.S. 7,191,435) to claim 3 is moot in view of applicant's amendment.
5. The rejection under 35 U.S.C. 103(a) as being unpatentable over Rodriguez (U.S. 6,487,718) in view of McCaleb (U.S. 6,751,794) to claims 7 and 8 is moot in view of applicant's amendment.
6. Claims 1-16 have been canceled.
7. Claims 17-25 have been added.
8. Claims 17-25 are pending.
9. Claims 17-25 are allowed, renumbered 1-9.

REASONS FOR ALLOWANCE

11. The following is an examiner's statement of reasons for allowance:

The cited prior art taken alone or in combination fail to teach, in combination with the other claimed limitations, inserting a code of said software-updating patch into an operating system (OS) running on said user computer system, and inserting a branch code into an obsolete code of said OS in order to branch to said code of said software-updating patch as substantially recited in independent claims 17, 20 and 23.

The closest cited prior art, Rodriguez (U.S. 6,487,718) teaches a method of updating software installed in a user computer system. However, Rodriguez (U.S. 6,487,718) fails to teach inserting a code of said software-updating patch into an operating system (OS) running on said user computer system, and inserting a branch code into an obsolete code of said OS in order to branch to said code of said software-updating patch as substantially recited in independent claims 17, 20 and 23; and as pointed out by the applicant's remarks/arguments on pg. 9, par. 4 to pg. 10, par. 4.
