REASONS FOR ALLOWANCE

The following is an examiner's statement of reasons for allowance: The instant invention claims a process for finishing a wood or wooden board comprising specific steps.

The closest prior art references that relate to the claimed invention are the following USP No. 7137229, 7171998, 6413364, 6551702, 5830548, 5629259, 4890656, 4856857 and US 2005/0089644. The closest prior art teaches that it is known in the art to use different processes for finishing wood or wooden board. However, the closest prior art does not teach or fairly suggest the instant invention having specific steps for finishing wood that include applying a sealing layer of melamine, printing a decoration onto sealing layer, applying a protective layer of melamine and pressing under specific conditions.
