DETAILED ACTION

The following is a first action on the merits of application serial no. 10/804,422 filed on March 19, 2004.

Allowable Subject Matter

Claims 1-13 are allowed.

The following is an examiner's statement of reasons for allowance: The prior art of record does not disclose or render obvious a motivation to provide for:

-(as to claim 1) a power train having a method for controlling an upshift of a transmission by determining a length of a first period of which energy is available to a secondary power source, determining a length of a second period of which a current vehicle speed increases to a target vehicle speed of a first shift point corresponding to an engine output equal to a combined output of the engine and the secondary power source and producing the upshift if the second period length is equal or greater than the first period length in combination with all the remaining limitations of claim 1.

-(as to claim 10) a power train having a method for controlling an upshift of a transmission by repetitively calculating a time rate of change of a current vehicle speed between frequent intervals, a length of a first period in which energy is available to a secondary power source, a length of a second period of which a current vehicle speed increases to a target vehicle speed of a first shift point corresponding to an engine output equal to a combined output of the engine and the secondary power source and initiating the upshift if the length of the second period is equal or greater than the length of the first period in combination with all the remaining limitations of claim 10.
