REASONS FOR ALLOWANCE

1. The following is an examiner's statement of reasons for allowance:

While Leung et al. (5,999,474) teaches a DRAM, auxiliary SRAM, and I/O circuit (relative to claim 34), the reference does not teach "if the block to which the write data was directed is being refreshed" (e.g. claim 34) or "if the first block of the DRAM is being refreshed during the attempt, writing data into the auxiliary memory" (e.g. claim 48) in combination with the other elements of the claims.

Taylor (6,172,927) teaches DRAM with an auxiliary input buffer 22. However, Taylor does not teach "direct transfer of data from the auxiliary memory to any block of the at least one DRAM..." (e.g. claim 34) and "after the first block of the DRAM is no longer being refreshed, transferring data stored in the auxiliary memory to the first block of the DRAM" (claim 48).
