### **REASONS FOR ALLOWANCE**

The instant invention is deemed to be directed to an unobvious improvement over the invention patented in U. S. Patent No. 6,324,843 to Yasuda et al. and U. S. Patent Application Publication No. 2003/0079170 to Webster et al. The improvement comprises a power train unit with a dipstick wherein the gauge portion of the dipstick extends within the housing from an area near the outer circumference of the reduced diameter swash plate supporting portion down to the bottom of the housing for the purposes of reducing the width of the power train unit.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."

### **PRIOR ART**

The patent to Yasuda et al and Publication to Webster et al. are cited for the showing of a power train unit with a dipstick similar to applicant's but lacking the gauge portion extending as claimed.

Prior art made of record but not relied upon is considered pertinent to Applicant's disclosure and consists of three patents.

Hayashi et al. (6,698,199), Saito et al. (6,530,218), and Hayashi et al. (5,575,151) are cited to show power train units with reduced diameter swash plate supporting portions.


