DETAILED ACTION

EXAMINER'S AMENDMENT

1. The application has been amended as follows: on page 1 of the specification, underneath the title the following has been inserted -- This application is a continuation of U.S. application no. 09/436,186, filed November 08, 1999, now U.S. Patent No. 6,406,604. --

Allowable Subject Matter

2. Claims 36-77 are allowed.

3. The reasons for allowance have already been stated in the Notice of Allowance of May 15, 2006. None of the claims have been amended since then and none of the references cited on the Information Disclosure Statement filed on August 08, 2006, subsequent to that Notice of Allowance, casts doubt on the patentability of the claims. The Examiner will note, though, that element 50 in Figure 4 of Robotti et al. (US 6,375,901 B1) is a microvalve, such as a phase reversible gel, for modulating fluid flow, not an affinity means for attracting and concentrating in the intersection an analyte. See col. 4:6-34 and col6:10-27.
