Continuation of 3. NOTE: Applicants arguments state that Tedesco teaches away from the present invention because it discloses the use of a screening server that is external to the database engine/server. Applicant states that the present invention handles all the steps disclosed in claim 1 from within the database. Examiner respectfully disagrees with applicant because the instant claims do not make reference or clarify that the limitations of the claim need to be executed at a server in the database. It is unclear by the claim's wording whether the limitations after "receiving a request for the database from a user" need to be executed at the database. Therefore the combination of Ellison and Tedesco does not teach away from the current application.
