1. Claims 6 and 24-37 are allowed.

The following is an examiner's statement of reasons for allowance: After reviewing of the prior art references the Examiner found that Applicant's argument at page 7 of Remarks filed on 05/29/2007 are persuasive for placing the claim 6 and dependent claims 24-28 in a condition for allowance. Claims 29-31 and 32-37 also includes similar allowable subject matter, therefore they are also allowed for the same reason as found at page 7 of the Remarks filed on 05/29/2007.

Claims 6 and 24-37 are allowable. The restriction requirement between inventions I, II and III, as set forth in the Office action mailed on 09/27/2006, has been reconsidered in view of the allowability of claims to the elected invention pursuant to MPEP § 821.04(a). The restriction requirement is hereby withdrawn as to any claim that requires all the limitations of an allowable claim. Claims 29-37, directed to an apparatus and method no longer withdrawn from consideration because the claim(s) requires all the limitations of an allowable claim.

In view of the above noted withdrawal of the restriction requirement, applicant is advised that if any claim presented in a continuation or divisional application is anticipated by, or includes all the limitations of, a claim that is allowable in the present application, such claim may be subject to provisional statutory and/or nonstatutory double patenting rejections over the claims of the instant application.
