On August 30, 2006, I requested that my assistant, Susan Kelly, contact Examiner Robert Swiatek regarding the above-identified application because we had not had any response from the Patent Office with respect to a Second Amendment, Power of Attorney and Terminal Disclaimer which were faxed and mailed to the Patent Office on April 26, 2005. Examiner Swiatek examined his file and noted that a Notice of Allowance had been mailed from his art unit in May of 2005. The Notice of Allowance was erroneously mailed to Wang Laboratories in Massachusetts instead of the Thomte, Mazour & Niebergall law firm in Omaha, Nebraska. Wang Laboratories apparently received the Notice of Allowance and returned the same to Examiner Swiatek's art unit. A Notice of Abandonment was issued by the Patent Office after the

issue fee was not paid and said Notice of Abandonment was also erroneously mailed to Wang Laboratories in Massachusetts rather than the Thomte, Mazour & Niebergall law firm in Omaha, Nebraska. Examiner Swiatek stated to Ms. Kelly that it was completely the Patent Office's fault that the Notice of Allowance and Notice of Abandonment were sent to the wrong address and that no one in his art unit had noticed that the Wang Laboratories address was not where the Notices should have been mailed. Examiner Swiatek also stated that a Ms. Carolyn Cofer in his art unit had apparently inadvertently entered the wrong address for the Thomte, Mazour & Niebergall law firm at the time the Power of Attorney was received in April of 2005. A revised Notice Regarding Change of Power of Attorney is currently being prepared by Ms. Cofer and is to be forwarded to the Thomte, Mazour & Niebergall law firm. While speaking with Ms. Kelly, Examiner Swiatek checked the "PALM" system and the correct address for the Thomte law firm was in the system.

The undersigned attorney hereby requests that the Notice of Abandonment be rescinded and that Examiner Swiatek be allowed to revive the application and mail the Notice of Allowance to the Thomte, Mazour & Niebergall law firm as originally intended by Examiner Swiatek.
