1. An Applicant's Amendment filed on October 3, 2005 has been entered. Claim 2 has been canceled; and claims 1, 4, 11, and 12 have been amended. Overall, claims 1 and 3-12 are pending in this application.

Allowable Subject Matter

2. The following is an examiner's statement of reasons for allowance:

As indicated on pages 7-8 of Applicant's Amendment, applicant persuasively argues that the prior art of record fails to disclose or suggest the combination of a first system and second system to, respectively, start heating a temperature of the filter and to adjust an exhaust air-fuel ratio in accordance with an amount of trapped soot for the combustion of the soot.
