

Continuation of 11. does NOT place the application in condition for allowance because: of the reason set forth in a previous office action. Aoki teaches as shown in Fig. 4, a flexible circuit board (30) is connected to a side of the liquid crystal display. In addition, with respect to independent claim 15, as stated in a previous office action, the specification does not disclose that the connector is independent of any switches. Unlike, applicant's argument, just because the specification states the connector as being a flexible printed circuit board, it does not mean that the specification reasonably discloses the connector as being independent of switches. The inherency argued by the applicant is not persuasive because any inherency (if any) should have been disclosed in the specification as filed originally.
