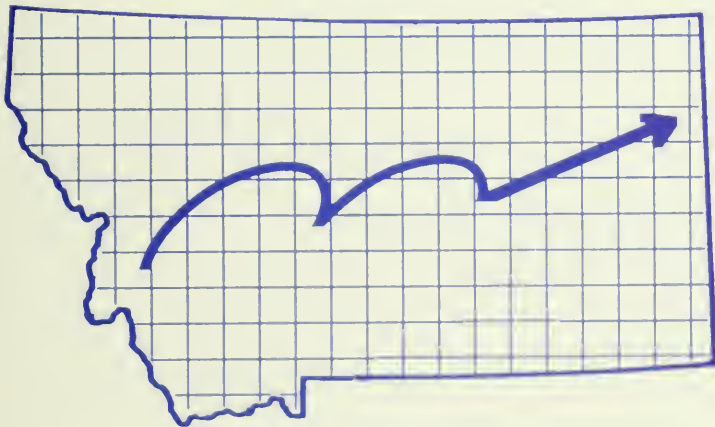


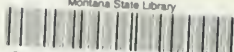

The Division administers Community Development Block Grant funding for economic development projects. This federally-funded competitive grant program awards approximately \$1.3 million annually to Montana cities, towns and counties, for re-lending by the local government to private business projects. Applications are made to the Division by the local government sponsoring the project; projects are selected for funding based on a number of criteria, including project feasibility, economic impact, and job creation for low to moderate income persons.

The Certified Communities Program helps local government and local development groups to organize and maintain community economic development efforts. In cooperation with the Montana Ambassadors and the Montana Chamber of Commerce, cities, towns, counties and tribal governments are guided in preparing community assessments and action plans, and implementing business recruitment and development programs. The network of Certified Communities receives relocation leads from out-of-state businesses forwarded by the Department of Commerce, and serves as the initial intake point for referring business clients to Small Business Development Center training and counseling.

Individual consulting and group training are available to businesses in the areas of financial analysis, financial planning, loan packaging, state and private capital sources, and business tax incentives. The program also works with communities, businesses and financial institutions to encourage the use of various public sector programs, including Community Development Block Grants, Economic Development Administration loans and grants, Small Business Administration loan guarantees, the Montana Board of Investments' in-state investment funds, Montana Science and Technology Alliance, and the Montana Growth Through Agriculture program.

It also provides technical assistance, either directly or through cooperating university system units, to assist small businesses in market identification, production management, quality control, cost accounting, and payment procedures for government procurement contracting.

This program works to increase export sales, international tourism and inward foreign investment for Montana. One-stop technical assistance to businesses wishing to enter foreign markets is available. Trade shows and foreign buyers are matched to exporters, and special training programs are conducted throughout the year to prepare more firms for export activity. The trade program maintains a product showroom in the Taipei World Trade Center on Taiwan, a Pacific Rim Trade Office in Tokyo, Japan, and a trade liaison in our sister state of Kumamoto, Japan.

The Business Location program publicizes and represents Montana to firms planning relocations or expansions. The program initiates and develops relations with target industries and individual firms, and prepares and presents location data in response to inquiries received by the department. The location office also works closely with local development organizations in their efforts to recruit new firms to their communities.

Marketing staff members work with individual small business and trade associations on packaging, promotion, market analysis and market strategy. Products of Montana manufacturers are represented at selected trade shows both in the United States and foreign countries.

The Made in Montana program is designed to elevate the status of Montana-made products in the marketplace. The program also serves to educate Montanans about the diversity of products manufactured in their state. Full-color "Made in Montana" logos, decals and hang-tags are available to manufacturers of products that have a minimum of 50% of their value added in Montana. The department operates an extensive public awareness campaign utilizing television, newspaper, outdoor, and radio advertising to encourage Montanans to "Look for the Label."

A private sector initiative, the Ambassadors program complements the department's business location, retention, marketing, and Montana promotion efforts. The Ambassadors are a membership organization, made up of approximately 200 business and university leaders from throughout the state. Members assist the Division in business recruitment projects, work with Montana manufacturers to help them market their products outside the state, and host foreign visitors and trade delegations. The program is funded by its members and staffed by the Department of Commerce.

OFFICE OF RESEARCH AND INFORMATION SERVICES

The Office of Research and Information services (ORIS) serves economic development efforts of the department and the general economic community of Montana by providing a central and accessible source of information and by conducting analyses of economic activity in the state. The office maintains a special library, monitors and analyzes the Montana economy, provides staff and research support to special councils, conducts specific economic analysis projects, distributes economic, demographic and business information, maintains and presents information on the department's economic development programs, and provides services for the department director. Through such activities, the office seeks to provide proper information to public and private entities for economic development planning, to implement state economic development services for existing industries, and to deliver accurate information to people interested in locating or expanding their business activities in the state.

A report entitled **Economic Conditions in Montana** is prepared for each session of the Legislature and is available for 1988. This report contains information on the statewide economy as well as data on 12 sub-state regions.

The Montana Board of Investments may purchase debt or equity investments at market rates as permitted by the Prudent Expert Principle. The board actively purchases qualified Montana Mortgages (both residential and commercial) from approved seller/servicers, buys the guaranteed portion of SBA loans and FmHA loans from Montana financial institutions, and purchases certificates of deposit from qualified Montana financial institutions.

Development Finance Programs

The 1982 Legislature, as a result of Initiative 95, authorized a series of programs designed to help small businesses obtain attractive capital financing. These programs are administered by the Board of Investments, Office of Development Finance (the Board). Each program operates with different eligibility criteria under state or federal law, but the primary focus of all programs is to increase availability of long-term, fixed rate financing to small Montana businesses.

Coal Tax Loan Programs

The Board is a development agency, not a bank or venture capital company. Its responsibility is to strengthen and diversify the state's economy through prudent investments in qualifying Montana businesses. The Board has limited financial resources and looks for those loan projects which have the greatest potential for creating employment opportunities for Montanans and for providing other long-term benefits to the state's economy. The Board's

programs are designed to assist businesses by making available to them long-term, fixed rate financing at competitive interest rates for a variety of needs.

Loans are made only through approved Montana financial institutions, which include state or federally-chartered banks, savings and loan associations, credit unions, development credit corporations, investment companies, trust companies, savings institutions, and qualified Montana capital companies. A complete list of approved financial institutions is available from the Board's office.

The Board is authorized by law to establish the types of loans that it will administer. The rules adopted by the Board provide several methods for making loans to Montana businesses, which are briefly summarized below. Detailed descriptions of each loan program, rules, application forms, and information on fees and the application process are available from approved financial institutions or from the Board's office in Helena.

Eligibility Requirements

Coal tax loans are limited by state statute and by the rules adopted by the Board of Investments in businesses that will have a "long-term benefit to the Montana economy." The Board has determined that:

- Investment in loans to businesses that will strengthen the Montana economy, that have the potential to maintain and create jobs, or that increase per capita income or future tax revenues to the people of Montana, either directly or indirectly, will meet the objectives of 17-6-304, MCA.
- In considering whether an applicant will maintain and create jobs, the Board will consider whether the applicant's proposed endeavor will displace existing jobs of competing Montana businesses.
- Loans to any governmental entity or non-profit corporation will not be funded under this program.
- At the time an application for financing is submitted the financial institution submitting the application shall certify that the loan for which financing is sought has not been classified in the most recent examination report of the financial institution.
- While a minimum or maximum loan limit has not been established, loans of \$500,000 to \$3 million will be targeted.

Federally Guaranteed Loan Program

Through the BOI Federally Guaranteed Loan Program, financial institutions that have secured a federal guarantee on a fixed-rate loan to a business that is eligible for Board investment may sell the federally guaranteed portion of the loan to the BOI at a pre-established rate. The most common use of this program will be for loans guaranteed by the SBA; however, the Board has purchased FmHA, FAA and BIA guarantees. The purpose of this program is to establish an active secondary market for fixed-rate federally guaranteed loans in Montana; to allow approved financial institutions the opportunity to provide their commercial customers fixed-rate financing at a lower rate than was previously possible; and to increase local lending capacities when loan

demand is high. Generally, the Board will only consider purchasing the guaranteed portion of loans originated for the purpose of using this program. Businesses must meet the eligibility requirements for BOI financing, and most types of business loans that are eligible for a federal agency's guarantee may be funded indirectly through this program. This generally includes the purchase of land, buildings, equipment, machinery, building expansion or repair, inventory, or funds for working capital.

Economic Development Linked Deposit Program

Through this program, the BOI will place a long-term deposit with an approved financial institution on the condition that the financial institution use the proceeds of the deposit to finance a corresponding fixed-rate loan to a specific borrower that is eligible for BOI investments. The deposit must be secured by state collateral and pledging requirements. The rate to the borrower on the supported loan will be "linked" to the return to the Board on its deposit; and although the BOI assumes no risk on the underlying business project, the financial institution is assured of a specific "spread" on its funds for the duration of the loan. In other words, this program removes the market risk to the financial institution in making a fixed-rate loan.

Funds from Economic Development Linked Deposits may be used by financial institutions to make loans for working capital, interim construction, inventory, site development, acquisition of machinery, equipment and buildings.

Business Loan Participation Program

The BOI Business Loan Participation Program, which may be used to finance commercial, multi-family, or SBA 504 loans, is designed to allow approved Montana financial institutions the opportunity to "sell" up to 80 percent of an eligible business loan to the Board of Investments. The Board, in essence, then owns a participation interest in both the financing and the security of an approved commercial loan that is serviced by the originating financial institution. Funds will be targeted to long-term fixed-rate loans that have the potential to positively benefit economic development within our state. Through this program originating financial institutions, will benefit by "leveraging" available funds beyond imposed lending limits, by receiving a relatively high yield on the financial institution's share of the loan, and by affording their commercial customers access to financing at terms that were previously unavailable. Borrowers that utilize this program will also benefit by receiving long-term funds at an attractive rate of interest.

SBA 504 Loan Participation Program

The Board may fund a portion of a project financed under the SBA 504 Program by purchasing from an originating lender up to 80% of the lender's first mortgage loan amount. All terms and rates are the same as under the Business Loan Participation Program.

As of April 30, 1989, the BOI had funded 148 Coal Tax Loans, in the amount of \$48.5 million. Loans have been used by trucking firms, lumber companies, tourism attraction and facilities operators, cherry growers, food processors, plastics manufacturers, dairies, furniture manufacturers, specialized tool manufacturers, and others. Of the total loan portfolio, 53% was in manufacturing, 14% in services, 7% in transportation, 28% in

agriculture/forestry/fisheries, and the remainder scattered among other industry classifications.

Industrial Development Bond Programs

The Board of Investments also issues tax-exempt industrial development bonds (IDBs) to fund loans to Montana businesses for the acquisition of land, buildings or equipment. All loans must meet federal eligibility requirements and primarily provide long-term, fixed-rate financing. After December 31, 1986, only manufacturing projects are eligible through September, 1990.

Stand Alone Industrial Development Bond Program

A borrower who can assume responsibility for funding its projects can have the Board issue Industrial Development Bonds (IDBs) under the "Stand-Alone" program. A borrower typically has three alternative ways to accomplish funding through IDBs: direct access to the bond market through the market's recognition of financial strength of the borrower, a bank letter of credit which the bond market recognizes and accepts, or a tax-exempt loan through a bank (no public bond offering necessary). The Board serves only as the legal issuer of the bonds and assumes no responsibility for funding the loan.

Project costs to be funded with IDB proceeds can be incurred only after the interest. Current sunset provisions also apply.

Montana Capital Companies

The Board also administers the Montana Capital Company Act, which is designed to make private venture or equity capital available within the state. Through the program, the state offers a 50% tax credit incentive (up to \$150,000) to investors in qualified Montana Capital Companies, which in turn must invest these funds in small, basic Montana firms. The capital companies must be certified and qualified by the Board. Available tax credits are limited to \$8 million through 1991, and are allocated to capital companies in order that they become "qualified" and have actual investors. As of June 1, 1989, eight firms had been designated as "certified and qualified" Montana Capital Companies while four firms had completed the "certification" stage and were in the process of raising at least \$200,000 in equity capital to become "qualified" for tax credits.

MONTANA HEALTH FACILITY AUTHORITY

The Montana Health Facility Authority (MHFA), created by the 1982 Legislature, is a bonding authority whose sole purpose is health care cost containment. To accomplish its mission, through the issuance of revenue bonds or notes, it provides financing or refinancing for projects consisting of construction, renovation, or equipment purchases, for public or private on-profit health care programs. The MHFA loans its bond proceeds to participating health care

facilities at interest rates below those of taxable commercial lending institutions, substantially containing the costs expended by the participants. In many instances, however, the commercial lending institutions are included in the financing to provide credit enhancement. The MHFA notes and bonds, which are neither general nor moral obligations of the state, may be issued to a single entity, or to several participating health care facilities. The MHFA offers its tax-exempt status to assist eligible facilities to issue tax-exempt bonds or notes, although taxable obligations can also be structured through the MHFA, with the MHFA as issuers.

MONTANA PROMOTION DIVISION

The Promotion Division is responsible for promoting the State of Montana as a travel destination for both summer and winter vacationers. Utilizing the State's "Master Marketing Plan", the division strives to increase the frequency of visitations by nonresident tourists and travelers. The division works closely with the private sector (airlines, ski areas, innkeepers, outfitters, etc.) to increase the dimensions of its tourism-related efforts. In addition, the division promotes group travel and markets Montana as a location for the film and television industries.

Consumer Travel Promotion

This section of the Montana Promotion Division is responsible for the promotion of the state to individual consumers. Consumer Travel Promotions includes four different but related functions: publications, advertising, exhibiting, and publicity. Each year, up to 12 full-color publications explaining and illustrating the Montana vacation product are published by division personnel. In addition, the staff creates, designs and oversees the production for all paid advertising and advertising campaigns. Consumer travel personnel also are responsible for generating publicity about Montana and for exhibiting at consumer trade shows.

Group Travel Promotion

Group Travel is responsible for initiating and maintaining productive contact with meeting planners and the travel trade. Personnel advertise in specific and various ways to attract national and international tour groups and conventions to Montana. A "Group Tour Planning Guide" is published regularly and sent to group tour operators. Staff members attend travel trade shows, makes sales calls and conduct familiarization tours for tour operators and travel agents. Group Travel targets its markets to include Canada and western and mid-western states for winter and summer group tours.

Motion Picture and Television Promotion

Staff involved in film and TV promotion act as a liaison for studios and production companies interested in filming motion pictures and commercials in Montana. In addition to scouting locations and negotiating permits, personnel go on location with film crews to serve as consultants and to provide

technical expertise and other location-related assistance. Staff also publish a "Motion Picture and Television Location Manual", which is sent to interested parties, including location scouts, producers and directors.

Regional Marketing Program

This program oversees the distribution of 25% of the accommodations tax and provides assistance with marketing to tourism regions and eligible cities within the state as mandated by the 1987 Legislature in HB 84.

TRANSPORTATION DIVISION

The Transportation Division provides analytical and financial assistance to freight and passenger transportation users statewide. The Division furnishes unique address of transportation issues and problems, and takes pride in finding lasting solutions for local governments, transportation providers, and users.

Intermodal Commodities Bureau (ICB)

The ICB provides several services for state transportation planning and economic development. They are broken down as follows:

Local Rail Service Assistance

Federal and state legislation authorize and direct the state to prepare a State Rail Plan. In this planning document, state rail policy is defined. Segments of rail systems within the state are evaluated, and federal assistance projects are identified. Financial assistance for eligible projects includes limited grants and low-interest loans to rail or rail-related industry for track plant rehabilitation, acquisition or new construction.

Short-Line Assistance Program

The Division has acquired railroad property and through lease, operating and purchase option agreement, provides for short-line rail service in areas where abandonment was a certainty. In addition to ownership assistance, the Division provides technical help in organizing and operating small railroads.

Special Projects

The Transportation Division conducts research and prepares special studies pertaining to timely transportation issues. These issues often concern grain movement, rail abandonment impacts, trucking, maritime transportation, rail passenger transportation and other related subjects. An additional responsibility is to monitor transportation-related legislation.

Intermodal Comparison Program

As transportation technology grows nationwide, Montana is reaching out to capitalize in applications of state-of-the-art methods. Inland ports, shipments, free trade zones, TOFC-COFC and double stacks are all part of our statewide transportation promotion.

Projects to develop facilities for this technology are underway within the state. Statewide industry transportation needs are monitored for all modes resulting in policy and project recommendations.

The 7.109% loans, matched by similar federal airport improvement grants, are available to any Montana tax-levying body -- cities, counties, airport authorities, etc. -- for a maximum loan period of eight years.

LOCAL GOVERNMENT ASSISTANCE DIVISION

The primary functions of the Local Government Assistance Division are to provide technical and financial assistance to units of local government; to insure local political subdivisions' financial compliance; to grant and administer Federal housing, economic development and public works funds; and to provide administrative support to the Montana Coal Board and the Montana Hard Rock Mining Impact Board.

Community Technical Assistance Program (CTAP)

As required by state law, the CTAP offers the following five services:

- * Provides technical assistance in three areas (community planning, land development, public works financing) to local government officials, planning boards, development groups and the private sector.
- * Provides guidance on land surveying laws and procedures.
- * Administers the County Land Planning Grant Program (See separate listing in this booklet).

- * Provides assistance to applicants for Community Development Block Grants.
- * Assists the Governor's office with community development problems of statewide impact.

CTAP staff receive and respond to over 500 requests per year from clients for one-on-one technical assistance. For example, staff have helped many community groups, cities, and counties to locate and package grants and loans for infrastructure projects such as senior citizen centers, water systems, parks, community centers, etc. A custom grant and loan computer database was developed by CTAP to assist Montanans in locating public works grants and other financing. Also, staff routinely assist planners, developers, surveyors and attorneys with land development and surveying problems. Workshops, custom publications, and special projects are other methods used to assist CTAP clients.

Hard-Rock Mining Impact Board

The Hard-Rock Mining Impact Act of 1981 requires the developer of a proposed, large-scale, metalliferous mine to prepare a plan that identified the project's anticipated impacts on local government services, facilities, revenues and expenditures. The impact plan is to include a schedule specifying when and how the developer will meet any net increase in local government costs that are expected as a result of the mineral development. The Hard-Rock Mining Impact Board is to facilitate the overall implementation of the Act and resolve, through a formal hearing process, any differences between the developer and the affected local governments concerning the impact plan. The Board is also authorized to administer grant programs dealing with the community and economic impacts of mine or smelter closures.

Community Development Block Grant (CDBG) Program

The Montana Community Development Block Grant (CDBG) Program is a federally funded competitive grant program which awards approximately \$5 million annually to Montana cities, towns, and counties to assist them with serious community needs. All projects must be designed to principally benefit low and moderate income persons or families.

Local projects address needs in three basic categories: economic development, housing, and public facilities. The grant competition for housing and public facility projects is conducted annually in the Fall. The grant competitions for economic development applications are continuous.

As of July 1, 1989, grants totalling over \$40,000,000 have been awarded to counties and municipalities from the HUD allocations to Montana for federal fiscal years 1982 through 1988.

County Land Planning Grant Program

This program is derived from the Montana coal severance tax. One half of one percent (.50%) of the total coal tax revenue is allocated to the CLPF. County governments receive CLPF. The funds then may be distributed by the counties to local planning boards (including city planning boards).

The funds are to be used for "land planning purposes." Basically, this means that the funds are to be used for local land use planning -- operation of planning boards, preparation of community comprehensive plans; administration of subdivision, zoning, lake shore, and floodplain regulations; and special plans or programs. Special plans or programs include downtown redevelopment, economic development, capital improvements planning, rural addressing systems, and natural resource inventories.

Local Impact Assistance Program

The Local Impact Assistance Program was initiated in 1975 by legislative action and is administered by the Montana Coal Board.

The Montana Coal Board awards grants and loans to local governmental units which have been required to expand the provision of public services as a consequence of large-scale development of coal mines and coal-using energy complexes. Funding is derived from the Montana coal severance tax. The Coal Board has awarded 198 grants of over \$60 million to local governmental units based on need, severity of coal impact, availability of funds, and degree of local effort in matching funds.

Section 8 Housing Assistance

A) Section 8 Existing Housing

This program is operated by the Department of Commerce under a contract with the U.S. Department of Housing and Urban Development. The basic purpose of the program is to provide rental assistance on behalf of lower-income families and the elderly in existing rental units that are decent, safe and sanitary. This program is operated on a first-come, first-served basis statewide and because the number of HUD-authorized units for subsidy is less than the demand, there is an extensive waiting list. In all instances the applicant, once certified, is responsible for finding a rental unit that meets HUD standards, and the rental subsidies are made to the property owner on behalf of the tenant. Payments are based on unit rent and an established portion (30%) of the tenant's adjusted gross income. Nearly \$40 million has been managed by the state for this program since 1978.

B) Section 8 Moderate Rehabilitation

This program also is operated under a contract between the Department of Commerce and HUD. It provides grants for upgrading of rental units in Montana.

Fifteen-year contracts are signed with developer-owners of rehabilitated rental units, and subsidies are provided on behalf of all eligible families who rent the units. Unlike the Existing Housing Program, the subsidy stays with the unit and is not transferred to other units when subsidized families move. Nearly \$7 million has been managed by the state for this program.

District Court Reimbursement Program

District Court Reimbursement funds the state assumption of certain expenses associated with criminal proceedings in district courts. The reimbursements are made to county governments only. The general definition of eligible expenses for state assumption includes: a portion of the salaries of court reports; transcripts of proceedings; witness and juror fees; indigent defense; and psychiatric examinations. Funding for these expenses is limited to the funds appropriated to the program by the legislature. Any reimbursable costs incurred by county governments for district court operations which exceed the appropriated ceilings for each fiscal year are the responsibility of the county.

MONTANA SCIENCE AND TECHNOLOGY ALLIANCE

Introduction

The Montana Science and Technology Alliance's purpose is to provide a source of financing for technology-based, entrepreneurial development to revitalize Montana industries and encourage new ones. While the staff is responsible for reviewing investment opportunities, final investment authority rests with the nine-member Montana Board of Science and Technology Development appointed by the Governor. The Alliance operates two financing programs: the Seed Capital Financing Program and the Research and Development Financing Program.

Seed Capital Financing Program

The Alliance's seed capital financing program gives priority to companies which incorporate advanced or innovative technologies, include plans for full commercialization and address one or more of the Alliance's target technologies. The Alliance has five-year management authority over \$7.5 million of the In-State Investment Fund, a portion of the Coal Severance Tax Trust, to capitalize the seed capital financing program.

The money is used to participate in financing new and expanding technology-based businesses in Montana that the board determines meet its investment criteria. These are companies which cannot be financed through conventional debt by banks due to the need for working capital and the lack of collateralizable assets but which hold realistic promise for rapid and significant growth.

All financings are structured as loans with the interest rate set at a level that provides a significant return to the Alliance. The Alliance may loan up to \$350,000 in a single round of financing and up to a total of \$750,000 to one company over multiple financing rounds. All seed capital program loans require a 100% co-investment from private sources. The Alliance looks to provide "venture capital" style financings through a mechanism that can be flexible enough to forego short term repayment requirements and that provide the Alliance with high return-on-investment potential. Through the careful investment practices of the seed capital program, the Alliance seeks to realize sufficient returns-on-investment from its seed capital portfolio companies to generate a reasonable return to the Montana In-State Investment Fund.

Research and Development Financing Program: Centers for Excellence Program

The Alliance's research and development financing program assists in the accelerated development of technology in the state by providing a source of funds to research organizations in Montana for projects which have outstanding technological and commercial potential for development in Montana. This program is funded for the 1991 biennium through appropriated funds.

In order to bring a greater focus to its research and development activities and to emphasize particular research emphases which have exemplary potential for economic diversification and commercial development in Montana, the Alliance initiated its centers of excellence program. The Alliance looks to reserve its funds available research and development for the continuation of the centers program.

The three technology centers funded include the Biotechnology Center focused at the University of Montana, the Advanced Materials Center focused at Montana State University and the Advanced Minerals and Hazardous Waste Processing Center at the Montana College of Mineral Science and Technology. Also included in the centers program is the Entrepreneurial Center which is a cooperative effort of the University of Montana, Montana State University and Eastern Montana College. The centers program has great potential to build Montana's applied research infrastructure and to stimulate the flow of commercial opportunities for the Alliance and other investors.

SBIR Funding

UTAP may be able to provide assistance in applying for Small Business Innovative Research (SBIR) funding from federal agencies. These funds are awarded competitively to qualifying small businesses capable of developing products needed by the agency.

Conclusion

The Alliance, through its seed capital financing program and research and development financing program, attempts to foster shared investments in promising projects involving innovative technologies. It is a process that is also designed to kindle the entrepreneurial spirit in Montana. If successful, the state's commitment to the future of its entrepreneurial economy will reap benefits for all Montanans.

RECLAMATION AND DEVELOPMENT GRANT PROGRAM

LABOR TRAINING PROGRAMS

Job Training Partnership Act

The Job Training Partnership Act (JTPA) was implemented October 1, 1983. Under JTPA, public and private sector representatives cooperate to develop and implement job training programs to meet Montana's special needs. The Act provides a framework whereby state and local programs can assist economically disadvantaged persons -- including youth, unskilled adults and dislocated workers -- to become productive members of the labor force.

Industrial Start-up Training Program

The Industrial Start-up Training Program, funded by the 1983 Legislature, is a broad-based job training effort for employees of new or expanding small businesses in Montana. Administered by the Department of Labor and Industry, the program is designed to minimize new employers' problems in obtaining a trained work force. Specifically, the department works with the employer to determine the required number of employees and their skill levels. The department then conducts labor availability surveys and recruits prospective employees by handling all the advertising, screening, testing, interviewing and training. The employer subsequently makes the final employee selection.

STATE PURCHASING POLICIES

Small Business Procurement Set Asides

The Montana Small Business Purchasing Act of 1974, was enacted to ensure that a fair portion of state purchases and contracts for supplies and services is placed with small businesses. The Act, Section 18-5-301-308, MCA, allows each state agency to designate specific commodities, equipment or services as small business "set asides" when there is a reasonable expectation that bids will be obtained from at least three small businesses capable of furnishing the desired property or service at a fair and reasonable price. Services rendered by registered professionals (accountants, attorneys, architects, etc.) are prohibited from being designated as set asides.

Bidding Preferences

Section 18-1-102, MCA provides for a three percent (3%) bidding preference for "resident" Montana bidders when they bid on state contracts. This preference is awarded to vendors who meet the residency requirements detailed in Section 18-1-103, MCA. Effective October 1, 1987, Section 18-1-102 also provides for a five percent (5%) preference for vendors submitting bids for goods manufactured in Montana. To be eligible for a preference a vendor must have a completed bidder affidavit form on file with the Procurement and Printing Division or submit certification of the Montana Made status of goods with each submitted bid.

The Procurement and Printing Division is responsible for determining eligibility for residence based on information provided by each vendor. This information is collected on the Bidders Affidavit form as part of the registration process for being included on the central bidders list. Affidavit forms are available upon request.

TAX INCENTIVES

Montana has implemented a number of business tax incentives. These incentives consist primarily of property and natural resource tax exemptions and reductions and individual income and corporation license tax credits and exemptions.

Property tax incentives include:

1. Property assessment reductions for new or expanding industries and for certain remodeling projects.
2. Property tax rate reductions for pollution control equipment and for qualified new industries and research and development firms.

3. Property tax exemptions for business inventories and freeport merchandise (merchandise produced outside Montana, which while in transit through the state is temporarily consigned to a Montana storage facility.)

General individual income and corporation license tax incentives include:

1. A wage credit for new or expanding manufacturing corporations producing a product new to Montana.
2. A five-year exemption from taxation for research and development firm organized to engage in business in Montana for the first time.
3. Exemptions for domestic international sales corporations (DISCs) and for investments in small business investment companies (SIBCs).
4. A credit for investing in a Montana capital company.

Natural resource related tax incentives include:

1. A phase-down of coal severance tax rates.
2. A reduced severance tax rate on new coal production for buyers of coal who have not previously purchased from Montana producers or who purchase more, on average, than they did from 1983-1984 or during 1986.
3. A 12 month net proceeds tax exemption and a 24 month severance tax exemption for new oil and gas production.
4. Reduced severance tax rates for oil and natural gas stripper well production.
5. A severance tax rate reduction for oil production from a tertiary project.

Other significant tax incentives include:

1. An individual income or corporation license tax credit for investing in wind powered electrical generating equipment.
2. An individual income or corporation license tax exemption for sellers of land to beginning farmers at less than 9% interest.
3. An individual income or corporation license tax deduction for expenditures on organic fertilizer produced and used in Montana.
4. Adjusted gross income for individual income tax does not include 40% of capital gains on the sale or exchange of capital assets before December 31, 1986.

Computerized Data Search

UTAP has access to over 400 national databases and 300 U.S. government laboratories and research centers through its affiliation with the NASA Industrial Application Center at the University of Southern California. Using computer and phone links, UTAP can help businesses work with search specialists to find the latest published information on technical problems. Remote sensing and image processing services also can be obtained.

In cases where published information is unavailable, inquirers may receive assistance from researchers in U.S. laboratories. These experts have been identified by the Industrial Application Center and have agreed to discuss problems in their areas of interest.

The purpose of this network of cooperation among federal government, university technical centers, and industry is to transfer the technology from NASA and other government laboratories to boost industry's competitive edge. Cost recovery fees are assessed for this service.

Center of Excellence in Advanced Minerals and Hazardous Waste Processing

Mandated to stimulate the development of new, and the application of existing technologies that deal with problems of minerals-related hazardous wastes, the Minerals/Hazardous Waste Processing Center (MHPC) funds cooperative projects between industry and academic researchers. U.S. SMALL BUSINESS ADMINISTRATION

Financial Assistance

Regular Loans

Most of the SBA's business loans are made by private lenders and then guaranteed by the Agency. There is no limit on the loan size, but SBA's maximum guarantee of \$750,000. SBA guarantees 90% on loans up to \$155,000 and 85% on loans exceeding \$155,000. The interest rate is set by the lender

(although some limits are imposed by the SBA), and the term cannot exceed 25 years. Loans for working capital seldom exceed seven years. Although loans may be for any worthwhile purpose, the Agency prefers to be considered a fixed asset lender.

Special Loan Programs

1. **Loan Development Company Loans (502 Programs):** Loans are made to groups of local citizens whose aim is to improve the economy in their areas. Loan proceeds may be used by the development company to assist specific small businesses for the purpose of plant acquisition, land acquisition, land, machinery and equipment.
2. **Certified Development Company Program (503 Corporation):** The program's purpose is to help communities by stimulating the growth and expansion of small businesses within a defined area of operation. Certified Development Companies are authorized to sell debentures pertaining to an identifiable small concern with SBA's 100% guarantee.
3. **Disaster Assistance:** When the President or the Administrator of the Small Business Administration declares a specific area to be a disaster area, Physical Damage Disaster Loans are available from the SBA. They are made to homeowners, renters and businesses to repair or replace damaged or destroyed homes, personal property and businesses.
4. **Surety Bonds:** SBA is authorized to guarantee to a qualified surety up to 90% of losses incurred under bid, payment or performance bonds issued to contractors on contracts valued up to \$1.25 million. The contract may be used for construction, supplies or services. (This program is administered by SBA's Denver, Colorado office.)

Business Development

SCORE and ACE (Service Corps of retired Executive and Active Corps of Executives)

These groups help small business managers or owners solve their operating problems through one-on-one counseling relationships.

Small Business Institutes (SBIs)

At each SBI (located on university and college campuses), senior and graduate students at schools of business administration, and their faculty advisors, provide on-site management counseling. Students are guided by the faculty advisor and SBA management assistance experts. They receive academic credit for their work.

Small Business Development Centers (SBDCs)

These centers draw from resources of local, state and federal government programs, the private sector and university facilities to provide managerial and technical help, research studies and other types of specialized assistance to small businesses. The Montana SBDC program is operated by the Business Development Division of the Montana Department of Commerce, with offices in Helena, Glendive, Kalispell and Bozeman.

International Trade Counseling and Training

SBA works closely with the U.S. Department of Commerce and other government agencies, and with private organizations to help develop programs to aid small firms in doing business abroad. Emphasis is placed on the practical application of successful exporting and importing procedures to small business.

Procurement Assistance

Federal Procurement specialists in SBA offices throughout the country counsel small businesses on how to prepare bids and obtain prime contracts and subcontracts, direct them to government agencies that buy the products or services the small firms supply, help them get their names placed on bidders' lists and assist in obtaining drawings and specifications for proposed purchases.

SBA:

- Helps federal agencies to direct government subcontracts to small businesses;
- Helps private contractors to direct federal contracts to small businesses;
- Refers qualified small businesses to federal prime contractors;
- Monitors the granting of federal contracts to small firms by federal agencies.
