Gem Fugio Back Design 1776 \$1/6

20001 Continental Currency February 17, 1776 \$1/6 PMG Gem Uncirculated 65 EPQ.

A lovely fractional Continental issue, this example has the Fugio design on the back and is boldly signed by Robert Tuckniss. The paper is bright and free of defects or repairs. The note is completely framed, with the left margin on the face being a bit snug. This note is presently tied with two others for the top grade recorded in the *PMG Population Report*. We last sold an example in this condition in our 2017 Eric P. Newman VIII Currency Signature auction where it realized \$4,800.


High Grade 1861 \$5 Demand Note

20002 Fr. 1 \$5 1861 Demand Note PMG Extremely Fine 40 EPQ.

This note is one of the iconic issues of United States paper money. First issued in the summer of 1861, so-called Demand Notes could be used for all dues to the federal government including import duties that traditionally were required to be paid in gold coin. Needless to say these notes were retained for this use as they were "good as gold." These notes are very scarce today, particularly in higher grades. Interestingly, the notes were handsigned for the Register and Treasurer by a large number of paid signers and bore no Treasury seal. This example has survived the last 159 years in great shape. Its paper is still bright with original surfaces, with dark, vibrant colors, and dark penned signatures. There is no evidence of repair or damage beyond faint evidence of limited circulation as expected for this grade. This historic note will make a wonderful addition to any large size type or Civil War collection. It is one of the finest examples known, and one of a small number to sport the EPQ designation. The last public auction appearance for this note was in 1993, when it crossed the auction block for \$4,400. **Starting Bid: \$10,000**

Rare St. Louis \$5 Demand Note

20003 Fr. 5 \$5 1861 Demand Note PMG Very Fine 20.

While \$5 Demand Notes periodically appear, they are usually from one of the East Coast cities like New York, Philadelphia, or Boston. However, notes payable in St. Louis are another matter. The Track & Price census records a total of ten notes at present and the *PMG Population Report* counts only three examples graded so far. This note is the middle grade of the three. PMG notes minor repairs which seem to be confined to small splits and nicks in the margins. This example last crossed the auction block in 2015 when it realized \$19,975. Starting Bid: \$10,000





THE FIVE UNIQUE SPEELMAN-WHITE UNCUT SHEETS FIRST PUBLIC OFFERING SINCE 1993

Present-day collectors are familiar with the fact that uncut sheets of modern currency are available for a small premium from the Bureau of Engraving and Printing (BEP) in Washington, DC. However, uncut sheets of Large Size Notes are another matter entirely. None were ever made available to the general public, and all known sheets were either kept by the Treasury officials at the time or obtained by Treasury officials for someone as a favor.

From July 1885 through the middle of 1910, the Bureau of Engraving and Printing delivered all notes to the Treasury Department in the form of uncut sheets, to be separated at the Treasury. Prior to that, and once again starting in June 1910 continuing to the present, the BEP delivered notes to the Treasury fully printed and separated. During those periods, Treasury officials would need to have made a special request to the BEP to obtain uncut sheets.

The Bureau of Engraving and Printing still possesses Treasury Department ledgers and indices recording the note deliveries from the BEP to the Treasury. These records are of particular interest here because they document the five unique Speelman-White uncut sheets we now offer.

For example, the ledger entry for August 30, 1923 details the receipt by the Treasury of \$1 Legal Tender Notes with Serial Numbers R73512001A through R73992000A, and mentions that the sheet with numbers R73628001A through R73628004A was transferred to the Treasury uncut, with the red notation, "H. V. Speelman." This is the uncut sheet we are offering this evening. Similar references in the ledgers can also be found for the \$2 Legal Tender sheet, the \$10 Legal Tender sheet, the \$1 Silver Certificate sheet, and the \$5 Silver Certificate sheet also appearing in tonight's sale.

These five unique uncut sheets, all delivered to Register of the Treasury, Harley V. Speelman, within a short period in late 1923, have remained together to this day. After Speelman, their trail is next picked up in the late 1950s, when

John J. Ford, Jr. obtained them from the F. C. C. Boyd estate and sold them to Oscar G. Schilke. From there, they went through Ben Levin, Stanley Kesselman, and two anonymous collectors, before they were acquired by Herman Halpern in 1991. It is believed, but cannot be proven, that they were obtained from Speelman by Wayte Raymond for Col. E. H. R. Green, whose estate was appraised by F. C. C. Boyd. Since Boyd, as the estate appraiser could not legally buy from the estate, he is known to have been given items from the estate for his fee.

For the first time, the sheets were offered individually in the Stacks sale of March 1993 (a raucous time in Manhattan as witnessed by your cataloger as the sale occurred on St. Patrick's Day). Fortuitously, all five sheets were acquired by our consignor, keeping them together for another 27 years. Tonight, they are again being offered individually to afford as many collectors as possible the opportunity to acquire one of these unique pieces of history.

As the perfect complement to the rarity of the Speelman pedigreed sheets here, The Monarch Collection features two additional sheets, numismatic treasures in their own right. Lot 20083 is the lone Serial Number 1 \$1-\$1-\$2-\$2 National Bank Note Uncut Sheet known to collectors. Lot 20024 is one of just three \$1 Educational Silver Certificate Uncut Sheets in private hands.

(This introduction is taken in part from Martin Gengerke's ground-breaking research into the history of the five unique Speelman-White uncut sheets we are offering this evening. Mr. Gengerke prepared this presentation as part of the sale catalog of the Herman Halpern collection in 1993 and for which he received an award from the Numismatic Literary Guild. We gratefully appreciate his permission to reproduce part of his presentation in this catalog.)

A superb uncut \$1 Legal Tender sheet in almost every respect, this piece is wholly original, boasts perfect embossing and colors, and has excellent eye appeal. Only a slender bottom margin precludes consideration of a full Gem grade for this pretty sheet. It is unique for this Friedberg number, with no others ever rumored to exist. As explained in the introduction about the five unique Speelman-White uncut sheets we are offering tonight, it bears the following illustrious pedigree: Sent to the Treasury Department in 1923; H, V, Speelman; Wayte Raymond; Col. E. H. R. Green; F. C. C. Boyd; John J. Ford, Jr.; Oscar G. Schilke; Ben Levin; Stanley Kesselman; Herman Halpern; and to our consignor in 1993. *From the Monarch Collection*

20005 Fr. 60 \$2 1917 Legal Tenders Uncut Sheet of Four PMG Choice Uncirculated 64 EPQ.

A gorgeous \$2 Legal uncut sheet, this piece is only held back from a full Gem grade by a bottom margin that is cut a touch closely. Nevertheless, the sheet is superb, with bright color and paper. This is the only sheet ever rumored to exist for Friedberg Number 60 and is one of the five unique Speelman-White sheets we are offering this evening. Its pedigree as outlined in the introduction to these sheets is as follows: Sent to the Treasury Department in 1923; H. V. Speelman; Wayte Raymond; Col. E. H. R. Green; F. C. C. Boyd; John J. Ford, Jr.; Oscar G. Schilke; Ben Levin; Stanley Kesselman; Herman Halpern; to our consignor in 1993. *From the Monarch Collection*

Unique Uncut Sheet of Fr. 122 \$10 Bison Notes One of Two Known of the Type and the Only Sheet in Private Hands

20006 Fr. 122 \$10 1901 Legal Tenders Uncut Sheet of Four PMG Gem Uncirculated 65 EPQ.

One of the most impressive uncut sheets imaginable, this offering features bright color and paper in a beautiful, highly popular design. It is one of only two uncut sheets known for the entire Bison series, the other being a Fr. 121 sheet that was offered in the 1950s as part of the James M. Wade collection and which is now forever off the market as it was donated to the ANA Museum by Aubrey Bebee about 30 years ago. The appearance of this sheet and the other unique Speelman-White sheets in tonight's offering is indeed a momentous occasion in the paper money field that may not repeated for decades to come, if ever.

The pedigree for this wonderful sheet is summarized as follows: after it was sent to the Treasury Department in 1923, it had the following provenance - H. V. Speelman; Wayte Raymond; E. H. R. Green; F. C. C. Boyd; John J. Ford, Jr.; Oscar G. Schilke; Ben Levin; Stanley Kesselman; Herman Halpern ; and from thence to our present consignor in 1993. *From the Monarch Collection*

A lovely Black Eagle uncut sheet with no folds whatsoever, and wholesome margins all around. It is a bright and crisp sheet with full, original embossing, as attested to by PMG's comment "Great Embossing." This sheet is unique for this Friedberg number, with no others rumored to exist, even in museums or government collections. It is one of the five unique Speelman-White uncut sheets offered tonight and carries the same provenance as its counterparts: to the Treasury Department in 1923; H. V. Speelman; Wayte Raymond; Col. E. H. R. Green; F. C. C. Boyd; John J. Ford, Jr.; Oscar G. Schilke; Ben Levin; Stanley Kesselman; Herman Halpern; then into the custody of our consignor in 1993. *From the Monarch Collection*

A gorgeous uncut sheet of Chief notes, both as a sheet and as individual examples. This sheet and the \$10 Bison sheet offered in an earlier lot are without a doubt the most impressive uncut sheets of Large Size Federal notes in existence. Not only is the condition superb, but the notes themselves represent one of the most popular types ever issued. Probably unique for this signature combination, with just one other uncut Chief sheet definitely confirmed - that being a sheet of Parker-Burke notes that was donated to the ANA Museum by Aubrey Bebee some 30 years ago - now forever off the market.

Unlike the other four unique Speelman-White sheets offered here, one public record does exist for a \$5 Fr. 281 sheet. The Albert A. Grinnell sale in March 1945, Lot 1042, did have an uncut sheet. Though the serial numbers were not given, the plate numbers match this sheet. It is not known if that was a second sheet, or if for some reason, this one sheet was sold to Grinnell, only to rejoin the group at a later date. The rest of the pedigree is quite impressive, as we detailed prior to the offering of the Fr. 39 \$1 Legal uncut sheet: H. V. Speelman, Wayte Raymond; Col. E. H. R. Green; F. C. C. Boyd; John J. Ford, Jr.; Oscar Schilke; Ben Levin; Stanley Kesselman; Herman Halpern; and from thence to our present consignor in 1993.

These notes are each a grade higher than the cut sheet we sold in our 2014 FUN Currency Signature auction for \$11,162. (Total: 4 notes)



The 1869 \$2 was the first of a series of issues that extended into the 1920s with minor design modifications, mostly involving the back design. The initial design included a band of blue stain that was to serve as an anti-counterfeiting feature. This, along with the red seal and black and green design elements, gave the note an array of attractive colors. It is printed on bright paper with decent margins and centering. **Starting Bid: \$2,500**



Remarkable \$10 Legal Tender - Tied for the Finest Graded by Either Service

20011 Fr. 95b \$10 1863 Legal Tender PCGS Gem New 66PPQ.

Perfectly even margins frame the delicately printed details of this \$10 Legal. The colors are ideal and vibrant, including the cherry red seal and serial numbers. This old friend is making its first public appearance since our May 1991 auction. Tied for the finest graded by either PMG or PCGS, it is also the first example at this grade level to ever cross the public auction block, according to Track & Price. First offerings at this rarified level are always difficult to estimate. As a guide, a perusal of auction records reveals that a pair of PMG Gem Uncirculated 65 EPQ examples realized \$21,150 and \$29,375 in 2013 and 2015, respectively.

The margins are huge and the colors are perfect. If you have been waiting for an ideal Bison for your type set, this example, which is new to the census, should certainly be considered.

The "Premium Paper Quality" comment was certainly earned by this Bison. Pronounced original embossing is very easily seen through the third party holder. Generally on Fr. 114s, the serial numbers are orange and the remainder of the overprint is a true deep red. This particular example shows that tendency at its most brilliant. This very attractive note is crossing the auction block for the first time in ten years. The last example we sold at this grade level realized \$11,750 in our 2017 FUN auction.

Last on the market in a 1990 Bowers & Merena sale, this pretty \$10 Legal represents a much tougher Friedberg number for this popular series, particularly in the higher grades. **Starting Bid: \$5,000**



Perfectly Graded PCGS 66PPQ Bison

The grade appears spot on to us as this is a really nice Bison, with broad well balanced margins, perfect colors of the inks and paper, and back centering the equal of the wonderfully centered face. These do come nice, but this one is a stand out among most of the 66s we have had the pleasure of cataloging.

Series 1923 was the final large size \$10 Legal Tender note to be issued. It features the familiar portrait of President Andrew Jackson with vibrant red serial numbers, design elements, and Treasury seal. The design has lots of white space, reflecting the design philosophy of the time, that the eye would then be drawn to the main elements intended to simplify the counterfeit detection process a bit. We are convinced in this case the note won its positive accolade for margins and color. Rainbow Fifties are a rare and extremely popular one-number type, with only about 70 pieces listed in the Track & Price census. That number includes pieces that have been reported by serial number but never offered at auction. It could very well include a few contemporary counterfeits which were some of the best of their time and continue to fool census takers if not carefully examined. Henry Clay, whose portrait appears at lower right, received electoral votes in three different presidential elections - 1824, 1832, and 1844. He also helped found both the National Republican Party and the Whig Party. He earned the nickname, "The Great Compromiser," due to his ability to defuse sectional crises.

The bronze, while it has lost its flashy color, has not oxidized to the point of damaging the paper, or for that matter, even showing through to the back. The margins, while they vary in size, are far superior to what is normally observed on these seldom seen notes. The ink and paper colors are bright and vivid. Only a few more than 100 are known to Track & Price. Their listing of grades indicates that 40 is well within the top ten percent of known examples. Middle-of-the-book notes were out of favor for a number of years, but have recently found their footing again and become part of all mainstream collections of large size US type.



Marcy, life-long politician, with stops as governor of New York, 1833-1839; United States Secretary of War, 1845-1849; and United States Secretary of State, 1853-1857. He died on July 4, 1857. The actual Proof impression is flawless, with PMG mentioning that the impression is unaffected by a few light corner folds and other collector handling from admiring viewers in the broad margins. Also, the back upper right-hand corner displays a tiny lightly pencilled "(9)." There are only two issued notes of this design known; one note is in the Smithsonian, and the other note is in private hands, being ex-Amon Carter / Joel Anderson. That issued example sold for \$1,920,000 in 2019. Tonight is an exciting opportunity to collect this Friedberg number. This example last crossed the auction block at our 2005 CSNS Currency Signature auction, realizing \$43,125, a number which we expect to easily surpass tonight.



In any case, General James McPherson, who was killed in action during the Battle of Atlanta on July 22, 1864, is depicted on this note. This variety also sports an attractive large brown spiked Treasury seal and a very busy, minutely detailed decorative back. The note checks all of the boxes in terms of originality, paper quality, great colors, and margins and centering for its assigned grade. It will add significant value to any collection of which it becomes a part.

The note features an oversize portrait of Thomas on the face and a very ornate green back featuring a large FIVE. The note has excellent original paper surfaces, wonderful colors, and wholesome margins and centering, with only a bit of a snug top margin on the face holding it back from an even higher grade.

Just about three dozen examples of this Friedberg number are enumerated in the census. As a type, the Large Brown Seal is seen on only the Fr. 366 and Fr. 367, making this one of the rarest designs available to collectors. 
Impressive 1890 \$10 Treasury Note

This 1890 \$10 Coin note was one of a number of issues that honored Civil War Generals in the decades following the Civil War. One wonders if this was a subtle way of reminding everyone of who won the war and who did not. In this case, the honor of appearing on the \$10 fell to Philip Sheridan, best remembered for his cavalry command exploits during the Civil War, some of which directly influenced Lee's surrender at Appomattox. It was first issued in 1891, several years after his death in 1887. His portrait is complemented by a large brown spiked Treasury seal. The back is completely filled with complex engraving that, at the time, was believed to make counterfeiting more difficult. This impressive appearing note is printed on bright original paper surfaces with deeply inked colors, and ample, even margins. PMG has spotted a solitary pinhole that has been sealed and is virtually impossible to find through the holder.



This Friedberg number does not have any example graded higher than Extremely Fine 45, with the Track & Price census enumerating only 33 notes in all grades. An attractive large size type note that will enhance any collection, this example last sold for \$6,600 in 2018 and should test that level once again.

The gold overprint is vibrant, the red seal especially vivid, and the back an explosion of orange color set between four boardwalk margins. The Benton who appears on this note is Thomas Hart Benton, a Senator from Missouri and an extremely influential politician in his day. He was related to many other 19th century luminaries, including two Civil War Colonels, a Confederate Colonel from Mississippi and a Union Colonel from lowa. He was the father-in-law of Presidential candidate John Frémont, and the great-uncle of Congressman Maecenas Benton who was the father of the famous artist Thomas Hart Benton. This Series 1907 issue was printed in the late teens while Teehee and Burke held the positions of Register of the Treasury and Treasure. In that five year span from 1915 to 1919, the Bureau of Engraving and Printing managed to print 116,000 notes, primarily for use in bank to bank transactions. Since few notes were used in regular channels of commerce, they faced heavy redemption. Today, just four dozen survivors are reported extant. Of that number, nearly a third are permanently impounded in Federal Reserve Collections, the Smithsonian, or have never been offered at public auction. The currently offered example shows just moderate wear. The back color is its full flaming orange, not faded a bit, which is quite unusual for a high denomination gold certificate. PMG has added a comment about minor repairs but any such restorative work is minor indeed as it is not readily apparent on this most attractive \$1000 Gold Certificate.

A Trio of High Grade \$10,000 Gold Certificates with Consecutive Serial Numbers

Collectors have the opportunity to own these notes as the result of a fire that broke out on December 13, 1935 in the Old Post Office in Washington, DC. These notes had been held in storage and were tossed out of the windows of the building as the fire took hold. Bystanders on the street below scooped them up convinced, at least momentarily, that they were rich. Thus, these notes were saved from destruction. The notes, of course, were cancelled and had no value as such. Many of these notes have water stains and damage as a result of the fire. These three consecutively numbered notes were probably part of a bundle or group of notes that had been sorted and held together. Fortunately none of the notes have water damage or damp staining. They are, however, roulette cancelled (as are the vast majority of these notes). Each note features a large portrait of Andrew Jackson, small red Treasury seal, and the word GOLD and serial number spaces printed in gold ink. Considering the circumstances of their "liberation" from government hands, all three of these notes, originally from the same sheet, are in remarkably nice condition with good color, paper surfaces, and margins. Tonight, we are pleased to offer one of the greatest National Bank Note rarities to appear in one of our auctions in quite a few years. This is the only all-Serial Number 1 First Charter uncut sheet known to exist, in either public or private hands. According to the National Currency Foundation census, a total of 20 uncut sheets are reported for the entire First Charter Period, both Original Series and Series of 1875. However, of those twenty, this Jacksonville, IL sheet is the only one bearing serial number 1. Notwithstanding the serial number 1 status, First Charter sheets of any number are a rare breed with, as stated, just 20 known to exist, as compared to 90 Second Charter sheets and 677 Third Charter sheets in the census. This sheet was a highlight of the famed Albert A. Grinnell collection, and was the first uncut National Bank Note sheet to be offered in Barney Bluestone's sale of the Grinnell collection as Lot 1445 on June 16, 1945. Back then, Mr. Bluestone stated that it was "the only number 1 sheet known to exist," a statement that is still true 75 years later. Since that time, the sheet passed into the hands of well-known dealer, Paul Kagin, and then to our consignor. This exciting piece is now once again available for a new generation of collectors.

The sheet itself is bright and fresh with excellent color and bold pen signatures. There is a light fold between each of the notes and a few pinholes are noted by PMG, but those minor flaws are hardly worth mentioning. Estimating the value of a unique piece such as this, destined to be a centerpiece of any collection it enters, is rather difficult. First, there have been few, if any offerings, of even non-serial number 1 First Charter uncut sheets in recent years. Second, a perusal of auction records does reveal that individual examples of serial number 1 Original Series \$1s in the better grades sell in excess of \$10,000, and number 1 Deuces fetch well over \$25,000. However, to quantify the added premium for having four of those number 1 notes in an uncut sheet is sheer guesswork. Therefore, we will be conservative and let the bidders decide tonight. *From the Monarch Collection*

PMG has declined to make an interpretation either way but, nevertheless, the question does add to the appeal of this pretty Richmond \$5,000, The note does have three small paper pulls on its back due to a previous mounting but is otherwise fully original with excellent color and embossing. All in all, this is a most attractive and intriguing example of a sought-after high denomination note.





The quality of this offering from the Boston district is quite striking in all facets with fully original paper throughout as confirmed by the application of an "EPQ" designation from PMG. 19. Auctioneer reserves the right to rescind the sale in the event of nonpayment, breach of a warranty, disputed ownership, auctioneer's clerical error or omission in exercising bids and reserves, or for any other reas in Auctioneer's sole discretion.

- 20. 
