Rob &amp; Jim:

I'm forwarding an e-mail that was provided to me by County Clerk Michael Backus, which lists all parcels of land situated between Rice Road (on the North), State Route 69 (on the South), US Rte 11 (on the West) and Bangall Road (on the East), in the Town of Mexico.

Although I don't believe James Steen's account to Tonya Priest about the location of Heidi Allen is accurate (if he in fact made that statement), I believe we need to thoroughly check those woods in order to be 100% positive. I think due diligence requires nothing less.

When this case goes to court, I want to be able to tell the judge that we did a thorough and exhaustive check of that area. I don't want to give the defense any opportunity to argue that we did less than our level best.

Besides, if there's any chance Heidi could be there, we owe it to her family. And I think the public expects us to do the same.

Since Steen allegedly told Priest that they crossed the railroad tracks, I think we **should begin with the properties due West of the railroad tracks**. If we find any cabins or similar structures, we should conduct an investigation, just as we did last week.

As you know, a proper search is going to require a lot of people, so I think it makes sense to bring in outside agencies to assist. I think we should reach out to NYSP, DEC, OPD and FPD. Perhaps there are federal agencies that would assist as well. We might also ask the Oswego County Search and Rescue Team. I will make all of my deputy coroners available, too.

As DA and Coroner, I believe a search of those woods is warranted and appropriate, and I ask for your assistance as we continue to investigate this case together. Please advise of your thoughts.
