## IN THE SENATE OF THE UNITED STATES.

Read twice and referred to the Select Committee on the Quadro-Centennial.

Reported by Mr. HAWLEY with amendments, viz: Omit the parts struck through and insert the parts printed in *italics*.

## AN ACT

- To provide for celebrating the four hundredth anniversary of the discovery of America by Christopher Columbus by holding an international exhibition of arts, industries, manufactures, and the product of the soil, mine, and sea in the city of Chicago, in the State of Illinois.
- Whereas, It is fit and appropriate that the four hundredth anniversary of the discovery of America be commemorated by an exhibition of the resources of the United States of America, their development, and of the progress of civilization in the New World; and
- Whereas, Such an exhibition should be of a national and international character, so that not only the people of our Union and this continent, but those of all nations as well, can participate, and should therefore have the sanction of the Congress of the United States: Therefore,
  - 1 Be it enacted by the Senate and House of Representu-
  - 2 tives of the United States of America in Congress assembled,
  - 3 That an exhibition of arts, industries, manufactures, and prod-

ucts of the soil, mine, and sea shall be inaugurated in the 4

year eighteen hundred and ninety-two, in the city of Chicago, 5

in the State of Illinois, as hereinafter provided. 6

1 Sec. 2. That a commission, to consist of two commis-2 sioners from each State and Territory of the United States and from the District of Columbia and eight commissioners 3 at large, is hereby constituted to be designated as the World's 4 Columbian Commission.

SEC 3. That said commissioners, two from each State 1 and Territory, shall be appointed within thirty days from the 2 3 passage of this act by the President of the United States, on the nomination of the governors of the States and Territories, 4 respectively, and by the President eight commissioners at 5 large and two from the District of Columbia; and in the same 6 manner and within the same time there shall be appointed two 7 alternate commissioners from each State and Territory of the 8 9 United States and the District of Columbia and eight alternate commissioners at large, who shall assume and perform the 10 duties of such commissioner or commissioners as may be un-11 able to attend the meetings of the said commission; and in 12 such nominations and appointments each of the two leading 13 political parties shall be equally represented. Vacancies in 14 the commission nominated by the governors of the several 15 16 States and Territories, respectively, and also vacancies in the 17 commission at large and from the District of Columbia may be

18 filled in the same manner and under the same conditions as

19 provided herein for their original appointment.

1 SEC. 4. That the Secretary of State of the United States

2 shall, immediately after the passage of this act, notify the

3 governors of the several States and Territories, respectively,

4 thereof and request such nominations to be made. The com-

5 missioners so appointed shall be called together by the Secre-

6 tary of State of the United States in the city of Chicago, by

7 notice to the commissioners, as soon as convenient after the

8 appointment of said commissioners, and within thirty days

9 thereafter. The said commissioners, at said first meeting,

10 shall organize by the election of such officers and the appoint-

11 ment of such committees as they may deem expedient, and

12 for this purpose the commissioners present at said meeting

13 shall constitute a quorum.

1 Sec. 5 That said commission be empowered in its dis-

2 cretion to accept for the purposes of the World's Columbian

3 Exposition such site as may be selected and offered and such

4 plans and specifications of buildings to be erected for such

5 purpose at the expense of and tendered by the corporation

6 organized under the laws of the State of Illinois, known as

7 "The World's Exposition of Eighteen hundred and ninety-

8 two:" Provided, That said site so tendered and the build-

9 ings proposed to be erected thereon shall be deemed by said

10 commission adequate to the purposes of said exposition: And

11 provided. That said commission shall be satisfied that the said corporation has an actual bona fide and valid subscription to 12 its capital stock which will secure the payment of at 13 least five millions of dollars, of which not less than five hun-14 dred thousand dollars shall have been paid in, and that the 15 further sum of five million dollars, making in all ten million 16 dollars, will be provided by said corporation in ample time 17 18 for its needful use during the prosecution of the work for the 19 complete preparation for said exposition.

SEC. 6. That the said commission shall allot space for 1 exhibitors, prepare a classification of exhibits, determine the 2 plan and scope of the exposition, and shall appoint all judges 3 and examiners for the exposition, award all premiums, if any, 4 and generally have charge of all intercourse with the exhib-5 6 itors and the representatives of foreign nations. And said 7 commission is authorized and required to appoint a board of 8 lady managers of such number, and to perform such duties as may be prescribed by said commission. Said board may ap-9 point one or more members of all committees authorized to 10 award prizes for exhibits, which may be produced in whole 11 or in part by female labor. 12

1 SEO. 7. That after the plans for said exposition shall be
2 prepared by said corporation and approved by said commis3 sion, the rules and regulations of said corporation governing
4 rates for entrance and admission fees, or otherwise affecting

- 5 the rights, privileges, or interests of the exhibitors or of the
- 6 public, shall be fixed or established by said corporation, sub-
- 7 ject, however, to such modification, if any, as may be imposed
- 8 by a majority of said commissioners.
- 1 Sec. 8. That the President is hereby empowered and
- 2 directed to hold a naval review in New York Harbor, in
- 3 April, eighteen hundred and ninety-three, and to extend to
- 4 foreign nations an invitation to send ships of war to join the
- 5 United States Navy in rendezvous at Hampton Roads and
- 6 proceed thence to said review. The President is further
- 7 empowered and directed to make arrangements fo the unveil-
- 8 ing of a statue of Christopher Columbus at Washington,
- 9 with appropriate ceremonies and civic and military parade,
- 10 under his general direction after said naval review, and not
- 11 less than five days before the opening of said Exposition, and
- 12 to invite the attendance thereat of foreign representatives.
  - 1 SEC. 8 9. That said commission shall provide for the dedi-
  - 2 cation of the buildings of the World's Columbian Exposi-
  - 3 tion in said city of Chicago on the twelfth day of October
  - 4 eighteen hundred and ninety-two, with appropriate ceremo-
  - 5 nies, and said exposition shall be open to visitors not later
  - 6 than the first day of May eighteen hundred and ninety-three,
  - 7 and shall be closed at such time as the commission may de-
  - 8 termine, but not later than the thirtieth day of October there-
  - 9 after.

SEC. 9 10. That whenever the President of the United Ï 2 States shall be notified by the commission that provision has been made for grounds and buildings for the uses herein 3 4 provided for and there has also been filed with him by the said corporation, known as "The World's Exposition of 5 eighteen hundred and ninety-two," satisfactory proof that a 6 sum not less than ten million dollars, to be used and expended 7 for the purposes of the exposition herein authorized, has in 8 fact been raised or provided for by subscription or other legally 9 binding means, he shall be authorized, through the Department 10 of State, to make proclamation of the same, setting forth the 11 time at which the exposition will open and close, and the 12 place at which it will be held; and he shall communicate to 13 the diplomatic representatives of foreign nations copies of the 14 same, together with such regulations as may be adopted by the 15 commission, for publication in their respective countries, and 16 he shall, in behalf of the Government and people, invite 17 18 foreign nations to take part in the said exposition and appoint representatives thereto. 19

SEC. 40 11. That all articles which shall be imported from foreign countries for the sole purpose of exhibition at said exposition, upon which there shall be a tariff or customs duty, shall be admitted free of payment of duty, customs fees, or charges under such regulations as the Secretary of the Treasury shall prescribe; but it shall be lawful at any time during

the exhibition to sell for delivery at the close of the 7 exposition any goods or property imported for and 8 9 actually on exhibition in the exposition buildings or on its grounds, subject to such regulations for the security 10 of the revenue and for the collection of the import duties 11 as the Secretary of the Treasury shall prescribe: Pro-12 vided, That all such articles when sold or withdrawn for con-13 sumption in the United States shall be subject to the duty, if 14 any, imposed upon such articles by the revenue laws in force, 15 at the date of importation, and all penalties prescribed by law 16 shall be applied and enforced against such articles, and against 17 the persons who may be guilty of any illegal sale or with-18 19 drawal.

1 SEC. 11 12. That the sum of twenty thousand dollars, or  $^{2}$ as much thereof as may be necessary, be, and the same is 3 hereby, appropriated, out of any moneys in the Treasury not otherwise appropriated, for the remainder of the present fiscal 4 5 year and for the fiscal year ending June thirtieth, eighteen hun-6 dred and ninety-one, to be expended under the direction of the Secretary of the Treasury for purposes connected with the ad-7 mission of foreign goods to said exhibition. 8 1 SEC. 12 13. That it shall be the duty of the commission

2 to make report, from time to time, to the President of the
3 United States of the progress of the work, and, in a final re4 port, present a full exhibit of the results of the exposition.

1 Sec. 43 14. That the commission hereby authorized shall

2 exist no longer than until the first day of January, eighteen

3 hundred and ninety-eight.

SEC. 14 15. That the United States shall not in any man-1  $^2$ ner, nor under any circumstances, be liable for any of the acts, doings, proceedings, or representations of the said cor-3 poration organized under the laws of the State of Illinois, 4 5 its officers, agents, servants, or employees, or any of them, or for the service, salaries, labor, or wages of said officers, 6 agents, servants, or employees, or any of them, or for any 7 subscriptions to the capital stock, or for any certificates of 8 stock, bonds, mortgages, or obligations of any kind issued by 9 said corporation or for any debts, liabilities, or expenses of 10 any kind whatever attending such corporation or accruing by 11

Sec. 45 16. That there shall be exhibited at said exposi-1 2 tion by the Government of the United States, from its Ex-3 ecutive Departments, the Smithsonian Institution, the United States Fish Commission, and the National Museum, such 4 5 articles and materials as illustrate the function and administrative faculty of the Government in time of peace and 6 its resources as a war power, tending to demonstrate the 7 nature of our institutions and their adaptation to the wants 8 9 of the people; and to secure a complete and harmonious 10 arrangement of such a Government exhibit, a board shall

11 be created to be charged with the selection, preparation, arrangement, safe-keeping, and exhibition of such articles and 12 materials as the heads of the several Departments and the 13 directors of the Smithsonian Institution and National Mu-14 . seum may respectively decide shall be embraced in said Gov-15 16 ernment exhibit. The President may also designate additional articles for exhibition. Such board shall be composed of one 17 person to be named by the head of each Executive Depart-18 19 ment, and one by the directors of the Smithsonian Institution and National Museum, and one by the Fish Commission, such 20 21 selections to be approved by the President of the United 22 States. The President shall name the chairman of said board, and the board itself shall select such other officers as it may 23 24 deem necessary. 25 That the Secretary of the Treasury is hereby authorized 26 and directed to place on exhibition, upon such grounds as shall 27 be allotted for the purpose, one of the life-saving stations au-28 thorized to be constructed on the coast of the United States by existing law, and to cause the same to be fully equipped 29 30 with all apparatus, furniture, and appliances now in use in all 31 life-saving stations in the United States, said building and ap-32 paratus to be removed at the close of the exhibition and re-

cause a suitable building or buildings to be erected on the site 2 3 selected for the World's Columbian Exposition for the Govern-4 ment exhibits, as provided in this act, and he is hereby authorized and directed to contract therefor, in the same man-5 ner and under the same regulations as for other public build-6 7 ings of the United States; but the contracts for said build-8 ing or buildings shall not exceed the sum of four hundred-9 thousand dollars, and for the remainder of the fiscal year and 10 for the fiscal year ending June thirtieth, eighteen hundred 11 and ninety one, there is hereby appropriated for said building 12 or buildings, out of any money in the Treasury not otherwise 13 appropriated, the sum of one hundred thousand dollars. The Secretary of the Treasury shall cause the said building or 14 15 buildings to be constructed as far as possible, of iron, steel, and, glass, or of such other material as may be taken out and sold 16 17 to the best advantage; and he is authorized and required to 18 dispose of such building or buildings, or the material composing 19 the same, at the close of the exposition, giving preference to 20 the city of Chicago, or to the said World's Exposition of 21 1892 to purchase the same at an appraised value to be ascertained in such manner as he may determine. 22 1 Sec. 47 18. That for the purpose of paying the expenses

SEC. 47 18. That for the purpose of paying the expenses of transportation, care, and custody of exhibits by the Government and the maintenance of the building or buildings here-inbefore provided for, and the safe return of articles belonging

to the said Government exhibit, and for the expenses of the 5 commission created by this act, and other contingent expenses, 6 to be approved by the Secretary of the Treasury, upon itemized 7 8 accounts and vouchers, there is hereby appropriated for the remainder of this fiscal year and for the fiscal year ending 9 June thirtieth, eighteen hundred and ninety-one, out of any 10 money in the Treasury not otherwise appropriated, the sum 11 of two hundred thousand dollars, or so much thereof as may 12 be necessary: Provided, That the United States shall not be 13 liable, on account of the erection of buildings, expenses of the 14 commission or any of its officers or employees, or on account 15 of any expenses incident to or growing out of said exposition 16 for a sum exceeding in the aggregate one million five hun-17 18 dred thousand dollars.

SEC. 18 19. That the commissioners and alternate com-1 missioners appointed under this act shall not be entitled to any 2 compensation for their services out of the Treasury of the 3 4 United States, except their actual expenses for transportation and the sum of six dollars per day for subsistence for each 5 day they are necessarily absent from their homes on the busi-6 ness of said commission. The officers of said commission 7 shall receive such compensation as may be fixed by said com-8 mission, subject to the approval of the Secretary of the Treas-9 ury, which shall be paid out of the sums appropriated by Con-10 11 gress in aid of such exposition.

1	SEC. 19 20. That nothing in this act shall be so construed
2	as to create any liability of the United States, direct or indirect,
3	for any debt or obligation incurred, nor for any claim for aid

- 4 or pecuniary assistance from Congress or the Treasury of the
- 5 United States in support or liquidation of any debts or obli-
- 6 gations created by said commission in excess of appropria-
- 7 tions made by Congress therefor.
- 1 SEC. 20 21. That nothing in this act shall be so construed
- 2 as to override or interfere with the laws of any State, and all
- 3 contracts made in any State for the purposes of the exhibition
- 4 shall be subject to the laws thereof.
- 1 SEC. 21 22. That no member of said commission, whether
- 2 an officer or otherwise, shall be personally liable for any debt
- 3 or obligation which may be created or incurred by the said
- 4 commission.
