“Average of the three days' ready delivery prices (including the last trading day) at other delivery centers as and when such delivery centers are specified by the Executive Committee in terms of Bye-law No. 520 after taken into account the transport charges to Indore, Value Added Tax, etc; however in case of Soybean the aforesaid ready delivery prices shall be exclusive of Value Added Tax.”

B. For Item No. 1.5(a) of Schedule I to the Bye-Laws of the Exchange, the following shall be substituted, namely:—

“(a) Yellow Soybean :

(i) Moisture 8% - 10% max. (as may be decided by the Executive Committee at the time of opening of Contract)

(iii) Damaged 2% max
