**No. 199-ITC(PN)/68.**—Attention is invited to the Import Policy for Registered Exporters contained in Volume II of the Import Trade Control Policy Book (Red Book) for the year April 1968—March 1969 issued under the Ministry of Commerce Public Notice No. 50-ITC(PN)/68, dated 1st April 1968.

2 The following amendments may be made at the appropriate places as indicated below:—

(i) The serial number mentioned against item No. 2 under para 2 of Public Notice No. 149-ITC(PN)/68 dated the 22nd July, 1968 may be amended to read as "A. 63" instead of "A. 49.2".

(ii) The entry at 2 under para 4 of Public Notice No. 128-ITC(PN)/68 dated 4th July, 1968 may be deleted, as the item "Bakelight tops for ignition coils" has been appropriately classified under S. No. C. 12 in Public Notice No. 154-ITC(PN)/68, dated 27th July, 1968.

2. As a result of the representations received, the import policy in respect of certain items has been reviewed and it has been decided to make the following amendments in the Import Trade Control Policy (Red Book—Vol. I) for the period April 1968—March 1969:—

39	Section II, S.No.41-A/II, Column 4. 1	The existing remark may be deemed to have been substituted by the following remarks:— "(1) A.U. for import of:— (a) cathodes blocks <i>i.e.</i> , carbon furnace (liner) blocks for use in electric furnaces. (b) graphite anodes required for electrolytic processes (on restricted basis). (2) Import of graphite electrodes and carbon paste will not be allowed."
51	Section II, S. Nos. 127—129/IV, Column 4.	(1) The item '(n) Orange oil' appearing in remark (2) may be deemed to have been deleted. (2) The following new remark may be deemed to have been inserted:— "(4) A.U. for import of Orange oil for export production only."
62	Section II, S. Nos. 34—37(d)/V, Column 4, remark (ii).	The remark (ii) may be deemed to have been substituted by the following:— "A.U. for import of:— (a) Pearl for manufacture of simulated pearls. (b) Pearl essence for manufacture of simulated pearls and acrylic plastic sheets."
