No. 10187-Agr VII-67/28801.—Whereas the Haryana Government Notification No. 10187-Agri-VII 67/28798, dated the 9th November, 1967, certain forests and waste lands mentioned in the Schedule appended thereto have been declared Section 29 of protected Forests under Indian Forests Act, 1927;

Now, therefore, the Governor of Haryana, in exercise of the powers conferred by Section 30 of the said Act, hereby:-

- (a) declares all standing trees in or upon these lands to be reserved, from the date of publication of this notification in the Official Gazette for a period of 30 years; and

(4) No person shall set fire to grass, tree or timber or kindle a fire on the land without taking reasonable precautions to prevent its spreading.

(5) No person shall clear or break up land for cultivation or for any other purposes.

(6) Income from compounding of offences under Section 68 of Indian Forest Act, 1927, shall be credited to Government.

(7) No person shall hunt, shoot or fish on the said land.

In case neither of them is present one of the non-officials present at the meeting will preside over it as may be mutaually agreed upon by the Members present.
  - 3. Three members present shall form a quorum for a meeting.

Bills of the membes of the Legislature will, however, continue to be countersigned by the Secretary, Haryana Vidhan Sabha and in the case of others by the Chief Secretary (in Accounts Branch).
  - (e) The Travelling Allowance for attending the meetings of the Committees should be allowed to the members from their permanent place of residence, to the place of the meeting. If, however, a member attends a meeting from a place other than the place of his permanent residence, T. A. should be allowed to him e ther from the place of his residence or from where he attends the meeting, whichever is less.
  - (f) The T. A and D. A. will be admissible to the non-official members (other than M.L.As.) on the production of a ce tificate to the effect that no T.A. in respect of the journey or D.A. for the period mentioned in the bill has been or will be claimed by him/her from any other official source.
