As per the reference cited the notification for a legal heirship certificate had been published in Kerala Gazette

dated 10-7-2012 Vol. 57, No. 28, Page No. 4365 & 4366. In that notification there is a sentence included by mistake, that "Parents of late Varghese Thomas are not alive". During the specified period of 30 days of above notification, there was no objection received orally or written. Since no objection received in the specified period, the legal heirship certificate was issued from this office (vide reference No. 4). But after the issue of the certificate it was known that the mother of late Varghese Thomas, Smt. Sosamma Varghese is alive.

Eventhough the issued certificate is genuine there is a sentence in the certificate by mistake that the parents of the deceased are not alive. For that reason the certificate issued from this office as per reference 4 cited is hereby cancelled. A new legal heirship certificate will be issued after the completion of all formalities as per the existing rules.
