Sealed competitive tenders are invited for hiring one fully covered pick up van with driver on contract basis for Iddli making Unit at the Special Sub Jail, Thiruvananthapuram for a period of one year (2013-2014) initially, which is likely to be extended further based on performance.

CONDITIONS

- 1. Average running distance/day: 60Km.
- 2. Pick up van should be ready at 5 a.m. on every day at special Sub Jail, Thiruvananthapuram Premises.
- 3. Normal period of requirement is from 5 a.m. to 6 p.m. every day.
- 4. Quoted rates should include all operation and maintenance expenses including fuel charges & remuneration to the Driver. Alteration should not be made in the tender form or schedule or Tender Conditions except to the extent of filling in the tender forms and schedules.
