Bye-Laws of the Devalaya of Shri Mahadev and its affiliated Devalayas of Velguem of Bicholim Taluka

Chapter I

Rights and Obligations

Article 1- In the village of Velguem of Bicholim Taluka, there exists the Devalaya of Shri Mahadeva.

The following temples are affiliating to the above Devalava:

- 1) Shri Shantadurga.
- 2) Shri Ravalnath.
- 3) Shri Quelbai.
- 4) Shri Dad-deu.
- 5) Shri Charado.
- 6) Shri Vagro and Marangana.

Article 2—(a) The General Body of the Devalaya shall be composed of the Mahajans mentioned in the annexed list and those persons professing Hindu religion who may, in future, be admitted as Mahajans by the Managing Committee of the Devalaya irrespective of caste, class, sect or family group to which such person may belong on payment of such enrolment fee as may be prescribed for the purpose by the General Body of the Devasthan, which fee, in no case, shall totally exceed Rs. 10/- (Rupees Ten).

(b) A person once enrolled as Mahajan shall enjoy rights, privileges, honours and obligations along with all other Mahajans unless he is prevented to enjoy the same, in terms of these bye-laws or the laws in force.

Article 3—(a) The right of all mahajans including of those who may be admitted as mahajans in terms of preceding article is hereditary and perpetual in the masculine lineage and is transmitted from generation by consanguinity or by legal adoption. This right becomes effective once a person becomes of major age and is duly enrolled as mahajan including those who may be admitted as mahajans in terms of preceding article.

(b) The list of all mahajans shall be properly maintained by the Managing Committee and a upto date copy of the same shall be displayed on the notice board of the Devalaya in the month of January every year.

Article 4—(a) All those professing Hindu religion, irrespective of caste, class, sect or family group shall be allowed, according to usage and customs, to render worship in the premises of the Devalaya and also to perform religious acts and to institute festivities and make donations to the Devalaya.

(b) Such acts shall, however, in no way, entitle them to claim mahajanship of the Devalaya.

Article 5—Every mahajan shall pay to the treasurer of the Devalaya a fixed annual subscription or such fee as may be prescribed for the purpose by the general body of the mahajans of the Devalaya.

Article 6—The members of the Managing Committee shall be responsible to carry out the duties and work relating to the temple without any remuneration.

CHAPTER II

Funds

Article 7—The assets of the Devalaya comprise of the following immoveable properties, in possession of the Devalaya, namely, lands and buildings mentioned herebelow. All such assets will be listed with proper discription in the Inventory Book of the Devalaya.

- (a) The building of the Devalaya of Shri Mahadeva situated in landed property "Deulacadii Tucda", registered under Survey No. 1 with sub-divisions 1, 2 & 3 with areas of 1225 sq. mts., 8525 sq. mts. and 625 sq. mts. respectively. This includes the Building of Agrashala.
- (b) The building of the Devalaya of Shri Shantadurga situated in landed property "Chinchantil Moli", registered under Survey No. 74 with an area of 8175 sq. mts.
- (c) The building of Shri Dad-deu situated in landed property registered under survey No. 44 with an area of 3425 sq. mts.
- (d) A paddy field known as "Mharwad", registered under Survey No. 6, sub-division 1, with an area of 2125 sq. mts.
- (e) A paddy field known as "Deuli-Xeta", registered under Survey No. 6, sub-division 2, with an area of 3100 sq. mts.
- (f) A paddy field known as "Namas", registered under Survey No. 6, sub-division 3, with an area of 1225 sq. mts.
- (g) A landed property with cocoanut grove and jack-fruit trees, known as "Palmar Namas or Uddo", registered under Survey No. 6, sub-division 4, with an area of 2500 sq. mts.
- (h) A landed property registered under Survey No. 41, sub-division 6, with an area of 50 sq. mts., wherein a pedestal is erected in honour of Shri Ganesh.
- (i) A paddy field known as "Dev-Xeta", registered under Survey No. 40, sub-division 3, with an area of 2300 sq. mts.
- (j) A paddy field known as "Kungo", registered under Survey No. 69, sub-division 2, with an area of 1975 sq. mts.
- (k) A paddy field known as "Bhavin-Xeta", registered under Survey No. 54, sub-division 6, with an area of 1900 sq. mts.

CHAPTER III

Receipts and Expenditure

Article 8 - The receipts consist of: --

- (a) Rents of immovable properties.
- (b) Interest of funds.
- (c) Offerings.
- (d) Subsidies.
- (e) Charges collected on the celebration of religious acts.
- (f) Annual contribution of mahajans.
- (g) Donations made by any person or institution inclusive Comunidade of Velguem.
 - (h) Entrance fee of new mahajans.
- (i) Proceeds of articles sold on auction on various festivities and occasions.
 - (j) Amount collected by way of fines, etc.
- (k) Amount of revenue from the properties which may be acquired.
- (1) Money accummulated in the donation box provided in the Devalaya.
- (m) Amounts collected on hire charges of the temporary shops allowed on festive occasions.
- II. The Expenditure of the Devalaya shall consist of: -
- (a) Maintainance and cleanliness of the temple and its premises.
 - (b) Festivities and religious performances of the temples.
 - (c) Government and other taxes.
 - (d) Salaries, wages/remmuneration of the employees.
 - (e) Non-recurring expenditure.
 - (f) Stationery.
 - (g) Cost of publication of public notices.
 - (h) Cost of purchase of law books.

III. The annual receipts and expenditure shall be estimated in the form of an annual budget that will be prepared by the Managing Committee of the Devalaya and approved by the General Body and by the Government, in accordance with provisions of "Regulamento das Mazanias" in force.

CHAPTER IV

Worship and festivities

Article 9 — The daily worship in the Devalaya of Shri Mahadeva consists of Abhishek, Puja, Neivedya and Nandadipa with the observance of all ritual formalities.

(a) There shall be two oil lamps burning throughout the day and night in the "Garbhagar" (sanctum sanctorum where the Linga and Idol of Lord Shri Mahadeva are enshrined) of Shri Mahadeva. The expenditure with burning of one oil lamp shall be incurred from the income of the Devalaya and of the other oil lamp by Dalvi families of Pale.

Article 10 — The annual festivities of the Devalaya are as shown below:

- Ramanavamim from 1st to 9th day of month Chaitra of Hindu Calendar.
- Mhatan Samaradhana on the 5th day of first fortnight of the month of Vaishak.
- 3. Zagor on any day of new moon of the month of Vaishak.
- 4. Four Mondays in the month of Shrawan.
- 5. Dattajayanti on the Full Moon day of the month of Margashirsha (Margashirsha Pournima).
- 6. Cala on the eight day of first fortnight of the month Paushya (Paushya Shudda Ashtami).
- Shigmo on the tenth day of second fortnight of the month Phalguna (Phalguna Vadhya Dashmi).
- (a) The annual festivity of Diuzanchi Zatra is also celebrated in the Devalaya of Shri Mahadeva and of Shri Shantadurga on the New Moon day of the month of Kartika (Kartika Amavashya) as well as of Navem in the month of Chaitra. This ceremony consists of cutting new spike in paddy field.
- (b) (i) The expenditure with festivities under Nos. 2, 3, 6 & 7 shall be incurred from the income of the Devalaya.
- (ii) The expenditure with the festivity of Ramanavami shall be borne by the families of Prabhu Velguenkar of Velguem, of Dhabal of Sanguem Taluka, of Dhond, of Bhat Sahastrabudhe and of Bhat Gobre of Velguem, being half of the expenditure by families of Porobo Velguenkar of Dabhal of Sanguem Taluka and the remaining half by other already mentioned families of Porobo Velguenkar, Dhond, Bhat Sahastrabudhe and Bhat Gobre of Velguem.
- (c) (i) Expenses with celebration of festivity of four Mondays in the month of Shrawan referred to in No. 4 will be borne as follows:—
 - 1st Monday by Bhicaji Shridhar Prabhu of Conxem of Ponda; 2nd Monday by Shankar Shivram Prabhu of Nirankal of Ponda; 3rd Monday by Shri Raghunath Shaba Prabhu Saukar of Borim on behalf of Vishun Ladke Porobo Velguenkar of Nirankal and the fourth Monday by Shri Krishnaji Yeshwant Prabhu Velguenkar of Torla of Siroda.
- (ii) In the case of five Mondays in the month of Shrawan, the fifth Monday shall be celebrated by collecting donation from the mahajans of Devasthan.
- (d) The festivity of Dattajayanti referred to in No. 5, shall be celebrated by Shri Anant Uttam Prabhu Tendulkar of Velguem, on behalf of Shri Shankar Govinda Porobo and Sazu Ragoba Porobo of Dabhal of Sanguem Taluka.

Article 11 — The charges payable by the Devotees for performance of various religious ceremonies shall be as shown below, subject to modifications as may be made by the General Body of the Devalaya from time to time: —

(i) One eighth of the above charges for religious acts listed under Nos. 1 & 2 and one fourth of charges for the religious acts listed under Nos 3 to 6 shall constitute the receipts of the Devalaya; three fourths of the charges for religious acts under Nos. 1 to 6 shall be the income of Bhat Pujari and the remaining one eighth of the charges for religious acts under 1 & 2 shall go to Bhavin and Deuli.

CHAPTER V

Servants and their duties

Article 12 — (a) The remmunerated staff of the temple is:—

- 1) Bhat Pujari.
- 2) Zalmi.
- 3) Camat.
- 4) Deuli and Bhavin.
- 5) Parwar.
- I) Bhat Pujari shall perform daily at 7.00 a.m. Nirmalya Visarjan (removal of flowers etc. of the previous day from linga and Idol), Abhishek, Mahapuja, Neivedhya, Arati, Prasad in the Devalaya of Shri Lahadeva in Garbhagar (Sanctum sanctorum where Linga and Idol of Lord Shri Mahadeva are enshrined). He shall also perform all religious acts/ceremonies on behalf of habajans/devotees since no other person than Bhat Pujari shall. The of entry into the Garbhagar of Shri Mahadeva. It is the Garbhagar of Shri Mahadeva. It is ceremonies and annual festivities are duly celebrated in the Devalaya of Shri Mahadev and proper cleanliness is maintained in the Garbhagar of Shri Mahadeva.
- II) The Zalmi shall perform all the religious acts/ceremonies daily and occasional, according to the practice followed hitherto in the affiliated Devalaya of Shri Shantadurga, Shri Ravalnath, Shri Quelbai, Shri Dad-deu and Shri Vagro.
- III) The Camot shall perform all the periodical religious acts and ceremonies in the Devalaya of Shri Charado.
- IV) The Deuli and Bhavin shall be responsible to maintain cleanliness in the premises of Devalaya of Shri Mahadeva, except Garbhagar, and of affiliated Devalayas. They shall also wash and clean all the vases and utensils belonging to the Devalayas and render all the assistance needed with promptness for celebration of festivities. The Deuli shall, in particular, hold the burning torch (Diuti) on the occasion of the festivities, take correspondence to the Mamlatdar's Office at Bicholim and to canvass verbally to all Mahajans to attendmeetings of the General Body as well as to tenants of the lands of Devalaya to pay rents or whatever amount due to the Devalaya. The Deuli and Bhavin shall attend to the wedding ceremonies of mahajans whenever invited and render whatever assistance needed by mahajans during such ceremonies.
- V) Any member of Parwar in the employ of Devalaya shall perform cultural acts in the Devalaya of Shri Marangana and other duties assisgned to him during annual festivities
- b) The salaries of the above staff will be as fixed in the annual budget of the Devalaya.

In addition to the salaries, the above staff and families, as detailed below, so long they are in the employ of Devalaya and perform religious and cultural acts, may do all the necessary work for cultivation of the paddy fields, as shown in the column 2 and retain their produce for consumption and for performance of all cultural acts in the Devalaya:—

c) Besides Bhat Pujari and the above staff, such as Deuli, Bhavin, Parwar, the Managing Committee may engage such of the staff as it deems necessary at remmuneration to be fixed by it with prior approval of General Body, provided there are sufficient funds available to meet the expenditure.

CHAPTER VI Penal and other provisions

Article 13—(a) Any mahajan in arrears of payment of annual subscription, if prescribed, due by him for three successive years and also those who indulge in the premises of the Devalaya in the commission of acts which cause or are likely to cause disorder or to offend the sentiments of other mahajans and those who enter premises of the Devalaya in drunken state, shall be disqualified to be a candidate or to cast vote in the election of the members of the Managing Committee.

- (b) The following are the penalties prescribed for those who fail to perform duties or disobey the orders of the General Body or of the Managing Committee in relation to the temple administration:—
 - 1) Warning.
 - 2) Suspension from duties for a period ranging from 10 to 30 days.
 - 5) Dismissal from duties.
- (c) The Managing Committee or the General Body shall not award any of the above penalties to the mahajans or the employees unless they are given an opportunity of being heard to defend their case.
- (d) Against the penalities imposed by the Managing Committee there shall be an appeal to the General Body of the Devalaya.

Article 14 — The administration of the Devalaya shall be regulated by these bye-laws and by the "Regulamento das Mazanias" in force, as well as by any general or special laws and regulations applicable or which may be made applicable in future to such institutions,

Article 15 — The above bye-laws shall come into force five days after their publication in the Official Gazette.
