

FOREWORD

This is a selected bibliography of references taken from a keysort file of 45,000+ references. This file is established in the Andrus Gerontology Center, compiled from commercially-available data bases and published sources relevant to gerontology. The data bases consisted of BA Previews (*Biological Abstracts* and *BioResearch Index*), MEDLINE/MEDIARS (*Index Medicus*), PASAR (*Psychological Abstracts*), Drug Abuse Information Center, Brain Research Information Service, *Sociological Abstracts* (1963-1967), *International Political Service Abstracts*, ERIC, NTIS and NEXUS. The published sources were primarily compiled from the entire file of Dr. Nathan Shock's "Current Literature in Gerontology and Geriatrics" published in each issue of the JOURNAL OF GERONTOLOGY, FROM 1959-1974 and various announcement services, such as PUBLISHERS' WEEKLY, MONTHLY CATALOG OF U.S. GOVERNMENT PUBLICATIONS, MONTHLY CHECKLIST OF STATE PUBLICATIONS, DISSERTATION ABSTRACTS, etc. All references were originally entered into the keysort file without editing or checking.

For this bibliography, all references of questionable accuracy were checked or deleted as the verification process was performed. Most of the references were selected from 1959-1974. However, some earlier ones were included if they were regarded as significant in the area of study. English-language references were stressed in the selection criteria but foreign titles containing unique data were not excluded. In many cases the titles have English abstracts for the convenience of the reader.

Many of the references listed herein can be obtained through a library or the interlibrary loan system. They are not necessarily available from the Andrus Gerontology Library at the University of Southern California. In some cases, the books may still be in print and can be purchased through a local bookstore or jobber. For journal articles, the full name of the issuing journal has been spelled out to aid in the acquisition of the item through their own library.

We wish to thank the bibliography staff for their help in making this bibliography possible.

THE ETHEL PERCY ANDRUS GERONTOLOGY CENTER

The Gerontology Center was established in 1964 for the purpose of creating a special environment for training and research in human development and aging. In 1971 it became the Ethel Percy Andrus Gerontology Center in honor of the founder of the National Retired Teacher's Association, The American Association of Retired Persons and an alumna of the University of Southern California.

Over 400,000 members of the organizations founded by Dr. Andrus contributed generously toward the construction of the 88,000 square foot, three story brick building on the west side of the campus. Alumni, philanthropic foundations and friends of USC also contributed substantially to the establishment of the Andrus Center, which was dedicated in February, 1973.

The operations of the Andrus Center may be divided into three principal areas:

1. The Research Institute which initiates, designs, and executes research on the many phases of aging.
2. Community Programs is directed to continuing professional education in various aspects of aging.
3. The Leonard Davis School of Gerontology, opening in September, 1975, will provide a curricula for the undergraduate education and training of personnel to meet growing needs in the expanding field of aging.

The harmonious integration of these operations will contribute to progress in many directions in the years ahead.
