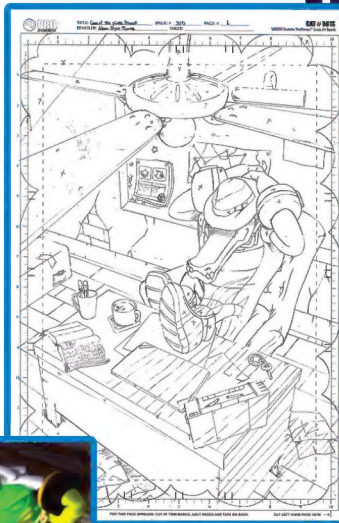
DETECTED DETECTIVES!!!

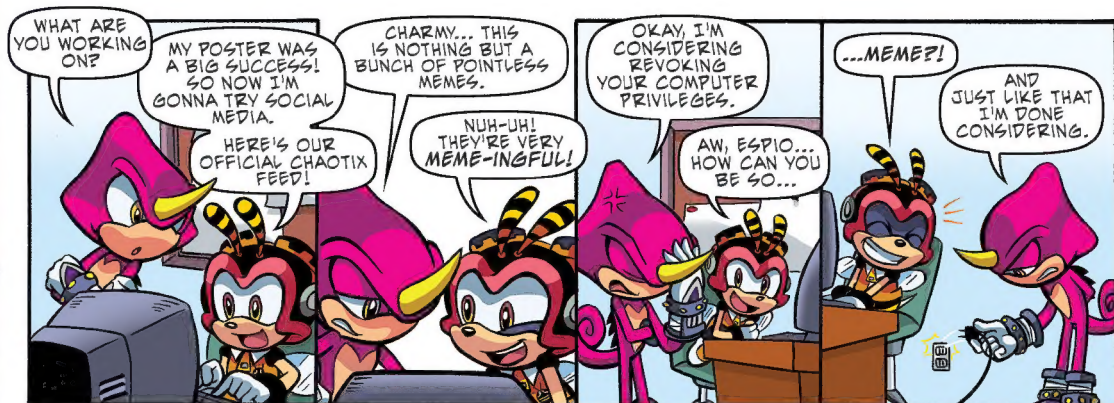
