A MESSAGE TO THE READER.

The following events about to be presented here. Are the known facts Investigated by me as the facts; that lead up to the disappearance of Heidi Allen on EASTER SUNDAY of April 3,1994.

DESCRIPTION OF A MISSING PERSON

Heidi M. Allen is an 18 year old white female. Date of birth 9-14-75. She has been missing since the morning of Easter April 3,1994. She is 5'11", 145 lbs., Blonde Hair, and Hazel Eyes and may be wearing glasses.

She was last seen at the D&W Convenience Store located on the corner of route 104 and rout 104B of New Haven New York, Easter Sunday morning of April 3,1994. She was wearing Jeans, a sweatshirt with plaid SU on the front, and white sneakers.

## WHO IS HIEDI M. ALLEN?

Heidi Allen lived in New Haven New York her entire life. For unknown reasons. She lived with her Grandmother rather than with her parents. Heidi was a Freshman for one year at the Mexico H.S. of New York. She then was enrolled into the OSWEGO CATHOLIC H.S. of Oswego New York. The events leading to this change of school is uncertain.

Prior to her disappearance. She attended Onandoga Community College. She worked at the D&W Convenient Store of New Haven New York. This store is owned by Matthew Duell, Cristine Duell, Cristine parents?.

## THE DAY HIEDI M. ALLEN WAS MISSING

Last person to see Heidi in the D&W Convenience store was Richard Thibodeau. Richard arrived parking in front of the front store cashiers window near the front door. Richard got out of the van and was confronted by an unknown person at the time holding the door open for Richard to enter the store. This person was later identified as John Swenszkowski driving a red XR7 sports car. The person proceeded on leaving the store. Richard purchased two packs of cigarettes. Paid for the items and left the store. Richard got into his van. Started it and had looked up to the window and had seen Heidi Allen looking out the cashiers window at Richard and smiling.

Before leaving the store parking lot. Richard had noticed the red XR7 parked near the pay phone. The driver of the red car was the man he recognizes as the man that had previously left the store holding open the door allowing Richard to enter Store during the entire event from arriving and leaving the Store.

The red XR7 sped Ahead of Richard in his van. And had turned left towards the direction of New Haven. Richard had proceeded left towards mexico for his home to pickup his family for a Easter Holiday event and dinner at Teresa Crawford's grandmothers home Leona Cory.

The following events proceeded with the arrival the following people. The first to arrive was David Stinson. Proceeded not in order were Pat Granger, and John Glinister. Within minutes of Richard and John's departure of the Convinient store. An Oswego Deputy Sheriff was presumably flagged down by one or more of the persons mentioned above. Later it is known that the Sherrif was called to the 104 and 104b intersection on a complaint of a BLUE VAN speeding and squealing rubbber on the road of 104b. This sheriffs name was Deputy Rick Curtis. At this time he was told that the D&W Clerk was no where to be seen or found. Heidi is presumably missing at this time.

## THE INVESTIGATION OF THE MISSING HIEDI M. ALLEN CASE

Detective Yerdon - Fred McClean spoke harshly of thier accusing Gary and Richard. He claimed they were inocent. Yerdon said, "How can you say this? You Use to be one of us. Fred replied, "Ya, and that is why I left the force. Detective Wheeler was also present.

## ABOUT RICHARD THIBODEAU

Richard is from Fitchburg Massechussets. First arrived in Mexico NY. 1984 because his two sisters Joan Barllow, Judy ?. Met Teresa Crawford that year and moved to rhode island for about a year looking for work. No work was found and moved back to Mexico 1986.

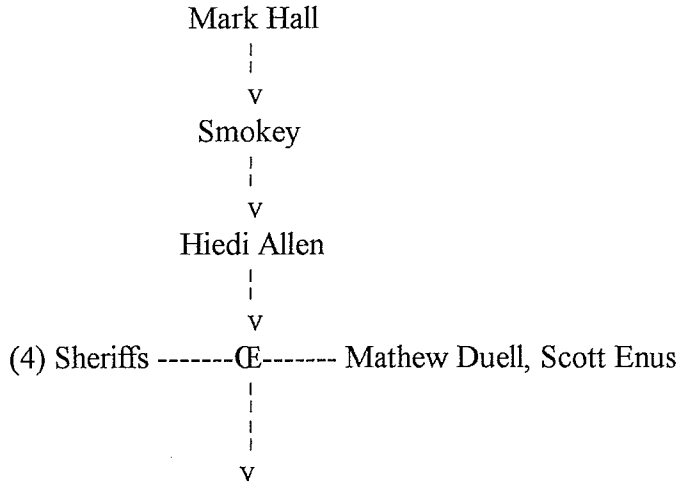
