

P R E F A C E .

THIS work was so far completed in August, 1863, that proposals were issued for its publication whenever subscriptions should be received to cover the bare cost of printing. As the people were then engaged in a greater undertaking, the subscriptions only reached one-fourth of the sum needed, and the work has awaited its time; the earlier portions of it slowly ripening, from the accession of additional material which has come to light, while the later generations have, perhaps, gradually grown more imperfect, from the occurrence of numerous births, marriages, and deaths, which have not been reported to the compiler.

While all genealogists aim at perfection, the best of their works show the hopelessness of reaching it in a first edition; and if in this case it is ever reached, it will be through the help of each one, who, seeing in it an imperfection or an error, shall promptly send the missing facts to the compiler.

For assistance in gathering records, rendered by persons outside of the family, special acknowledgments are due to Dea. Alfred Andrews, of New Britain, Conn.; Hon. George C. Woodruff, and the late Payne Kenyon Kilbourne, of Litchfield, Conn.; Rev. William P. Aiken, of Newington, Conn.; and the Judges of Probate, and Town Clerks of Hartford, Wethersfield, and Litchfield, Conn.

PUBLISHER'S NOTE TO PREFACE.

IN the year 1847 I began collecting the records of the family of John Stoddard, of Wethersfield, Ct., expecting at that time to be able to connect them with the family of Anthony Stoddard, of Boston. In 1870, at the request of some members of the family, I again took up the work, and after I had made considerable progress, I learned that Mr. D. W. Patterson had in 1860 nearly completed a genealogy of that family. I therefore made arrangements to buy his work, and have him carefully compare the two collections; incorporating with his whatever additions my own furnished. The result is, without doubt, a more complete work than either would have made alone; and will, I trust, receive the approval of the family.

EXPLANATION.

THE names of the Stoddards are arranged in generations; the whole of one generation being given before any of the next; a number, of a regular series, being given to each for convenient reference; which number follows the name in brackets, thus [], when it appears elsewhere, to identify the individual, and refer to his record; while another number following his name in parenthesis, thus (), refers to the record of his first child.

The records of those in the female lines, bearing other names, are given in connection with the account of their parents, the names being printed in different type.

The Roman numerals before the names of the Stoddards, and the Arabic figures before those of other descendants, indicate their order in their respective households; while the small superior figure, at the right of each name, denotes the number of the generation.

When frequently repeated in the same connection, names of towns are represented by their initial letter or syllable. A complete index of Christian names of Stoddards, and family names of those intermarrying, follows at the close of the work.

THE NAME.

“STODDARD. Concerning the origin of this name there is a tradition, that the first of the family came over with William the Conqueror, as standard-bearer to Viscompte De Pulesdon, a noble Norman, and that the name is derived from the office of a standard-bearer, and was anciently written *De La Standard*, corrupted to *Stodard* or *Stodart*.”

GENEALOGY.

1. JOHN STODDARD¹ (2) was an early settler in Wethersfield, in the Colony of Connecticut, where several parcels of land were recorded to him, June 18, 1645. He seems to have been there for several years prior to that date; as his name occurs in the records of the Colony as Juror, March 2, 1642-3, as plaintiff in an action of trespass against John Plum,—damage 20 shillings,—April 6, 1643; as defendant in an action brought by William Boreman, Dec. 4, 1645, and July 5, 1646. Hinman's *First Puritan Settlers of Connecticut*, p. 77, calls him "Sergeant, of Wethersfield, 1639," but on what authority does not appear.

The name appears on the early records in the following forms: Stadart, Staddart, Stader, Stadder, Stodar, Stodard, Stoddar, Stoddard, Stoder, Stodder, Stother and Studard.

He married, about 1642, Mary Foote, who was b. in England about 1623, dau. of Nathaniel and Elizabeth (Deming) Foote. He d. W., Dec. —, 1664; an inventory, dated Dec. 20, 1664, showed an estate of £407-8-0. His widow m. (2d) 1674, John Goodrich, Sen., of W., who d. April —, 1680; and she m. (3d) in 1683, Lieut. Thomas Tracy, of Norwich, Conn., who d. Nov. 7, 1685. The date of her death does not appear, though she was living as late as August, 1685. See Goodwin's *Foote Genealogy*, pp. 47 and 269-70, and *History of Norwich, Conn.*, by Miss Caulkins, Ed. of 1866, p. 201.

One of his descendants in Lisle, Broome Co., N. Y., has an account book begun by his grandson, John Stoddard, of Wethersfield, and Litchfield, in November, 1716, and, by his descendants, used for more than one hundred years, for accounts and family records, in which are statements that seem, at first sight, to show a different name for the wife of John Stoddard.

"My Great Grandfarthr by the name of John was born about 1620, and My Grandfarthr about 1660, as near as the ancient record Says; y^e first died in 1703, the latter in 1728—January.

"My mother's name was Abigail Peck, Grand Mother Sarah Camp, her Mothers Name Mary Sanford & her Mothers Name was Sarah Smith who came from London, in the 17th year of her age."

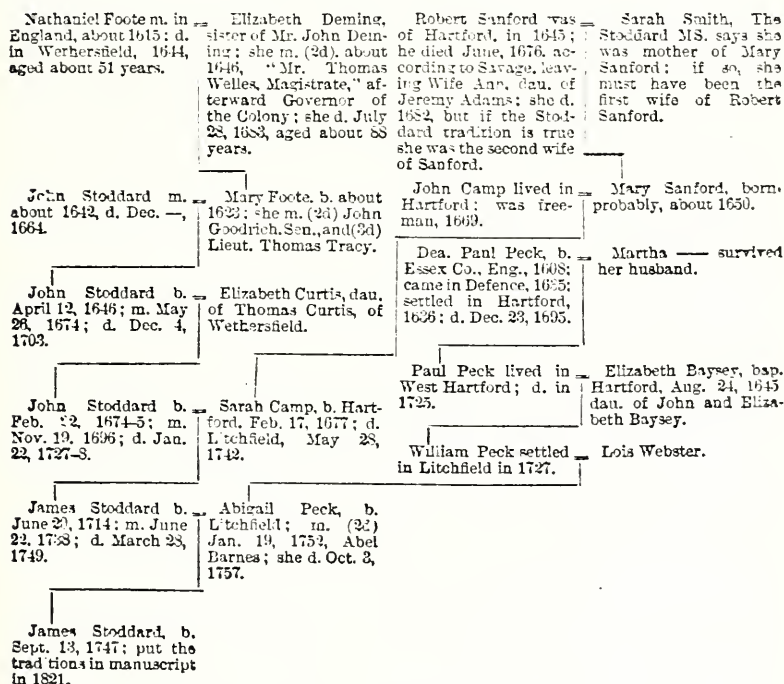
"My Grand Farthers name was John, and his farthrs Name was John who Married Mary Sanford; he died December 4th 1703, and his farther Married Sarah Smith from London about 1632, as near as we can find—but have no account of his Decease.

"My Mothers Name was Abigail Peck—My Grand Mothers Name was Sarah Camp—her mothers Name was Mary Sanford & her Mothers Name was Sarah Smith who came from London to Hartford, and returned with my Great Grandfathers Farther, John Stoddard for her Portion before she married—which was £100 : 0 : 0—Sterling."

A comparison of the several versions, which were all written by one hand, will show that the writer did not clearly know whether he was giving an account of his ancestors in the paternal or maternal line, and one can hardly tell which version is most truthful. The following pedigree shows the facts, as they now appear :

2. I. MARY², b. Wethersfield, Conn., March 12, 1643 [1643-4]; Mr. Goodwin says May 12, but the original record is plainly March,

and the Probate record agrees with it. She m., Dec. 10, 1663, **Joseph Wright**, son of Thomas Wright, of W. She d. W., Aug. 23, 1683, "aged about 38 years," according to the record, yet really 39 years, 5 months, and 11 days old. He m. (2d), her sister Mercy. Children:

2. ELIZABETH², b. W., Nov. 18, 1667.

3. JOSEPH², b. W., Feb. 14, 1669-70; m., May 21, 1701, Mary, dau. of Joseph Dudley, of Guilford; settled in Colchester, Conn., where he d. Sept. 2, 1756, aged 87 years.

4. SARAH², b. W., May 16, 1674.

5. THOMAS², b. W., Jan. 18, 1676-7.

6. JOHN², b. W., May 19, 1679.

7. JONATHAN², b. W., June 18, 1671.

3. II. JOHN², (9) b. W., April 12, 1646; m. W., May 26, 1674, Elizabeth Curtis, dau. of Thomas Curtis, of W., who d. in Wallingford Nov. 13, 1671. He d. W., Dec. 4, 1703, "Etatis Suae 58 years, i.e. if he had lived till Aprill next coming." His Will was dated Nov. 30, 1703; inventory dated Jan. 10, 1703-4, amounted to £725-9-6. The date of her death does not appear.

4. III. CALEB², (twin) b. W., Sept. 12, 1648; d. before his father.

5. IV. JOSHUA², (twin) b. W., Sept. 12, 1648; m. W., Aug. 15, 1680, "Bethia his wife." Goodwin says she was Bethia Smith, dau. of Richard Smith of W. He d. about 1725, and his wife about the same time, *s. p.* His estate was distributed Aug. 2, 1726, to the heirs of his brothers and sisters. Her estate was distributed July 13, 1725, to her brothers and sisters, Samuel Smith, Joseph Smith, Benjamin Smith, Beriah Fox, and Hester Strickland's heirs.

6. V. MERCY², b. W., Nov. —, 1652; m. W., March 10, 1685, **Joseph Wright**, of W., whose first wife was her sister Mary. He d. Jan. —, 1715. The date of her death does not appear. Children:

1. BENJAMIN², b. W., Dec. —, 1686.

2. NATHANIEL², b. W., Oct. 16, 1688.

7. VI. ELIZABETH², b. W., July —, 1656; Goodwin says she m. — Wright.

8. VII. NATHANIEL², (18) b. W., March —, 1660-61; according to Mr. Goodwin, his first wife, Mary, d. Jan. 17, 1693, yet I could find no such record in W. Her child was b. Jan. 17, 1692 [1692-3], and she probably d. about that time. He m. (2d) Dec. 7, 1693, Eunice Standish, dau. of Thomas and Susanna Standish of W. He d. Feb. 9, 1714, aged 54 years; she d. Aug. 5, 1716, aged 52 years.

Children of JOHN² [3] and ELIZABETH (Curtis) STODDARD.

9. I. JOHN², (21) b. Wethersfield, Feb. 22, 1674-5; m. W., Nov. 19, 1696, Sarah Camp, b. Hartford, Feb. 17, 1677, dau. of John and Mary (Sanford) Camp. In 1712-15, he was one of the petitioners for the incorporation of Newington, as a separate ecclesiastical society. He was one of the proprietors, and an early settler, of the town of Litchfield, Conn., where, according to the family record and grave-stone, he d. Jan. 22, 1727-8, "aged 53." The Litchfield town record notes the death of Ensign John Stoddor, but gives no date. His widow d. L., May 28, 1742, according to the town record, while the family record says 1743.

10. II. JOSEPH², b. W., Feb. 10, 1676; d. May 8, 1677.

11. III. "ELIZABETH², the Daughter of John Stader and of Elizabeth his wife was borne february 4 day of nouembr 1678" [Wethersfield town record]. Her name, as a single woman, appears in a list, dated Nov. 11, 1747, of the members of the church in Newington, where she d. May 15, 1755, age not stated. Her estate was appraised Sept. 10, 1755.

12. IV. "JOSEPH², the son of John Stader and of Elizabeth his wife was borne Nouember 24, 1680, and died Jan.ry 16: 1678." So it is plainly written in the town record of Wethersfield; possibly the dates of birth of Joseph and Elizabeth are transposed. The name of Joseph does not appear in his father's will, while that of Elizabeth does.

13. V. MARY², b. W., April 6, 1682; was named in her father's will, Nov. 30, 1703; m. Jacob Warner, and was living with him in Hadley, Mass., June 28, 1726. Perhaps he was the same whose nine children are recorded in Boltwood's *Hadley Genealogies*, pp. 588-9; who was b. Sept. 29, 1691, son of Andrew and Deliverance (Rockwell) Warner; had wife Mary, who d. March 20, 1756; and d. Oct. 3, 1747.

14. VI. JONATHAN², (32) b. W., not recorded; mentioned in his father's will, Nov. 30, 1703, as not yet of lawful age; he m. ———, 1717, Abigail Wickham, b. ———, dau. of Col. Joseph and Sarah (Satterly) Wickham, of Killingworth, Conn., and Southold, Long Island. See Moore's *Indexes of Southold*, No. 813, pp. 144-5. The date of her death has not been found. He m. (2d), about 1737, Esther Buck, or Griswold, who had borne both names, yet her descendant, who gave the information, could only say that she was a widow, without telling which was her maiden name. "The wife of Jonathan Stoddard" was a member of the church at Newington, Nov. 11, 1747, when Rev. Joshua Belden was ordained. He made his will July 30,

1757, "being old, weak and infirm." He d. Newington, Aug. 31, 1757. "Ye aged wid^w. Stoddard" d. N., Sept. 22, 1771, aged "above 72."

15. VII. DAVID³, (40) was named in his father's will, Nov. 30, 1703, as yet under age; he m. Dec. 3, 1719, Keziah Rennalls [? Reynolds], b. W., Dec. 27, 1700, dau. of Jonathan and Elizabeth (Coleman) Rennalls. He d. W., May 14, 1736.

16. VIII. SAMUEL³, was the last in order of the sons named in his father's will, Nov. 30, 1703; no record of his birth or marriage has appeared; and the account book of his brother, John, shows that he died before April 12, 1725; his estate was divided among his brothers and sisters, May 16, 1725.

17. I. NATHANIEL³, (46) b. Wethersfield, Jan. 17, 1692-3; m. W., Sept. 26, 1728, Sarah Buck, b. W., March 25, 1701, dau. of Samuel and Sarah (Butler) Buck.* They lived in Newington society; he d. Aug. 15, 1756; she made her will Oct. 3, 1757, and d. Nov. 4, 1757.

Children of NATHANIEL² [8] and EUNICE (Standish) STODDARD.

18. II. ABIGAIL³, b. W., Nov. 11, 1697; m. W., Feb. 12, 1719 John Francis, b. W., Oct. 12, 1684, son of John and Mercy (——) Francis (*N. E. H. & G. Register*, xvii., 262). No record of children appears. He d. May 15, 1738.

19. III. THOMAS³, (48) b. W., July 29, 1699; bap. W., Aug. 20, 1699; m. W., Dec. 18, 1735, Mary Camp, b. W., Oct. 25, 1713, dau. of John and Rebecca (——) Camp. They were members of the Newington church, at the ordination of Rev. Joshua Belden, Nov. 11, 1747. He d. Aug. (var. July) 26, 1772, aged 73 years; she d. Aug. 26, 1775, according to the gravestone, while the family record says Aug. 5, 1775, aged 61 years.

20. IV. JOSHUA³, b. W., March 4, 1703-4; m. W., March 13, 1757, Martha Deming. He d. W., May 7, 1770, in 66th year.

Children of JOHN³ [9] and SARAH (Camp) STODDARD.

21. I. JOSEPH⁴, b. Wethersfield, Jan. 28, 1697-8; bap. W., Jan. 30, 1697-8; d. W., Feb. 17, 1697-8, "not three weeks old."

22. II. LYDIA⁴, b. W., March 20, 1698-9; bap. W., March 26, 1699; m. Newington, March 25, 1724, **Peletiah Buck**, b. W., Sept. 2, 1698, son of Samuel and Sarah (Butler) Buck. She d. N.,

* At the time of this marriage of his daughter, Samuel Buck was mentioned as deceased. His wife was dau. of Dea. Samuel Butler.

July 29, 1726. He m. (2d) W., Jan. 18, 1744-5, Jemima Andrus, who d. N., May 9, 1777, of small-pox, in 73d year. He d. N., April 19, 1777, in 79th year. Children:

1. LYDIA⁵, b. W., town record says April 22, family record says April 16, 1725.

2. PELETIAH⁵, b. W., July 25, 1726; m. W., Nov. 9, 1754, Hannah Hills; they joined church in N. Aug. 3, 1755; he d. N., Aug. 24, 1757. Children:

1. Lydia⁶, b. W., Sept. 15, 1755; bap. N., Sept. 21, 1755.

2. Chloe⁶, b. W., Aug. 7, 1757. d. N., Sept. 10, 1759.

23. III. MOSES⁴, (56) b. W., March 20, 1700-1701; bap. W., March —, 1700-1701; m. Hartford, May 18, 1732, Ruth Goodwin; the marriage was recorded in Litchfield, where he was Deacon and Captain. She d. L., Aug. 19 (gravestone says 20), 1777, in 70th year. He d. L., Sept. 2, 1777.

24. IV. SARAH⁴, b. W., Sept. 18, 1703; m. April 2, 1735, **Jabez Whittlesey**, b. Dec. 12, 1705, son of Jabez and Lydia (Way) Whittlesey. They lived in Newington, Conn., and Stockbridge, Mass. (*Whittlesey Memorial*). He d. (date not known), and she m. (2d) N., April 28, 1748, Josiah Jones, b. Weston, Mass., Oct. 24, 1701, son of Capt. Josiah and Abigail (Barnes) Jones. (See Bond's *Hist. of Watertown, Mass.*, p. 315). He d. March 22, 1769, aged 68 years; she died in consequence of a fall, Dec. 30, 1799, in her 97th year. Children:

1. SARAH⁵, b. W., Aug. 12, 1736; m. Jan. 7, 1762, Capt. Elijah Brown. b. Aug. 4, 1730, son of Dea. Samuel and Mercy (Patterson) Brown. She d. soon after the birth of her only child, which also died. He m. (2d) June 27, 1764, Phebe Nash, b. Westfield, Mass., July 13, 1735, dau. of Stephen and Elizabeth (Smith) Nash. He d. Stockbridge, Dec. 18, 1819, in 90th year. Mrs. Phebe (Nash) Brown d. St., April 5, or 12, 1834, aged 98½ years. See Bond's *Hist. of Watertown*, p. 129, and *Nash Genealogy*, p. 81).

2. EZRA⁴, b. W., Feb. 11, 1738; m. — — —, Ann Pixley; they settled in Stockbridge, Mass., and, about 1794, removed to Union, now Lisle, Broome Co., N. Y., where they died. They had eight children. (See *Whittlesey Memorial*, p. 74).

3. LYDIA⁵, b. W., Sept. 10, 1739.

4. LOIS⁵, b. W., May 2, 1741; m. Stockbridge, Dec. 8, 1763, **David Pixley, Jr.**, son of Lieut. David and Abigail (—) Pixley. She d. and he m. (2d) Lydia Patterson, b. Watertown, Mass., Dec. 16, 1745, dau. of Joseph and Lydia (Mareau) Patterson, by whom he had two children, Amos and Mary. Col. David Pixley was one of the earliest settlers on the site of the village of Owego, N. Y., where he d. Aug. 25, 1807, in 67th year. Children:

1. David⁶, m. Drusilla Bond.

2. A Daughter, accidentally shot and killed by her brother, when she was about eight years old.

25. V. JERUSAHA⁴, b. W., family record says Jan. 6, 1705, town record says Jan. 7, 1705-6; d. Litchfield, July 26, 1728.

26. VI. MARY⁴, b. W., April 17, 1708; bap. W., April 18, 1708; m. Litchfield, Jan. 25, 1732-3, **Stephen Smith**. Children:

1. OLIVE⁵, b. Litchfield, Oct. 20, 1733.

2. CHLOE⁵, b. L., March 23, 1735.

3. SUPREAM⁵, b. L., Aug. 16, 1737; m. Nov. 25, 1764, Jerusha Kilbourn, dau. of Elisha; he had five children: *Elias*⁶, *Joseph*⁶, *Mary*⁶, *Deidamia*⁶, and *Olive*⁶.

4. ELIAS⁵, b. L., May 20, 1739.

5. STEPHEN⁵, b. L., March 2, 1741.

27. VII. JOHN⁴, b. W., May 12, 1710; bap. W., May 14, 1710; d. Litchfield, Dec. 5 (others say 26), 1735, in 26th year.

28. VIII. ABIGAIL⁴, b. W., May 28, 1712; bap. W., June 1, 1712.

29. IX. JAMES⁴, (62) b. W., June 20, 1714; m. June 22, 1738; Abigail Peck, dau. of William and Lois (Webster) Peck, and cousin of the celebrated Litchfield hunter, Paul Peck. He d. Litchfield, March 28, 1749, being accidentally killed at the raising of a house, and was the first one buried in the east burial ground at Litchfield South Farms, now Morris, Conn. She m. (2d) Jan. 19, 1752, Abel Barnes, and died Oct. 3, 1757.*

* ABEL BARNES was b. New Haven, Jan. 1, 1723, and after the death of his wife Abigail, he m. (2d) Aug. 9, 1758, (Rev. Mr. Joseph Bellamy officiating) Mrs. Gift Gay, b. "in Potuxit, in Rode island," Oct. 9, 1732, widow of John Gay. He d. Aug. 20, 1787, in 65th year. Children by wife Abigail:

I. LUCRETIA, b. Litchfield, South Farms, Nov. 23, 1752; m. L., July 10, 1771, **Elijah Higbe**, b. Middletown, Conn., Feb. 23, 1750, son of Daniel. They settled in Stockbridge, Mass., thence moved to Union, Broome Co., N. Y., in Oct., 1795, and from there, in Feb., 1816, to Berkshire, now Newark Valley, N. Y., where he d. Sept. 13, 1820, and she, March 18, 1838. Children:

1. WHEELER, b. Stockbridge, Mass., Aug. 20, 1772; d. S., April 26, 1779.

4. ELIJAH, b. S., May 26, 1778; m. Esther Howard, who d. Oct. 15, 1839; he m. (2d) Rachel Howard, cousin of his first wife; she d. Jan. 21, 1866, aged 71 years. He d. Union, N. Y., March 29, 1854.

5. ANSON, b. S., April 10, 1780; m. May 7, 1811, Anne Patterson, b. Richmond, Mass., Oct. 19, 1787, dau. of Amos and Anne (Williams) Patterson. He d. Newark Valley, N. Y., Aug. 27, 1854; she d. Newark Valley, Nov. 8, 1862. Children:

30. X. JOSIAH⁴, (68) b. W., Dec. 21, 1716; settled in Litchfield; moved thence, in 1743, to Salisbury, Conn., and settled on the south side of the Furnace Pond, where Harvey D. Warner lived one hundred years later. He was the second town clerk of Salisbury, and represented the town in the General Assembly at six sessions between Oct., 1757, and May, 1762. He was one of the proprietors of the first iron works erected on the outlet of Furnace Pond, about 1748. (See Judge Church's *Centennial Address at Salisbury*, 1841, pp. 52, 65 and 77). He bore the military title of Ensign. His wife's name was Sarah. He d. Salisbury, July 29, 1764.

1. *Lucy Ann*, b. Newark Valley, N. Y., May 18, 1814; m. Aug. 31, 1832, William Annan Sutton, M. D., b. Feb. 10, 1803, son of John and Sarah (Schuyler) Sutton. He d. Feb. 12, 1837. Children: 1. George Byron, b. Oct. 12, 1833, at Newark Valley, N. Y., where he resides, unmarried, a landscape painter and taxidermist. 2. William Annan, b. Newark Valley, July 8, 1837; a young man of great promise, and a fine musician; died of consumption, at Newark Valley, Feb. 16, 1856.

2. *Syphia*, b. Newark Valley, Dec. 4, 1815; m. Feb. 8, 1844, Alvah Fuller, b. ———, 1806, son of Noah and Lois (Spooner) Fuller; resides in Aurora, Ill. Children: 1. Ann Aurelia, b. Ontario, N. Y., Aug. 25, 1845; 2. Alice Caroline, b. Ontario, July 22, 1847; 3. Noah Higbe, b. April 3, 1850; d. Aurora, Ill., Aug. 8, 1851; 4. Henry Clay, b. Aurora, Sept. 9, 1852; 5. William Alvah, b. Aurora, Nov. 13, 1854.

3. *Charles*, b. Newark Valley, Aug. 7, 1817; m. Aug. 22, 1837, Caroline Amanda Lincoln, b. Newark Valley, March 1, 1819, dau. of Otis and Sarah (Slosson) Lincoln; resides in Newark Valley, a farmer, has one son, William Anson, b. Jan. 20, 1854.

In May, 1776, a regiment was ordered to be raised for the defence of the State, "to be subject to join the Continental army, if so ordered by the Governor." He enlisted in this regiment, in the company of Capt. Bezaleel Beebe, of Litchfield, and was one of thirty-six picked men, ordered from that company, under Capt. Beebe, to reinforce the garrison of Fort Washington, about the first of November, 1776. This story is fully told in Kilbourne's *History of Litchfield, Conn.*, pp. 96-101; from which the following is extracted:—

"On the morning of the 16th [November, 1776] the attack was commenced at four different points nearly at the same moment. The assailants were provided with excellent trains of artillery, which were brought to bear with effect. The attack was prosecuted with extraor-

dinary energy and spirit, and the Americans continued to defend themselves until resistance became fruitless. During a recess in the fight the garrison was again summoned to surrender; and, after a brief consultation with the officers, Magraw capitulated. The entire American force, amounting to two thousand six hundred men, surrendered as prisoners of war. During the siege, the enemy lost about twelve hundred, and the Americans about four hundred."

"The terms of the capitulation were regarded as liberal and honorable on the part of the victors, and highly favorable to the vanquished. The manner in which those terms were violated, and every principle of humanity set at naught, by the miscreants into whose hands the unfortunate prisoners were placed, is without a parallel in the history of the Revolutionary struggle. Crowded, with hundreds of others, into the Sugar House and on board the Prison-ships, without air or water, and for the first two days without food; contagion and death were the natural consequences. The dysentery, small-pox, and other terrible diseases, broke out among them, and very few of the whole number survived the terrible ordeal. On the 27th of December, 1776, an exchange of prisoners took place. Only eleven of Captain Beebe's Company were able to sail for Connecticut, viz., Marsh, Woodruff, R. Loomis, B. Beach, N. Beach, Marshall, Brownson, Bissell, Little Benedict and Mason. Six of these died on their way home, viz., Bissell, Brownson, B. Beach, Marsh, Marshall and Loomis. The remainder of those who were living at that date, being too ill to be removed, were left behind—where all, except Sergeant Mather, died within a few days, most of them with the small-pox."

Then follows a list of the thirty-six picked men, with Captain Beebe's notes respecting them; from which we learn that Aaron Stoddard died on the 12th day of January, 1777, "at the Church called the North Church." Our Author continues:—"Probably no similar instance of mortality occurred during the entire war. Only *six* survivors out of a company of thirty-six hale and hearty young men, is a per-centage of loss rarely reached even in the most fatal engagements. But few, if any, of these men were slain in battle. They died miserable deaths, from cold, hunger, thirst, suffocation, disease, and the vilest cruelty from those to whom they had surrendered their arms on a solemn promise of fair and honorable treatment! Well might Ethan Allen, a professed infidel, with clenched teeth exclaim to Captain Beebe, as he did on one occasion—"I confess my faith in my own creed is shaken; there *ought* to be a hell for such infernal scoundrels as that Lowrie!"—referring to the officer in charge of the prisoners."
