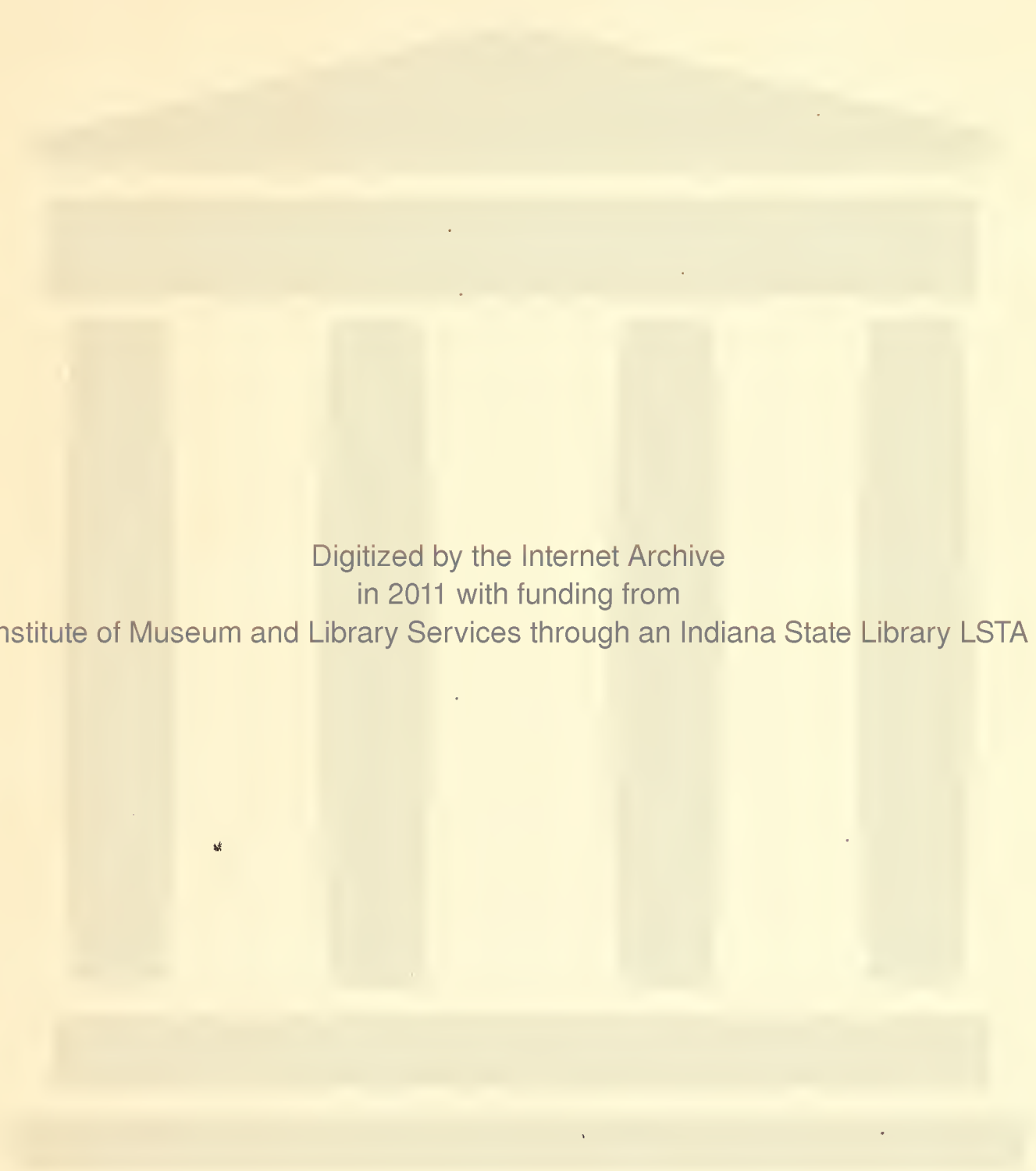
**JOINT RESOLUTION**

Creating a commission to recommend a design and site for a monument or monumental memorial to Abraham Lincoln, and for other purposes.

1        *Resolved by the Senate and House of Representatives*  
2   *of the United States of America in Congress assembled,*  
3   That the chairman of the Committee on the Library of the  
4   Senate, the chairman of the Committee on the Library of the  
5   House of Representatives, the Secretary of War, the Super-  
6   intendent of the United States Capitol Building and Grounds,  
7   Daniel S. Burnham, of Evanston, Illinois, Charles F. McKim  
8   and John M. Carrere, both of New York City, be, and they  
9   hereby are, created a commission to prepare, or approve of,  
10   a general design for a monument or monumental memorial  
11   to be erected to Abraham Lincoln in the city of Washington,  
12   said monument or monumental memorial to cost, exclusive

1 of the site, about, but not exceeding, the sum of one million  
2 two hundred and fifty thousand dollars, and to consider the  
3 selection of a suitable site for said monument or monumental  
4 memorial; and that the said commission report to Congress  
5 on the first Monday in December, nineteen hundred and  
6 nine, concerning the design and the site for such monument  
7 or monumental memorial.

8       SEC. 2. That to enable the commission to carry out the  
9 purposes of this Act, the expenditure of ten thousand dollars,  
10 or so much thereof as may be necessary, is hereby authorized.  
11 The members of the said commission shall serve without com-  
12 pensation, but shall be paid their necessary traveling ex-  
13 penses; and disbursements made under this Act shall be  
14 made by the Secretary of the Interior on vouchers approved  
15 by the Superintendent of the United States Capitol Building  
16 and Grounds as the appropriations for the Capitol building  
17 are approved and disbursed.
