- c) Voted to send Messrs. Man Jai Kim and Joong Hai Choi to guide and help two Ham Nam and Hwang Hae Presbyteries attain the required standard.
- d) Voted to agree in interpreting "Physically Healthy Person" as "the physical condition that is able to carry out the Pastoral responsibility" in the Article 23, 5th Chapter of the Constitution.
- e) Voted to agree in interpreting the item 5, article 25 of Polity in the Constitution, "Pastors engaged in other special Evangelistic Works" as Pastors without Charge if there is no connection with Presbytery or General Assembly but if there is any connection, "Special Pastor Evangelist". In item 6"Connected Institution" means that "An Institution engaged in Literature or Educational Work having an official relationship with Presbytery or General Assembly" and those who are working in Schools Factories or Evangelistic Organizations which are operated by any individual without having an official relationship with Presbytery or General Assembly are called "Pastors without Charge".

- f) Voted to place the slection of a special committee in the Preparatory Committee elected by the C.O.C. and the Executive Committee of the G.A. for the coming Mission Consultation with sister churches in Mission in 1973.
- g) Voted to hold the long range plan(Priority List) of the Mission property use prepared by the C.O.C. and to have a new plan worked out in a consultation between the C.O.C. and the G.A. Executive Committee and have it approved by the Ganeral Assembly.

### 3. Keimyung College Issues

- a) Voted to instruct Mr. Stanton Wilson, Chairman of the Board to call the Board meeting and correct the part of Charter which was illegally amended without having an official approval of the responsible Presbytery and it is noted that Mr. Wilson is responsible regardless of the reasons.

- b) Voted to advise and welcome without discipline the Rev. S.K.Kim and all involved if they return to the original Presbytery after dissolving their illegaly organized presbytery even though it is an error to leave the Presbytery and even illegal to organize a Presbytery.
- c) Voted to appoint a co-ordinating Comm. of three, Polity -Chairman, Education-Chairman and Rev. Joong Hai CHOI, to deliver the advise and opinions of the General Assembly toward a peaceful settlement.
