MINUTES OF THE THIRTY-FIRST ANNUAL MEETING.

THE thirty-first annual meeting of the Southern Presbyterian Mission in Korea met in the Owen Memorial Hall, Kwangju, according to appointment, June 17th, 1922, and was called to order, by Rev. S. D. Winn, at 8:15 P. M.

Rev. S. D. Winn conducted the devotional exercises.

Linton, Miss Mary Pope, Rev. D. A. Swicord, Rev. E. T. Boyer, Rev. and Mrs. Jas. I. Paisley, Miss Margaret Martin. Miss Hattie Knox, Miss Miriam DeHaas, Rev. and Mrs. Thos, D. Murphy, Miss Mary Bain, Miss Florence Hughes, Miss M. V. Davis, Dr. and Mrs. H. L. Timmons.

Communications were read and referred to the proper committees.

The Nominating Committee was named as follows: Messrs Preston, Newland, Winn, Bull, and Hopper.

The minutes of the Ad-Interim Committee were accepted. the reading of them having been dispensed with.

The results of the circular letters were read as information.

The meeting adjourned with prayer.

Sunday June 18th.

9:45. a. m.

Sunday School was held with Rev. E. T. Boyer acting Supt. 11 A. M. Church Worship.

The following children received the ordinace of baptism, Martha Eoline Unger, Sarah Bolton Newland, and William L. Parker; Revs. P. P. Winn, R. Knox, and L. B. Tate officiating.

Rev. S. D. Winn presided and introduced Rev. C. R. Erdman, the distinguished professor of English Bible and Pastoral Theology in Princeton Seminary, who preached a

rich sermon from Ruth 1:15. At 8:15 P. M. Dr. Erdman preached on the subject "Under the Juniper Tree!" After the sermon the sacrament of the Lord's Supper was administered by Revs. J. S. Preston and L. O. McCutcheon.

Monday, June 19th.

9. a. m.

The Mission was called to order by the Chairman, who led in devotional exercise.

The minutes of the previous meeting were read and accepted after some corrections.

The docket was taken up at Unfinished Business and a partial report of the Nominating Committee was read by Mr. Hopper and adopted.

A communication from Rev. J. O. Reavis D. D. regarding a possible visit in 1923 by Rev. W. T. Thomson D. D. for special Sunday work was referred to the Evangelistic Committee.

Reading of the Station reports was begun; the Chunju report was read by Rev. E. T. Boyer, and a part of the Kunsan report was read by Miss Lathrop, the reading being suspended that the Mission might engage in the regular morning worship.

10:30 a.m.

The Mission engaged in worship. Mr. Knox presided, and Dr. C. R. Erdman brought the message of the hour, a masterly and heartening one, on Nehemiah the Hero of the Restoration.

11:33 a. m.

Business was resumed, and the reading of Kunsan's report was concluded.

A partial report by the Evangelistic Committee was considered and was made a special order by vote. It reads: "Moved and carried that for health and other reasons the summer school at Kwangju be considered not advisable." A motion was passed to postpone action on motion to adopt this item until to-morrow morning making it the first order of the day. The report of the Kwangju station was read by Rev. J. K. Unger.

Announcement was made of the receipt of a telegram from Dr. Avison asking for a date to be heard by the Mission. A motion wos passed that he be invited to speak Wednesday night following Dr. Erdman.

The Mission took recess until 2:30 P. M. 2:30 p. m.

The chairman opened the meeting with song and prayer. The report of Mokpo Station was read by Dr. Nisbet.

The report of Soonchun Station was read by Rev. J. C. Crane. The station reports were so full of striking evidences of God's rich blessing upon the work of the Mission for the past year, that the Chairman called the Mission to engage in a prayer of thanksgiving with Rev. W. F. Bull leading.

Mr. W. P. Parker made a soul reviving report of the past year's work at Pyengyang.

A partial report of the Language Committee was adopted.

A partial report of the Evangelistic Committe was read, and adopted.

A partial report of the Apportionment Committee was read and adopted.

The following resolution was adopted: "Resolved that the Mission request its Educational Committee to draw up and present to the Mission for its approval during this Annual Meeting a graded course of Bible study for use in all our Mission Schools of primary and academy grade."

The meeting adjourned with prayer. 8:15 p. m.

The Mission met for worship, with Rev. Jas. I. Paisley presiding. Dr. C. R. Erdman brought the message of the evening from Matt. 15:21-28, on Prayer. No business was transacted at the night session.

Tuesday, June 20.

9:00 a.m.

The meeting was opened by the Chairman with brief devotional exercises.

The minutes of yesterday's proceedings were read, corrected and adopted.

A motion was passed to hear Dr. Gale to-morrow (Wednesday) morning immediately after the devotional hour.

The first order of the day, a partial report of the Evangelistic Committee upon which motion to adopt was pending, was taken up and after free discussion, was adopted.

Final report of the Nominating Committee was read and the report as a whole was adopted.

Communication from the North Chulla Presbytery was referred by motion to the Apportionment Committee.

The Finance Committee made partial report of the budget for the year ending March 31, 1922.

Motion was passed to table the item of Girls' Schools until report of the Educational Committee should be brought in.

A motion was passed to instruct the Educational committee to bring recommendation in their report, regarding the budgets for the girls' schools.

Business was laid aside to engage in worship. Rev. L. T. Newland presided. Dr. C. R. Erdman delivered a telling message on Faith as exemplified in Abraham's obedience. 11:30 a. m.

Business was resumed.

A motion prevailed to refer back to the Finance committee the item of Yen 2,400 in Kwangju's budget for" Country Schools."

A motion was duly passed adopting the partial report of the Finance committee.

Report of the Leper Hospital Committee was read and adopted.

The annual report of the Secretary—Treasurer was read by Mr. Swinehart, the report received and the recommendations referred to proper committees.

Motion was made and carried to adjourn until to-morrow morning, and the meeting adjourned with prayer.

Wednesday, June 21st.

9,00 a.m.

The meeting was called to order by the chairman who led the devotional exercise.

The minutes of Tuesday's session were read, corrected and approved.

A motion was passed that Misses Colton, Kestler, and Tate and Rev. F. M. Eversole and Dr. J. B. Patterson be reported present.

A motion was made to extend a hearty welcome to Dr. J. S. Gale giving him the privilege of the floor, and this was passed by a rising vote.

A communication from the Board of Trustees of the Pierson Memorial Bible School was read and referred by motion to the Evangelistic Committee.

A telegram of greeting from North Chulla Presbytery was read and a motion passed that the Mission Secretary cause reply to be sent.

A partial report of the Evangelistic Committee was read.

A motion carried to lay on the table for twenty-four hours the recommendation to approve the proposed constitution of the Sunday School Association of Korea. The partial report was adopted.

The Apportionment Committee read a partial report, the reading being interrupted to hold the service of the devotional hour.

10:30 a.m.

The Mission engaged in worship, and heard with great pleasure D. C. R. Erdman on the theme, "How God Guides His People," from Ex. 13:17-19. 11:30 a. m.

Business was resumed and a motion passed to extend the privileges of the floor to Rev. W. C. Erdman, and the Misses Covington and Boyer.

Dr. Gale delivered a most interesting and impressive address on the necessity of providing a Christian literature for Korea. The Chairman thanked Dr. Gale for the address, and a motion was duly passed referring the subject matter of the address to proper committees for consideration and report.

The reading of the report of Appointionment Committee was continued.

It was moved and carried that the Medical Committee meet in joint session with the Apportionment Committee at 2:30 o'clock to-day.

The Educational Committee presented a partial report, the reading of which was arrested by the hour for closing, so upon motion after a closing prayer, recess was taken until after Dr. Erdman's address to-night at which time Dr. Avison will address the Mission.

8:15 a. m.

At the night service the Mission heard a splendid address by Dr. C. R. Erdman on the theme, "Luke the Beloved Physician."

Dr. Avison addressed the Mission on the work at Severance College and Union Medical Hospital. The address was accepted with thanks, and a motion carried to refer it to the Medical Committee.

The meeting was adjourned with prayer until to-morrow morning.

Thursday, June 22nd.

9:00 a.m.

The Chairman led the meeting in devotional service.

On account of no quorum being present business was delayed until a quorum had arrived, it then being 9:25 o'clock.

A motion was passed to make consideration of the time for opening the day's work the first order after the devotional hour.

Moved and carried that overtures or station requests be referred to the various committees having jurisdiction prior to the convening of Annual Meeting.

Consideration of the proposed constitution of the Sunday School Association of Korea was called up by the Chairman, and the recommendation as submitted by the Evangelistic Committee was adopted.

Second reading of the Educational Committee's partial report was concluded and the report adopted.

The Evangelistic Committee made a partial report which upon second reading was adopted.

A communication of greeting from a teacher in the girls' school at Soonchun was read.

The Apportionment Committee read a partial report.

10:30 a.m.

The Mission discontinued business and engaged in worship, during which time Dr. C. R. Erdman spoke on "The Lord's Return,' much to the interest and edification of all present.

11:30 a.m.

Returned to business.

A motion was passed that no committee should so work as to conflict with the Mission's hours for business, and that all be urged to be present at nine o'clock each day.

Motions were passed to table items 2 and 6 of the Apportionment Committee's report, which are as follows:

"We recommend that Dr. and Mrs. Rogers be located at Soonchun with the request that he devote his entire time until next annual meeting to special research work in all the stations, to sprue, its cause, prevention and cure.

"We recommend that Messrs Newland, Dodson, and Nisbet be assigned to one month's work each in Chunju Eastern Circuit, the two former in the fall, the latter in the spring.

It was moved and carried by rising vote to elect Rev. P. P. Winn associate member of the Mission. The Chairman welcomed Mr. Winn to which the latter spoke appropriate words out of his fifty years of experience as a minister.

The Finance Committee made a partial report which upon second reading was adopted.

Item five, however, relating to the increase of Mrs. Choi's salary was tabled.

The Language Committee read a partial report. As the

time for business had expired motion was passed to extend five minutes.

The meeting was adjourned until to-morrow morning, and closed with prayer.

Friday, June 23rd.

9:00 a. m.

The Mission met and engaged in a brief season of worship with Mr. Murphy leading. After devotions, the Chairman opened the business meeting.

The minutes of Thursday's session were read and approved.

Discussion was resumed on an incomplete report of the Language Committee, the report adopted and the report of the committee as a whole was adopted.

The report of the Committee on Property at the Seminary was made, passed the second reading and adopted without discussion.

The Property Committee read a report which was discussed and referred back to the committee.

The Evangelistic Committee made a partial report. The item on Chunju's request to employ an ordained helper was tabled. The other part of the report was approved on second reading.

The Educational Committee made report which was under discussion when the time came for recess just a few moments before the devotional hour. 10:30 a. m.

The Mission worshipped God. Dr. C. R. Erdman delivered perhaps the richest sermon of the entire number on the theme, "The Holy Spirit and the Life of the Believer." 11:30 a. m.

The Mission posed for a photograph just outside the Memorial Hall.

Business was resumed.

Item six of the report of the Educational Committee under discussion was referred back to the Committee.

Item eight was amended as follows: "that the unbelieving

children of Christian parents be given preference, and that the rule be not retroactive."

Report of the Statistician was called for, and the motion passed that he prepare a tabulated statement of the statistics as far as possible from the statistics already in his hands to be posted for information.

Motion was passed by rising vote to enroll Mrs. Charlotte Bell Linton as a member of the Mission.

The Apportionment Committee read a partial report, but the time for noon closing having arrived, the meeting took recess until 8:15 P. M. The meeting was closed with praper. 8:15 p. m.

The Mission met and heard the final message of Dr. C. D. Erdman on Jacob.

At nine o'clock the chairman opened the meeting for busines, at which time report of the Apportionment Committee was continued, and the partial report adpoted.

Motion was made and carried that the Mission by rising vote express its great gratitude to Rev. C. R. Erdman, D. D., Professor of English Bible and Pastoral Theology in Princeton Seminary, for the masterly sermons so full of rich spiritual food which he brought to us.

The meeting adjourned with prayer until to-morrow morning.

Saturday, June 24th.

9:00 a.m.

The meeting was opened with devotional service led by the Chairman. The minutes were read, corrected and approved.

Communications were read and referred to proper committee.

The Bible Committee reported and the report was adopted.

The Cheedisan Committee made report which was adopted. Informal but enthusiastic and eloquent verbal reports were made of visits to Cheedisan by the Mission Committee and by others, all of whom favor having a summer resort in that locality.

Partial report of the Apportionment Committee was read, after which the Mission took a short recess just before the hour for worship.

10:30 a.m.

Rev. S. D. Winn presided and his father Rev. P. P. Winn delivered a fine sermon on the Sabbath. 11:45 a. m.

Business was resumed, and the report of the Apportionment Committee was continued.

A motion carried to leave the matter of Miss Mathews assignment in the Committee's hands for further consideration.

The matter of Miss Shepping's assignment to translation work for part time was referred back to the committee.

The item embracing the call for two additional lady workers, to supply vacancies one for Kunsan and one for Chunju was voted to be embodied in the Evangelistic Committee's report.

Partial reports of Chunju's and Mokpo's assignment of work were read and approved.

A motion passed to adjourn until Monday morning at nine o'clock, and the meeting closed with prayer.

Sunday, June 25th.

Sunday School was held at 9:45 A. M. with Rev. D. A. Swicord superintendent. Special Children's service was held at eleven o'clock when Rev. Thos. D. Murphy preached on the theme "What Can God Do With my Life?," from the Text John 6:9.

Christian Endeavor Service was held at 4:30 P. M. with Miss Bettie Virginia Knox in charge, and worship was held at night and Rev. W. F. Bull preached a ringing message on the "Need of a Revival."

Monday, June 26th.

9:00 a.m.

The Mission opened for business with the Chairman in charge of the devotional service.

The minutes of Saturday's proceedings were read, corrected and approved.

Telegram of greeting from the Clark family en voyage to America was read.

A motion was passed to instruct the Mission Secretary to send a telegram of greeting to the Northern Presbyterian Mission in session in Seoul.

The Evangelistic Committee read a partial report.

A motion was carried to table the item on Industrial Educational Men until the Educational Committee should bring in recommendation on this point. The items on the assignment of doctors and nurses were laid on the table. What remained of the report was then adopted.

The Educational Committee read a partial report. The item including the course of Bible study for station and country schools was adopted for use one year. The body took recess.

10:30 a. m,

The meeting engaged in worship, during which Rev. P. P. Winn gave a very helpful sermon on the Lord's Prayer. 11:30 a. m.

The Educational Committee continued its report. A telegram bearing on the establishment of a Woman's College in Korea was read. The partial report was adopted.

The Finance Committee read a partial report.

It was moved and carried that the matter of subscriptions to the Christion Messenger be made the order of the day. A motion was then passed which directed Rev. J. C. Crane to proceed at once quietly to enlist pledges for new subscriptions without halting the business in hand. The report was adopted.

A partial report by the Rules and By-Laws Committee was read. On second reading the Secretary of this Committee having volunteered his services, was directed to prepare the matter for printing a revised copy of the Rules and By-Laws for the printer so as to relieve the Mission Secretary of this labor. The item to elect Chairman in advance was stricken out of the report.

The time for recess having come, a motion was passed to extend five minutes to hear Dr. Patterson.

A motion was passed that the building order in each station be sent in to the Ad Interim Committee for consideration at its next meeting.

D. Nisbet having requested permission to leave the meeting this evening, the leave was granted.

Motion was passed to take recess until eight o'clock tonight. 8:00 a.m.

The Mission assembled and was opened by short devotional service, Rev. Jas. I. Paisley leading.

A motion was duly passed accepting the report of the Statistician.

A telegram from Severance to Miss Shepping bearing on Miss Matthews' assignment was read.

The Apportionment Committee read a partial report.

The recommendation concerning Miss Matthews was taken from the table and adopted. A motion passed to take from the table the assignment of the month each to Messrs Newland and Dodson in Chun-ju E. Circuit. It was changed to read, "Three weeks, sessional work." Motion passed to assign Rev. P. P. Winn, "Associate member of the Mission, station pastor, Chun-ju and to assist in classes." Motion passed to take Miss Shepping's assignment from the table. The assignment was adopted as read. Motion was passed to take Dr. and Mr. Roger's assignment from the table; the assignment was adopted. Motion passed that Rev. J. F. Preston also be given assignment of representative of S. Chulla Bible Institute. Motion passed that the recommendation giving permission to Chun-ju to secure teacher for missionaries' children be added to the Evangelistic Committee's report. The report of the apportionment Committee was adopted as a whole.

It was moved and carried that Mr. W. P. Parker be assigned as professor in the Union Christian College in Pyengyang, and Mrs. Parker to local evangelistic work.

It was moved and carried to consider place for holding next Annual Meeting. Kunsan and Soonchun extended invitations, and the mission voted to accept Kunsan's invitation.

Motion passed to adjourn until to-morrow and the meeting closed with prayer.

Tuesday, June 27th.

9:00 a.m.

The meeting opened with Rev. Joseph Hopper in charge of the devotional service.

The minutes were read, corrected and approved.

The Educational Committee read report.

A motion was passed that the call for Industrial Educational Men be changed to read "Kwang-ju first, mechanic or other industrial man, Chun-ju Second, industrial man."

The report as a whole was adopted.

The Nominating Committee brought in a partial report which was adopted. The report of this committee was then adopted as a whole

A motion was passed that the Executive Committee be requested to send out Dr. Gilmer or another doctor as soon as possible to Mokpo.

A motion was passed directing the Sec'y-Treasurer to put in a call for a secretary to fill Miss DeHaas' place. A motion was passed to add call for evangelistic worker among the Japanese to the Evangelistic Committee's report. A motion was then passed to adopt the complete report of the Evangelistic Committee without further reading.

The Medical Committee made a partial report which was duly adopted, after which the report of the Committee as a whole was adopted.

The Property Committee presented a partial report which was adopted, and a motion also passed to adopt the report of this committee as a whole.

The Finance Committee read a partial report.

A motion passed that item No. 15 be changed so as allow Kunsan to transfer funds over and above the five percent limit. A motion to take the Finance Committee's recommendation regarding Mrs. Choi from the table was passed and the recommendation adopted.

Time for recess having come, recess was taken until 10:30. A. M.

The Mission engaged in worship and Rev. P. P. Winn gave another most helpful sermon on "Importunity in Prayer." 11:30 a. m.

Business was resumed.

Finance Committee's report was continued.

The following motion passed: "That while determining the order of building in the mission, the Ad-Interim Committee be ordered to re-adjust the Permanet Eqipment Budget, including objects omited from the same."

By motion Dr. H. L. Timmons was excused from further attendance upon this meeting.

A motion to include five hundred yen in the budget for Pyeng Yang School for Missionaries' Children was passed.

The report of the Finance Committee as a whole was adopted.

The Report of the Committee on Education of Missionaries' Children was read and adopted after second reading.

It was moved and carried to extend time until one o'clock if necessary to finish the business. The report of the Severance Medical College Board was accepted.

Rules and By-Laws Committee made report which was adopted, and the report of this committee was adopted as a whole.

Rev. L. T. Newland was elected to prepare the annual report of the Mission to the Executive Committee.

It was moved and carried to have Dr. Reynold's Notes on Euphonic Changes printed in a separate volume.

A motion passed to have the Mission's course of Language Study printed in the minutes.

A motion passed directing the Language Committee to edit Dr. Reynold's Notes and prepare them for the printer.

The Mission voted for the next Annual meeting to be about June 20th, 1923, the exact date being left to Kunsan Station.

A motion empowering the Mission Secretary to appoint two from each station to prepare copy for the October number of the Missionary Survey was passed.

Mr. Paisley was selected to send one copy of the Mission photograph to each station and to order as many as each • station should call for.

A motion to request the Ad-interim Committee to fix the limit of the number of words in station reports and to advise the stations not to exceed this limit, was passed.

After reading and adopting the minutes, the Mission sang "God be With you," was led in a closing prayer by Rev. P. P. Winn, and adjourned.

ANNUAL REPORT OF SECY-TREAS 1921-22.

Returning from America in June 1922, I at once took over the work of Mission Secretary-Treasurer. Owing to there having been no Balance attempted at the close of the Fiscal Year, March 31st, 1921, the work ran over into the current year, making it quite difficult to tell what should be counted in the business of this fiscal year.

One of the interesting facts brought out in the following financial report, is that \$4,577.24 was returned to Mr. Willis,

Treas., as unexpended balance for the year 1921-22. For a like period there was \$5,854.95 credited to him for the premiums received on Drafts which he had sent.

This is especially gratifying since the Executive Committee had maintained the rate of exchange at two for one during the previous ten years, at a loss to themselves for the entire period.

On the occassion of my recent visit to America the plan of reporting to the Nashville Office was changed and simplified, thus eliminating some of the work which had been previously required.

While the system of handling the finances and reports within the Mission shows a steady improvement, there are several recommendations I would present to the Mission at this time;

(1) Lack of uniformity in handling Circular Letters causes me to suggest that a resolution be brought in, definitely regulating this feature, and fixing a route for the letters to travel.

(2) In the matter of securing S. S. Bookings for our Members going to America, there is often a duplicating of effort and misunderstandings arise. The Executive Committee highly recommends the plan of all bookings being made through the Treasurer. If the Mission decides to adopt this plan, then there should be very definite rules settled upon, and a fixed plan of procedure adopted.

(3) That the Mission take some definite action in the matter of making charges to Missionaries' accounts, of the amounts paid by Mr. Willis for them in America, and stating whether in such cases the credit of three months is to be allowed

(4) Different Stations interpret differently the request of the Executive Committee to turn over to the Mission Treasurer, the balances in individual's hands at the end of the fiscal year. Uniformity in this matter is very desirble and it is suggested that the Mission determine upon the general practice to be followed in such cases.

(5) Repeated attention has been called to Paragraph 59, sub-paragraph 2, Page 32 of the Executive Committees Manual, which reads as follows;

"No equipment work shall be begun or debts therefore contracted by the Mission until specific appropriation therefore has been made by the Committee, and until plans, specifications and estimates therefore have been approved by the Mission."

In addition to this being only an ordinary business requirement on the part of the Executive Committee, they point out cases where the Mission and individuals might have been spared embarassment if this rule had been adherred to. Respectfully Submitted,

4. We should like to emphasize the vital importance of constant personal association with the Koreans, visiting in their homes, itinerating with and without other missionaries, and in regular Sunday School work.

5. That after consultation with Dr. Reynolds, his notes on euphonic changes, verb forms, etc. be printed.

LEPER HOSPITAL COMMITTEE REPORT FOR ANNUAL MEETING. 1921-22

The past year at the Leper Home has been one of joy and satisfaction for what has been done for these unfortunate people of earth. Those who call themselves "dead dogs" have by care and christian influence been made men and women of higher appirations and a hope for the future has been instilled into their hopeless lives. We are confident of the value of the work to the lepers themselves and as evidence to the other Koreans that Christianity knows no bounds in its sympathy for those who are in need. The type of leper work done in our colony is evidence of the fact that christianity meets every need of body, mind, and soul. At the end of the first quarter there were 446 inmates in the home, and 68 in the huts, making a total of 517 being cared for. Those in the huts have been largely supported by gifts from missionary friends in Korea. They were cared for during the winter at a very low cost and saved from intense suffering.

Treatment. The use of the new treatment, "esther," has been used for about 6 months and though there have been some good results from it we are not yet able to give any definite data on its effect. Ten cases were discharged in April as probable cures but only time will tell whether they will be permanent. These were cases who had been with us for some years.

Industrial. We have proven in this home that out of leeches or non-producers we can produce hardworking substantial citizens. Our homemade carpenters are now able to erect good substantial two story brick buildings, even the brick and tile being made by the lepers. The tinshop turns out all buckets, lamps, basins etc. A class has been taught cloth making and we are now making some of the cloth used in the home with the prospect of making all we use. Added to this list are mat-makers, blacksmiths. farmers, shoe makers, and purse-cord makers. All rakes, baskets, giggies, brooms, and such articles are homemade products. A number of nurses and medical attendants have been trained so that now all the minor medical work is done by the lepers. Two men are quite efficient with the microscope, being able to diagnose intestinal parasites, bacillus etc.

Church. There is a flourishing church with three elders and three deacons which has been under Mr. Talmage's care. Not until a leper learns to read and write is he given a Bible and a hymn book. The spirit of the colony is to be credited largely to the Christian influence there. An active C. E. has been organized with a membership of about 117 regular members.

We hope every missionary will feel it a part of his privilege to press on the Koreans the fact that it is part of Korean Christians duty to support their own lepers. We ought to help in the fight against leprosy by teaching the necessity of cleanliness.

The leper work never had a better outlook for there may now be a possibility of a cure. It can be wiped out of Korean if the proper methods are taken. Let us all feel an interest in this work as missionaries who desire to be a blessing to the people among whom we work, for the cleaner we made the living conditions, the more respectable we make them look, and the lighter we make their suffering, the better are we preparing the soil for the gospel. Some means should be taken to care for the thousands of lepers in Southern Korea. The method that is best is yet to be decided. Let us make it a part of our prayer that these who wait for help will some day be given a place of refuge where their suffering can be alleviated, the minds enlightened; and their souls saved.

REPORT OF THE COMMITTEE ON OUR PROPERTY AT THE SEMINARY.

Your Committee would respectfully report the Property at the Seminary in good shape and giving very useful service in housing the family of Mr. W. P. Parker and our representatives on the faculty of the seminary during the year, Messrs. Reynolds, Bull and McCutchen.

We repeat our request for \$300 with which to change the form of the dormitory roof and to change the front porch by a suitable porch, and for \$150 with which to provide servants quarters on the above property.

We urge the mission to make provision at the earliest

possible moment for \$3,000 with which to purchase a tract of land suitable for two residences, one for our second resident seminary professor, and one for the family of Mr. Parker.

REPORT OF EDUATIONAL COMMITTEE

We recommend:

1. That we request the Finance Committee to put Yen 6,000.00 in the budget for each of the Girls' Schools.

2. That all five stations be urged to develop their Boys' High Schools and as far as possible turn over their lower grades to the native church.

3. That we request the Finance Committee to prepare a budget of Yen 10,000.00 each for Kwangju and Chunju Boys' Schools, and Yen 8,000.00 for each of the other Boys' Schools, it being understood that this larger amount for Kwangju and Chunju is on account of their industrial work.

4. That the tuition for the Girls' School be Yen 2.00 per term for the Po Tong and Yen 3.00 per term for the Ko Tong.

5. That the tuition for the Boys' Schools be Yen 250 for the first four grades of the Po Tong, Yen 3.00 for the 5th and 6th grades Po Tong, and Yen 4.00 per term for the Ko Tong grades.

6. That the course of Bible study for station and country schools be as follows:

- Po Tong: 1st Year: Lord's Prayer, Ten Commandments, Apostles' Creed, Child's Catechism, Bible Stories.
 - 2nd Year: Matthew and Mark.
 - 3rd Year: Luke and John.
 - 4th Year, Acts and the Life of the Twelve Apostles.
 - 5th Year: Genesis and Exodus.
 - 6th Year: Old Testament History.

Ko Tong: 1st Year: Old Testament Characters.

2nd Year: Life of Christ.

- 3rd Year: 1st Corinthians, Galatians, Ephesians, Philippians.
- 4th Year: Psalms and Daniel.

5th Year: Hebrews and Minor Prophets.

(N. B. This recommendation, No. 6, was adopted for one year).

7. That the country school curriculum for each station for the first four grades be the same as that of the station school as far as possible.

8. That not over 25% of the students admitted to the high school grades be non-Christian. This means that 75% shall have received at least the catechumen examination, and that unbelieving children of Christian parents be given the preference in the 25%. This rule shall not apply to pupils already enrolled.

9. That in reply to the communication from Dr. C. A. Clark we would say: (a). That we are in favor of having a College for Women in Korea, and (b). that it be Presbyterian and we suggest that its location be Taiku.

10. That in reply to the Korean communication from Yi Chai Ik Moksa we instruct Mr. Winn to reply that we are actually teaching more hours throughout the year than the Government public schools, and that as far as possible we are endeavoring to carry out the suggestions made.

11. That Recommendation 2, Report of Educational Committee, Minutes of 1915, be rescinded.

12. That the principals of the Boys' Schools be appointed as a committee of the mission to communicate with the highest authorities of the provinces to request that examinations to Christian teachers be given on other days than the Sabbath, and if no satisfactory answer is obtained, that they take the matter to the authorities at Seoul.

13. That the school principals be allowed to pay such, salaries as the stations approve, provided they are not more than salaries paid by other Presbyterian schools of the same grade outside of Seoul.

14. That we call for an industrial man for Chunju, and a mechanical engineer or other worker for Kwangju.

REPORT OF EVANGELISTIC COMMITTEE.

1. Moved and carried that Kwang-ju be allowed to have a summer school for this current year only and that summer schools be not the policy of the mission.

2. Moved and carried that though Edward Junkin looks forward towards literary work that we advise him to take a regular Seminary course and come out as an ordained man.

3. That no missionary or station send out a questionnaire to the native churches affecting mission policy without approval of the Mission.

4. In view of the emergency prevailing, that the Committee be urged to send out a single lady worker at once to take the place of Mrs. Bell, nee Dysart of Kunsan and if Miss Austins health is so that she cannot return that they also send out a lady worker to take her place.

5. Moved and carried that the proposed constitution of the Sunday School Association be approved.

6. In reply to the question as to the doctrinal soundness of the teaching of our union schools, we reply that a Committee appointed by the Ad-Interim Committee is already doing this work and will report at an early date.

7. In reply to the question of additional aid to Seminary students we reply that the General Assembly has already ordered this done by the Presbyteries.

8. We endorse the action of the Committee of the Sunday School Association to use Dr. W. T. Thompson six months in Korea in 1923. We request that he come to our mission in January and February and also to Annual Meeting the last two weeks in June.

9. We endorse the plan of Furlos as suggested by Mr. Rowland to the Committee as an optional plan at the desire of the missionary and the approval of the Mission.

11. We approve the proposed changes in the curriculum of the Bible school for Women and that the revised schedule be printed in the minutes.

12. That the providing of help for the Chei-ju classes and

the dates for the same be left to the Evangelistic Committee in consultation with the native pastors.

13. Since the difficulty in arranging for the Classes was aggravated by the fact that in three of the stations the classes must be held during school vacations in order to get the use of the school plants we call attention to the urgent need of providing all stations with Bible class buildings as fast as possible.

14. We invite the Presbyteries to appoint one member on each of the Committees in charge of the North and South Chulla Bible Institutes for Men.

15. In reply to a letter from Dr. Deming of the Pierson Memorial School concerning the correlating of courses with our North and South Chulla Bible Institutes, we recommend that the Committees in charge of these Institutes correspond and confer with the faculty of this school regarding this matter and report to next Annual Meeting.

16. We recommend that Chunju Station be given permission to secure a teacher for Missionaries children upon the terms laid down by the Executive Committee.

17. We put in an urgent call for a Secretary for our Mission Secretary-Treasurer, to take the place of Miss de Haas who has been ordered home on sick leave.

18. We repeat our call for an Evangelistic worker among the Japanese.

CHEEDISON COMMITTEE REPORT.

2. We recommend that a special committee of six be appointed to take up with the Imperial University the matter of buying or leasing the necessary land and that Captain Swinehart be chairman of this committee.

REPORT OF BIBLE COMMITTEE.

The Bible Committee held two meetings during the year. Despite the disturbed financial conditions of the world the work of the Bible Society has been maintained with great success.

The main question before both meetings of the Society this year was the Revised translation of the Bible. At the fall meeting the Board of revisers presented Genesis as ready for publication. At the same time one member of the Board resigned stating that he did not agree with the principle of revision in use by the board. After much discussion the Board of Revisers was enlarged and Genesis was referred back to them for further consideration.

At the spring meeting this question was more fully discussed after a full review of the revised Genesis by many members of the Bible Society and others whose criticisms were before us and it was decided not to publish Genesis until it was worked over by the Board and approved by The Bible Society.

A new edition of the Gospel of Luke with translation notes has been gotten out during the year.

We regret to report that Mr. Miller has sprue and we commend him to your sympathy and prayers.

REPORT OF RULES AND BY-LAWS COMMITTEE.

We recommend:

1. That the Rules and By-Laws Committee prepare and print a revised copy of the Rules and By-Laws including all corrections to date.

2. That we annul the change made in the Rules and By-Laws in 1918 concerning Sec. IV, Art. 6, beginning with the words, "That, for the general direction"

3. That we strike out Sec. I, Art. 3, Item 23 (Report of Committee on Federal Council) and Item 26, and part (Educational Senators).

4. That Sec. I, Art. 6 be changed as follows:

(a). Item 1, 2nd sentence beginning, "This letter shall be," to read, "Copies of this letter showing the vote of the station from which it originated shall be forwarded to each station including Pyengyang and Seoul, to receive the signatures of its voting members. No measure shall be adopted in this way except by a two-thirds majority of the mission on the field,"

(b). Item 3 to read, "Each circular letter shall be drawn up on blanks printed by the Misson Secretary in accordance with rules governing same, said rules to be printed on the reverse side of the blanks".

(c). Item 4 to read the same as the present Item 3.

(d). Item 5 to read the same as the present Item 4.

(e). The present Item 5 to be struck out.

(f). Item 6 to read, "Station Secretaries shall receive copies of circular letters and be responsible for obtaining the signatures of the members of the station and forwarding to the Mission Secretary within ten days. The Mission Secretary shall place the copies on file, and inform the Station Secretaries of the result."

5. That Sec. 11, Art. 10, be changed to read as follows: "The Secretary shall attend to the printing of the Minutes of Annual Meeting including all Committee reports and shall forward a copy of the same to the Executive Committee as soon as printed, but any recommendations of special importance shall be sent immediately after Annual Meeting." 6. That Sec. III, Art. 10, be struck out.

7. That the articles of Sec. IV be re-arranged so as to show more orderly the action of the mission.

8. That Sec. IV, Art. 5, beginning with Item 1, be changed to read as follows: "1. Plans for the development of the medical work, including charges, selection of assistants, and permanent equipment needed. 2. The best methods of developing and educating the Medical Assistants. 3. Plans for making the medical work evangelistic in aim and methods. 4. Plans for the furtherance of the general health of the mission body."

9. That a new Article (No. 20) be added to Sec. VI to read as follows: "The Mission at each Annual Meeting shall appoint someone to prepare a report to be forwarded to the Executive Committee after approval by the Chairman and Secretary of the Mission."

REPORT OF THE FINANCE COMMITTEE.

1. We report that the Auditing Committee has made the annual audit of the Mission Treasurer's books and found same carefully and accurately kept.

2. We recommend that we answer the requests from the Union Christian College Pyeng Yang by stating that we have included the yen 4,500 for running expense in our budget; and that there is yen 47,500 in a permanent equipment budget which is now being raised and that on this account now we cannot increase the amount for permanent Equipment.

3. That the Mission Secretary be asked to thank Mrs. Winsborough for the help given by her and other women of the church to get missionaries ready to go home on furlough.

4. That in answer to the letter of the Executive Committee asking on what terms and conditions our Mission would cooperate in another Leper Hospital within the bounds of our Mission, we reply that as in the case of the colony already established, the Mission will assume oversight of the work, but no financial responsibility other than that of administering the funds.

5. That the increase in the salary of Mrs. Choi, should she be employed as the literary assistant for the current year, be provided by Kwangju station out of its budget.

6. That the Mission approve the item "yen 2,400 Additional Country School" in Kwangju Budget with the understanding that the Committee shall be responsible for this item only as it is made up from funds received from other than regular sources.

7. That the use of loose-leaf books for station Minute books be ordered discontinued.

8. That the Mission Secretary be requested to communicate with the treasurer of the Executive Committee asking for a ruling as to whether those going to America on short term vacations at their own expense shall be paid field salary or home salary during this period.

9. The Committee reports that the records of all the stations were found neatly and correctly kept, with exceptions as noted in the minute books.

10. Messrs. Knox and Winn were appointed a committee to audit the Mission Treasurer's books April 1923.

11. That the matter of securing steamer reservations for Missionaries going to America, be in the hands of the Mission Treasurer who shall prepare blanks to be filled out by the Missionary indicating his preference as to sailing date, and steamer.

12. In answer to requests from Severance College we reply, that \$ 7,000 for a professor's residence is in our permanent equipment budget which is now being raised; but that owing to the present conditions of our permanent Equipment plans the amount asked for capital building funds can not now be included in our budget.

13 We recommend that Rev. J. C. Crane be appointed a Committee to secure subscription in the Mission to the Christian Messenger. 14 We recommend that Kwangju Station be given permission to readjust the items for girls' school and residences in its permanent equipment budget to provide for building a new residence for single ladies allowing the present single ladies home to be used for school purposes.

55

15. That Kunsan station be given permission to readjust the items for residences in its permanent equipment budget to provide funds for alterations on the residence formerly occupied by the single ladies.

16. That in no case shall additional appropriation be asked for residences already in the permanent equipment budget.

17 That we advise Kunsan station that the 300 yen requested for repairs on Mr. McEachern's residence should properly come out of station budget for repairs, if not, transfer be allowed over and above the regular 5%.

18. That the Mission Society be requested to communicate with the Treasurer at Nashville asking for a grant of 1,000 yen to be used in investigation of sprue, this fund, if secured, to be under the direction of Dr. Roger, not transferable.

19. That 400 yen collected on fire insurance, be paid to Dr. Patterson for rebuilding.

20. That there be fixed meetings of the Ad Interim Committee on the 2nd Tuesday in October, the last Friday in January and the last Thursday in March.

REPORT OF AD INTERIM COMMITTEE.

Seoul, Korea, September 19, 1921.

Pursuant to the call of M. L. Swinehart, Convener, the Ad Interim Committee met in Mr. Gregg's home at two p. m. with the following members present :

Messrs. Knox, Swinehart, Eversole, McCallie, Harrison, Coit, Winn, Newland, Nisbet, Mr. Linton sitting for Mr. Bull and Mr. Crane for Mr. Preston. The devotional exercises were led by Mr. Swinehart, following which Mr. Nisbet was elected Chairman and Mr. Swinehart served as secretary ex-officio.

Messrs. Owens, Boots and Mansfield were invited to address the committee on the medical and dental situation in Korea, and in our Mission. These gentlemen reported that it might be possible to secure Dr. W. J. Sheiffley for our Mission as he had expressed a willingness and desire to return and as Severance Hospital found it inconvenient to give him a place on its staff at this time. It was moved and carried that we extend an invitation to Dr. Sheiffley to come and serve us as a dentist for our Mission, and that the Executive Committee be asked to open negotiations looking to his appointment.

In view of the evident fitness of Captain M. L. Swinehart to assist in the Five Million Dollar Compaign, and in order to evidence our desire to cooperate with the Executive Committee in the furtherance of this campaign, should they consider his presence desirable, it is moved that we offer his services to the Executive Committee and to the Stewardship Committee, to return home should they so desire.

A communication from Dr. E. W. Smith was read and the following resolution was passed, viz :—"That each station make such division in the permanent equipment items, as requested in Dr. Smith's letter, and that they indicate the onesixth which can be spared with the least loss to our work and report same to our Mission secretary on or before November first, 1921."

Mr. Swinehart was directed to edit the items in the fiveyear equipment needs of our Mission, and to make any alterations or changes that he may deem advisable.

A communication from Rev. James O. Reavis, D. D. was read and the Mission secretary requested to report that while the committee appreciates very much the sympathetic attitude of our Executive Committee in offering to send Dr. W. P. Thompson of Union Seminary, Va, to our mission to assist in the special campaign for Sunday-school work, and to meet one half of his expenses, the other half to be borne by the World's Sunday-School Association, that we approve of the reply made by our secretary, Mr. Swinehart, and state that the Mission is not aware of the request for such a worker being sent to us at this time.

A communication from Dr. S. H. Chester concerning the relation of our members to the native church which was referred to the General Assembly by the Executive Committee and asking if our Mission would suggest any changes in the present rule as layed down in the Manual in Section 3, Paragraph 18, as desirable; we would reply that we see no call for any change in the Executive Committee's Manual.

It was ordered that Mr. McCutcheon be authorized to go to China as directed by the General Assembly, and that the Mission treasurer ask for permission to pay this out of 1920-21 unexpended balances—not exceeding Yen 200. The matter of arranging for a teacher for the fall term in the Theological Seminary to take Mr. McCutcheon's place, should it be found impossible for him to attend, is left to Chunju Station.

It was ordered that in view of the emergency existing at Soonchun Station, we request the Executive Committee to secure and send out a doctor for that station for a five year term of service, and that Dr. J. McL. Rogers be asked to assist in securing such a man.

After full discussion and consideration, the committee voted that if the Executive Committee finds it impossible to secure doctors or dentists for our work under our present rule of service, we request the Committee to send us such workers for a minimum five year term of service.

Replying to Dr. S. H. Chester's letter regarding the question of sound teaching in any of the Mission schools in cooperation with other missions, we would respectfully report that a committee consisting of Messrs. Bull, Reynolds, and Clark is hereby appointed to make this investigation within our bounds, and to report to the next meeting of our Mission.

Replying to Dr. Chester's letter dated August 2, 1921, relative to the Mission's approval of Miss Hattie Knox as a member of our Mission, we desire to state that our Mission felt that its request to the Executive Committee for her appointment as a member of our Mission was equivalent to an endorsement. However, we are happy to add our unqualifield endorsement of Miss Knox's application to become a member of our Mission and trust that nothing may intervene to prevent her speedy appointment:

Ordered that the Eleventh day of October, 1921 be fixed as a time to investigate Chidesan, and that a sub-committee be appointed to investigate Moodunsan as a possible summer resort and report back to the Mission. Messrs. Harrison, Winn and Coit were appointed as such a Committee.

Permission is granted to Kwangju Station to loan temporarily from "Kwangju land" the sum of Yen 1,000 to assist in providing a Bible class dormitory for that station.

Soonchun station was given permission to borrow Yen 300 from Emergency Repairs to be used for "repairs," to be repaid when appropriation is made covering the repair account in that station.

In view of the fact that our secretary-treasurer has never had an office or office furniture provided at the Mission's expense, and since an office building for his use is now under course of construction, and since furniture will be necessary we request the Executive Committee to appropriate \$ 250 for this purpose, the same to be taken from 1920-21 unexpended balances.

Mokpo Station was granted permission to move a Korean residence now in front of Mr. McCallie's home to be used in the Boys' School and paid out of funds on hand until the amount is realized from the permanent equipment fund.

Chunju Station was given permission to transfer as follows :--

From itinerating to country schools, Yen 800, from helpers in new territory to country schools, Yen 400, and it is understood these amounts shall be over and above the five percent limit of transfer within the station. It was moved and carried that Soonchun Station be allowed to arrange with the evangelistic workers in other stations for itinerators to work in the Soonchun territory this fall and winter.

The Mission Secretary was asked to communicate with the Executive Committee and ask a ruling on the matter of child's allowance for missionaries' children while at boarding school in Korea. The Committee is therefore requested to state whether it is the purpose of the Committee to pay the annual amount allowed for children when attending boarding schools in the country in which the parents live, or whether a monthly allowance should be given the children while in school and the regular children's allowance be paid during the months the children are at home with their parents.

It was ordered that the summer vacation allowance of Yen 60 per individual be available for use any time of the year that the station is willing to approve of the vacation being taken.

It was ordered that Messrs. Swinehart, Eversole and Crane be requested to consult with the Seoul Language School Committee and if they are requested to provide aid in teaching force, they are hereby empowered to arrange for same.

The special committee on schools for missionaries' children appointed by the Mission at our last meeting made a partial report and was continued, with instructions to report further at a future meeting.

The amount available for site and residence in Pyeng Yang is authorized fixed at \$7,000 which is to provide for a site in addition to the one for Mr. Parker's residence if possible. That our representative at the Seminary, with Mr. Parker, be a committee on site and be empowered to determine location after a full consultation with Pyeng Yang Station.

The meeting adjourned with prayer by Mr. Harrison.

PIERSON MEMORIAL.

Seoul, Korea, September 21, 1921.

The Ad Interim Committee met at the Pierson Memorial at 8:30 P. M. with the following members present: Messrs. Nisbet, Crane, Linton, Eversole, Knox, McCallie, Coit and Swinehart. Dr. Nisbet led the devotional exercises.

Chunju Station was given permission to alter the west upstairs room of the single ladies' Home, to make it habitable, the funds to be provided within the Station.

The following resolutions were passed :---

1. Whereas: -Because of the alarming increase in the number of cases of sprue among the members of our Mission, more than twenty being now affected and the great loss to the work by reason of so many being incapacitated from work, and the expense to the Executive Committee because of the enforced return to America of many thus affected,

Be It Resolved;

That we request the Executive Committee to secure the Services of a doctor, who shall be especially qualified to engage in research work, looking to the determination of the cause, if possible, and to the proper treatment to effect cures. Such a man could be secured for a short term of service, perhaps one or two years, it being requested that he remain only long enough to make a through study of the health conditions of our Mission and report fully, including recommendations for relief in the matter. This in no way reflects upon the skill and ability of our Mission doctors, who are already too heavily burdened with their regular Mission hospital work to allow for any time to be given to this work, but is in accord with their recommendations.

2. Whereas:-The bounds of our Mission do not extend to nor include any part of the city of Seoul, and,

Whereas :---All Union meetings, language classes, etc., are held in that city requiring frequent and prolonged visits on the part of many of the members of our Mission, and, Whereas:—Our representatives on the Tract Society, the Union Newspaper, the Bible Society, Severance College, and the numerous committees of the Federal Council are required to make several trips to Seoul each year, and,

Whereas:—The rates at hotels in Seoul are too high to allow our representatives on these committees, and in attendance on such meetings, to be entertained in public places, and,

Whereas :—The missionary residents of Seoul are already severely taxed to entertain the members of their own Missions who are called to Seoul on like duties as our members are.

Therefore be It Resolved:—That we appoint a Committee of three, to investigate the possible cost of a plant to be known as a Missionary Home, and the possible expense to our Mission of maintenance, who shall report to the next meeting of the Mission or Ad Interim Committee.

(Swinehart, Linton, Eversole were appointed as such Committee.)

3. Whereas: -- The very life of the Union Newspaper published by the Federal Council is endangered because of lack of funds and editorial staff.—All the Missions are called upon to do their part in keeping this very important work from being lost to our Union effort, and as every safeguard is being thrown about the comity interests of our Missionary activities in Korea.

Be It Resolved;

That we ask our Executive Committee for permission to secure \$600.00 for this purpose, through friends in and out of the church, with the understanding that any amount given to this fund by members of our Church shall be over and above what they now give to Missions.

It was moved and carried that Mrs. Pillay Choi be offered to Seoul Language School for the fall term, 1921, the expense to be borne by our mission and charged to new Missionaries language teachers' account.

Messrs. H. Miller and Koons appeared before the Committee and urged that Mr. W. M. Clark be transferred to Secul at once to take up his work in the Christian Literature Society. No action was taken by the committee, but a promise was made to give the matter full consideration.

The meeting adjourned with prayer.

AD INTERIM COMMITTEE MINUTES

Kwangju, January 26th, 1922

Pursuant to the call of M. L. Swinehart, Convener, Ad Interim Committe met at the home of Mr. Swinehart in Lwangju at 9:00 o'clock, A. M. January 26th, 1922, with the following members present: Chairman Nisbet, Messrs. Winn, Harrison, Newland, Knox, Cumming, Preston, Coit and Swinehart, and Mr. Clark sitting for Mr. Eversole, and Mr. Linton in place of Mr. Bull.

Chairman Nisbet conducted the opening devotionals.

Communications were read, Overtures from Stations were submitted, and the following Docket adopted:—

- 1. Communications
- 2. Overtures from Stations, considered in alphabetical order.
- 3. Miscellaneous business.

After full consideration of a communication from Rev. W. D. Reynolds D. D. together with the facts in the case as known to members of the Committee, the following resolution was adopted:---

"In view of the fact that health conditions of his family make it necessary for Dr. Reynolds to return to America at this time, it seems to the Mission wise that while in America he be used for translation work. In order to do this, it will be necessary to have a Korean Assistant for whose maintenance not more than \$60.00 per month will be required.

"We ask the Executive Committee to take these facts into consideration and inform us by cable of their action. In case the Executive Committee approve of our recommendation, that the Mission Treasurer be authorized to provide the traveling expenses home for Dr. Reynolds, it being understood that traveling expenses of the Secretary, either going or coming, be not furnished by the Executive Committee."

The Mission Secretary was instructed to write to Rev. C. A. Clark D. D. thanking him for his efforts in securing a copy of the law regarding fallen women, and to file the copy of that law with the Mission records for future reference.

Answering the Report and request of the House Site Committee for Professor's house in Pyengyang, it was ordered that we recommend that the amount available for such site be \mathbf{X} 6,000,00, which amount is included in the Permanent Equipment Fund of \$5,000.000. This amount to secure the 1549 tsubo, or enough for two house sites as mentioned in the letter from the "Committee for Site" dated October fifth, 1921.

The Secretary was instructed to reply to the communication from Rev. S. A. Moffett, D. D. saying that the matters referred to our Mission would be considered at our next Annual Meeting.

It was with regret that the Committee heard the letter from Rev. W. L. Lingle D. D. saying it was not possible to accept the invitation to visit our Mission this year, and the Mission Secretary was instructed to write him that we sincerely trust he will be able to come at some not far future date.

The Mission Secretary was instructed to communicate with Rev. Dr. Erdman, Princeton, requesting him to visit our Mission during Annual Meeting this year and deliver a series of lectures.

In connection with the proposed visit of Rev. W. T. Thompson D. D. to Korea and for Sunday School work, the following resolution was passed:—

"The Ad Interim Committee of the Southern Presbyterian Mission wishes to express its appreciation of the action of the Executive Committee in appropriating money in order to assist the World's Sunday School Association to send out Rev. W. T. Thompson to Korea, and expresses its regret that, owing to the 16 S. S. Institutes held in different parts of Korea in November and December, making it impossible to expect to do anything more than a limited Sunday School work in Bible classes and institutes during the first months of this year, the World's S. S. Association found it advisable to cancel Dr. Thompson's proposed trip at this time.

"We also desire to exress our appreciation to the Union Theological Seminary for so generously offering to loan Dr. Thompson for the work, and the World's Sunday School Association for their active and unselfish effort to secure aid for the work in Korea, and to Dr. Thompson himself in agreeing to come to us."

Upon motion it was ordered that we accept the cut of ten percent on class B items, imposed by the Executive Committee owing to the decrease of receipts, and that each Station be authorized to adjust this within the Station Budget, and report the same to the Mission Treasurer on or before March First, 1922.

The Meeting adjourned with prayer, to meet at 2:15 P. M.

2:15 p. m.

The Committee was called to order by the Chairman and Mr. Linton led in prayer.

Drs. Wilson and Patterson appeared before the Committee and spoke on the medical situation in the Mission.

It was moved and carried that when we adjourn, we adjourn to meet at Kunsan, March 24th, 1922.

Ordered; that each Station report individual balances and deficits at that meeting, and also report Station Balances and deficits.

Ordered, that we give Kunsan Church the free use of 300 pyung of land for ten years without obligating ourselves in any way for the buildings they may have on it, and with the understanding that they shall pay the taxes on the land they use.

Permission is requested from the Executive Committee to allow Kunsan Station the rents on the Mission property in Kunsan amounting to about Yen 15.00 a month, to be applied on purchase of houses for secretaries; this to apply to the years 1921, 1922 and 1923.

The meeting adjourned with prayer. 8:00 p. m.

The session was opened with prayer by Mr. Winn.

Messrs. Knox and Newland were appointed a Committee to confer with Dr. Wilson and prepare a letter setting forth the facts in the matter of the Special Expenditures at the Hospital, and after the same has been approved by Kwangju Station, copies be sent to the Executive Committee and to Mr. C. E. Graham.

The Secretary was instructed to write a cordial letter to Dr. M. O. Robertson, expressing our hope that he and Mrs. Robertson return to Korea and to their post at the conclusion of their regular furlough.

Ordered that the Leper Committee of the Mission make Quarterly Audit of the Leper Hospital Books, and the Quarterly Report be sent to London.

Dr. Wilson and family were given permission to leave on regular furlough in April, 1922 in place of May, on account of the need of an operation for Mrs. Wilson.

The matter of Dr. Wilson's withdrawing from the regular work and entering Leper work was tabled until Annual Meeting.

The question of the new Leper Hospital Site was tabled until Annual Meeting.

Ordered, that on account of Rev. H. D. McCallie's illness, Mr. and Mrs.McCallie's furlough be changed from April first, 1922 to February 25th, 1922, to return within one year.

The request to appoint Miss Hattie Knox as business woman for Kwangju Hospital and to extend a call to Severance Hospital to allow Dr. Hopkirk to visit Kwangju Station once a month during the time they are without a doctor and the reply to the Executive Committee as to the terms and conditions of cooperation with the Mission to Lepers, all were tabled until next Annual Meeting. It was moved and carried that Miss Georgia Hewson be assigned in charge of the Kwangju Hospital after Dr. Wilson leaves on furlough, and that Mr. Swinehart have charge of the finances of the same.

Ordered, that when Dr. Wilson goes on furlough, Mr. Swinehart be assigned to have charge of the Leper Hospital, and that Mr. Unger assist him and be in charge of the Industrial work at the Leper Hospital Church.

Ordered, that Dr. Timmons be assigned to Soonchun Station until Dr. Rogers' return, and that the Mission Sec. inform both doctors of this action.

That Ad Interim Committee provide for recovering our Hospital Building at Soonchun, and that Mr. Swinehart be put in charge of making the plans, letting contracts, etc.; the Station members to render such assistance as is in their power, and that an effort be made to secure the money needed out of unexpended balances.

The Mission Treasurer was authorized to make transfers within the General Budget to balance such accounts.

Mr. Swinehart tendered his resignation as Mission Secretary of Sunday School work, which was accepted.

The Special Committee on Statistical Blanks reported on a form of Statistical Blank which contains the information required in reporting to General Assembly, Federal Council and to the Mission, and that practically all this information is found in the Statistical Blank already adopted and in use by the Presbyteries. This blank was adopted and Mission Secretary requested to have the same printed and distributed for use in making report to the Mission this year.

The members of Soonchun Station were given permission to make application for the land needed at Chijisan, either by purchase or lease, but that the Mission be not committed by such action until the report be submitted to the Mission and reviewed and approved by that body.

AD INTERIM COMMITTEE MEETING MINUTES, KOREA MISSION.

Kunsan, March 23rd, 1922.

The following members of Ad Interim Committee met at the home of Rev. Harrison at 8:00 P. M.:—Chairman Nisbet, Messrs. Knox, Newland, Cumming, Harrison and Swinehart, and Mr. Crane in place of Mr. Preston, and Mr. Clark sitting for Mr. Eversole.

Devotional exercises were conducted by the chairman.

The Secretary was ordered to read the communications.

Ordered, that the Secretary be instructed to forward the letter from Severance Hospital (Dr. Avison) to the Executive Committee, with a request that if the appropriations made by the Executive Committee for Severance Hospital and College are to be considered as outside of the Budget and not subject to cut as suggested in the letter, then and in that event, we ask the Appropriations for PyengYang Union Christian College and the Union Theological Seminary, which now bear their proportionate share of the cut, to be considered in a similar way, and that if additional appropriation is made for one, that it be provided for all Union Causes in which we participate.

The Secretary was instructed to reply to Dr. S. H. Chester's letter by saying that the greatest need is for a good dentist, rather than a pharmacist, that the dental work of the Mission may be looked after, but that if the dentist who has corresponded with Dr. Chester, and who is also a pharmacist, can be recommended by the Executive Committee for this work, we will gladly welcome him as a member of our Mission.

Replying to the letter of Dr. Avison about guaranteeing a proportionate part of the cost of a third dentist for Severance, that we request the Secretary to say that owing to the financial stringency in America, and the fact that we are urging the Executive Committee to send us a dentist for work in our Mission, we cannot at this time agree to join the proposition. It was ordered that we pay the expenses of Rev. C. Darby Fulton to Korea to investigate the matter of his coming to Korea to enter the work here, viz: Yen 122.09, out of balances to be reported at this meeting.

The communication from Treas. E. F. Willis, regarding the matter of the \$1,000.00 which was given to Rev. John McEachern and Mr. W. A. Linton, to be carried as an advance until it can be absorbed in the Kunsan Station Budget, was considered, and the following resolutions adopted :--

- 1. That we express our disapproval of the action of brethren in thus drawing from the Executive Committee any part of any year's Budget, without having consulted and secured the consent of the Mission to do so.
- 2. That inasmuch as we are returning a considerable sum to the Ex-Committee as unexpended balances for the year 1921 22, and since we cannot see our way clear to absorb the \$1,000.00 in our Budget for this year, we would request the Executive Committee to make an additional appropriation for this amount if they do not care to cancel this charge against our Mission, from funds being returned.

The meeting adjourned to meet at 9:00 A. M. Friday, March 24, 1922, after being led in prayer by Mr. Newland.

Kunsan, Korea, March 24th, 1922.

Pursuant to adjournment, the Ad Interim Committee met at the home of Mr. Harrison at 9:00 A. M., with the following members present: Committeemen Nisbet, Harrison, Cumming, Knox and Swinehart, with Mr. Clark sitting for Mr. Eversole, and Mr. Crane acting in place of Mr. Preston.

The Chairman read a scripture passage and Mr. Clark led in prayer.

The Minutes of a meeting held by the same body the evening before were read and approved, and made the official action of the Ad Interim Committee. A letter to the Executive Committee, regarding our financial policy, etc. was adopted as follows, and the Secretary ordered to send a copy to the Executive Committee. (See attached letter)

The Committee heard with great pleasure the letter from Mr. Edward L. Junkin, in which he expressed his desire to enter the work in Korea, and asking our advice as to the preparation he should make to best fit him for his life's work. The Secretary was requested to convey to Mr. Junkin our great joy in this prospect of his taking up work in our Mission, and that at the next Annual Meeting definite action will be taken in the matter, after which Mr. Junkin will be advised. Mr. Harrison was also requested to write Mr. Junkin a letter of advice and suggest to him the preparation he should make for this work.

Regarding the communication from Dr. Chester asking further information regarding the reported heretical teachings in some missions, we will say that since the deliverance made by this Mission last year seems to be insufficient, we appoint a Special Committee to investigate and make full report to next Annual Meeting. Messrs. Knox and Tate were appointed as such Committee.

Mr. Knox was appointed in place of Dr. Wilson, and Dr. Timmons in place of Dr. Rogers as members of the Severance College Board.

Mr. Winn of Chunju was reported present.

The Committee welcomed Rev. Eugene Bell, D. D. and Mrs. Bell back to the Mission. Dr. Bell made a statement regarding his physical condition, and the Committee unanimously passed a motion of appreciation and graditude at his return to the field, and, while he will not be able to undertake full work as formerly, we approve of the action of the Executive Committee in returning Dr. Bell to the field, as there is a work that he can do and a place he can fill.

It was moved and carried that Dr, Reynolds be requested to defer his sailing date to permit him to complete the spring term at the Seminary, and if he should find it impossible to do this, then Mr. McCutchen be requested to take the last half of the spring term.

The meeting adjourned with prayer. 2:30 p.m.

The Committee met at 2:30 and was convened with prayer by Mr. Nisbet. Kwangju Station was given permission to use Yen 85.00, now on hand, to apply to the expense of Dr. Mok in his study at Peking.

Ordered, that all Stations be required to prepare an audit of all Station Accounts at the close of September 1922, for report to the Ad Interim Committee as an extra precaution tending to keep the expenditures within the Budget.

Ordered, that the following General Budget Items, which have been paid, over and above the appropriation, be charged to the funds not yet expended :—
