Yes I have.

I want to chat with Edgar in Mayor's office and then get my hands on the plans for the Circle from [redacted] so I can figure out the electrical capability and the infrastructure needs for using water from the retention tank under the Circle, which should be simple.

I will have [redacted] create some new elevations and rendering of us looking at the Circle ringed with green and no tree and other flotsam so that the visual idea of what the palette will be.

Then I want to do some quick considering of the size envelope of what we are proposing - ideal height and pedestal height and width.

Then I want to make a proposal for Dept of Cultural Affairs to put grant money up for the artist.

Then after I have that, Mike declares me the Chair of the Windward Circle Beautification Committee which is easy since for the past 4 years I have raised about 10k to clean it up and decorate it at XMas, and we send out applications for a 5 or ten person committee to agree on guidelines and evaluate proposals.

In other news: Main St from Windward Circle to Westminster is about 700 feet long, 76 feet wide and parks 15 cars at meters.

Attached is a pic of Main St with marks on all the property owners and tenants I know I can get to sign on to do head in parking without even trying.

The only impediment is there is a bus stop on the east side of Main at the Circle, but that could be moved onto the Circle easily, nothing is there in front of the old Antler hotel.



Second, how can we start a lease agreement for this group or some other method to allow them to place and operate the Carousel? Can you convey to and the Venice Chamber what you need to get a lease agreement even in the works?


Hi all -

I hate adding any more to this petty email but here are just a thought - frankly Taylor can probably express the government position better than I or George.

The tower is currently meant to be temporary - just its for Summer not for just a party. The Venice sign started out as a temporary installation but the city, coastal and the community decided it was positive to the community.

As George points out there are many expressions on public property from the POW mural, the venice sign, or banners on public light poles advertising museums.

I think there is a permit process involved in doing anything temporary on or across public property. I believe anyone is free to do so if they feel it is important enough. I remember we were looking at getting an anti- violence sculpture for the boardwalk plaza that was a giant gun, but it was of too much concern for the community so we did not move forward.
