Unfortunately I did not see your suggested edits and this morning, the Motion was introduced and will be scheduled before the full Council next week, likely at the June 8th Council session.

I like your edits and they are technically correct and probably more accurate but the language we used was drawn from a previous similar Motion accepted by the Council (and the Planning Department). Stylistically your edits are probably more focused and clearer and we'll take note for future reference - I'm thinking at this point, rather than upset the apple cart, we proceed with the Council vote next week. We could then theoretically introduce an "Amending Motion" to refine the moving clause on the Council floor, but I'm thinking the current language is "good enough" and securing an officially adopted Motion to include in the development team's entitlement package submittal before June 18th is the key objective. We'll make note of your edits for future reference.
