Thank you. Hakeem sent me another person confused and thinking that the Community Plan was being updated, and yes, it was in reference to the 1330 W. Pico Motion; we can clarify.

Hello Shana -

Thanks for reaching out - I checked the Council Member's September 4th schedule and did not see the NC meeting on his schedule. So I do not believe he personally attended that particular meeting. However, it is possible our Field Deputy or District Director attended the NC meeting. It's quite possible any reference to a "new" plan was in relation to the Central City West Specific Plan amendment, but I don't think our field staff would necessarily be totally conversant on that process.

We also introduced a Council Motion (initiating a General Plan Amendment at 1330 W. Pico Blvd.) related to a proposed convention center hotel in Pico-Union, which amends a previous Motion to refer potential future land-use changes within a specified geographic area considered "transitional" to the future Westlake Community Plan update process. Again I don't think our field staff would speak to that matter.
