




# **Connecting to Computer**

## Charging the Battery

The player's battery can only be charged through the USB port of a computer.

 Slide the USB connector upward as shown below.



Insert the USB connector of the player into the USB port on the computer tightly (use an optional USB extension cable if necessary). Once connected, the display shows as below:

> USB Connected Hold ▶II to charge batt.

 Press and hold ►II to enter battery charging mode. The display shows as below with the battery icon = animating.

**USB** Connected

- Charge the unit for at least 2 hours before first use.
- You can still transfer files to the player in the battery charging mode.
- When the battery is full, the display shows "Battery full".

# Transferring Files to the Player

You should refer to the software manual for details in software installation, connecting your player with the computer and transferring files to the player.



#### Note

The player will automatically go to battery charging mode if the battery level is low.

Do not disconnect the USB connection during music

download. Doing so may corrupt system files or the files being downloaded.



## **General Controls**



- 1. MIC Microphone.
- 2. USB connector.
- + Increases volume; moves upward in menu navigation.
- -- Decreases volume; moves downward in menu navigation.
- Skip and search backward a file; goes back a menu level in menu navigation; selects radio frequency and preset stations.
- Skip and search forward a file; goes up a menu level in menu navigation; selects radio frequency and preset stations..
- 7. Press and hold to switch on or off the player; starts and pauses playback.


- Starts and ends recording; press to select music files as My Selections; for sectioned audible files, press repeatedly during playback to select skipping by section or by file.
- 9. M Accesses the player's menu.
- 10. Lock switch slide to the locked icon to prevent accidental key activation. The lock icon \$\textcap\$ shows on the display when keys are locked.
- Headphone jack, input jack for line-in recording (TC1500FM, TC1501FM, TC1502FM, TH1500, TH1501, TH1502 only).
- 12. Reset button.

Note: Radio Recs files are recorded files from the radio (see "Radio Recording"); Voice / Line-in Recs are recorded files from the microphone and line-in audio cable respectively (see "Voice Recording" and "Line-in Recording"). My Selections files are your preferred files (see "My Selections").

Music files are further sorted as below:

- Artists
- Albums
- Titles
- Genres
- Years

The navigation menu is displayed when playback is stopped or when **M** is pressed during playback.

This player is meant to play mp3 and Windows Media™ audio files transferred in the built-in flash memory. To do so, you need the use of a Windows computer with USB port and a music management software (Yahoo! Music Engine or Window Media Player recommended).

The Music Management CD that comes with your Digital Audio Player contains all of the necessary software components you need to make your Digital Audio Player work properly.

These components do the following:

- to install USB driver (for Windows 98SE users only),
- to use a music management software to organize your music collection,
- to enable you to transfer files from your computer to your Digital Audio Player.

### **Getting Started**

#### Inserting the Included CD-ROM into CD-ROM Drive

 Turn on your computer and place the Music Management CD that comes with your digital audio player into your computer.



#### Note:

Don't connect the USB device to the PC or digital audio player before or during the CD-ROM installation.

If you're running Windows ME/2000/XP, no additional drivers are required. If you're running Windows 98SE, you must install the USB drivers from the CD-ROM in order for the digital audio player to function properly.

If the setup screen does not appear, double click My Computer, double click your CD-ROM drive icon, and double click "Install" to run the installer.





### **Connecting to the Computer**

#### **Connecting the Player to** the Computer

Connect the Digital Audio Player to your computer. If a USB connection cable is provided, connect it to the player first before the computer. The larger end of the cable should be connected to the computer while the smaller end to the player.



Some models can be directly connected to the USB port of the computer. If necessary, an optional USB extension cable can be used.

The digital audio player will appear as a removable disk drive.



It might take several seconds

for the device (the Digital Audio Player) to be detected, especially in Windows 2000/XP. Click Refresh in My Computer or Explorer to make sure the device has been detected



The Digital Audio Player is capable of transferring files

at full-speed when a USB 2.0 connection is used. USB 2.0 is up to 40 times faster than USB 1.1. If a USB 2.0 port is available on your computer, use it to connect to your Digital Audio Player. The player is still backward compatible with the older USB 1.1 ports. However, you will not be able to take full advantage of the potential speed increase.

## Transferring Files to a Digital Audio Player

Depending on the availability of software on your Music Management CD specific to your digital audio player, you can transfer files to your Digital Audio Player via 1) Yahoo! Music Engine (Windows XP only), 2) Windows Media Player or 3) Windows Explorer (requires no software installation).

If your Digital Audio Player isn't already connected to your computer, connect it to the computer using the provided USB cable as illustrated on the previous page.
