


ADANGER: Never use blades , wire or flailing devices. Unit is designed for line trimmer use only. Use of any other accessories or attachments will increase the risk of injury.

OPERATOR SAFETY

- Always wear safety · Dress properly. glasses or similar eye protection when operating, or performing maintenance, on your unit (safety glasses are available). Eye protection should meet the requirements of ANSI Z87.1.
- Always wear face or dust mask if operation is dusty.

- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. Do not go barefoot or wear sandals. Stay clear of spinning line.
- Secure hair above shoulder length. Secure or remove loose clothing or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- · Being fully covered also helps protect you from debris and pieces of toxic plants thrown by spinning line. Stay Alert. Do not operate this unit when
- you are tired, ill, or under the influence of alcohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.
- Never start or run inside a closed room or building. Breathing exhaust fumes can kill.

 Keep handles free of oil and fuel.

UNIT/MAINTENANCE SAFETY

- Disconnect spark plug before performing maintenance except carburetor adjustments.
- Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working condition.
- Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper length.
- Use only 0.080" (2 mm) diameter Poulan PRO® brand line. Never use wire, rope,
- Install required shield properly before using the unit. Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- · Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor
- Use only recommended Poulan PRO® accessoriés and replacement parts.
- · Have all maintenance and service not explained in this manual performed by an authorized service dealer.

FUEL SAFETY

- Mix and pour fuel outdoors.
- Keep away from sparks or flames.
- Use a container approved for fuel.
- Do not smoke or allow smoking near fuel or the unit.
- · Avoid spilling fuel or oil. Wipe up all fuel
- Move at least 10 feet (3 meters) away from
- fueling site before starting engine.

 Stop engine and allow to cool before removing fuel cap.
- · Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage trimmer head and be thrown causing serious injury.

- Use only for trimming, mowing, and sweeping. Do not use for edging, pruning, or hedge trimming. Keep firm footing and balance. Do not over-
- reach.
- Keep all parts of your body away from spinning line and muffler. Keep engine below waist level. A hot muffler can cause serious burns.
- Cutting with the line on right side of the shield will throw debris away from the oper-
- · Use only in daylight or good artificial light.

TRANSPORTING AND STORAGE

· Allow the engine to cool; secure unit before storing or transporting in vehicle.

- · Empty the fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting the engine and letting it run until it stops.
- · Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by

For normal homeowner use, the muffler and spark arresting screen will not require any service. After 50 hours of use, we recommend that your muffler be serviced or replaced by your Authorized Service Dealer.

ASSEMBLY

WARNING: Make sure your unit is properly assembled and all fasteners are secure.

ADJUST THE HANDLE

Loosen wing nut or plastic knob on handle.Rotate handle to upright position and tighten in a comfortable position between the


trigger and the safety label on the tube. Tighten handle securely.

ATTACH THE SHIELD

WARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line. The line limiter blade (on underside of shield) is sharp and can cut you.

Insert bracket into slot on shield.

- Pivot shield until bolt passes through hole in bracket.
- Securely tighten wing nut.
- Remove packing cover from the arbor shaft if so equipped.
- Thread trimmer head onto shaft; tighten securely against dust cup.



FUEL YOUR UNIT

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan PRO® brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.


STARTING

HOW TO STOP YOUR UNIT

To stop the engine, move the ON/OFF switch to the OFF position.

HOW TO START YOUR UNIT





WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

COLD ENGINE STARTING (or a warm engine after running out of fuel) Rest engine and shield on ground. Move the ON/OFF switch to the ON posi-

- Slowly press the primer bulb 6 times.
- Move choke lever to FULL CHOKE position.
- · Squeeze and hold throttle trigger through all remaining steps.
- Pull starter rope handle sharply 6 times.

 Move the choke lever to HALF CHOKE
- position. Pull the starter rope handle no more than 6 pulls, until engine runs.

• Allow the engine to run 10 seconds, then move choke lever to OFF CHOKE position.

RESTARTING A WARM ENGINE

- · Move choke lever to HALF CHOKE position.
- · Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow in-structions in STARTING A COLD ENGINE.

USING YOUR UNIT

OPERATING POSITION




Cut from your left to your right.

ADVANCING THE CUTTING LINE


Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. A metal blade attached to the shield will cut the line to the proper length.

REPLACING THE LINE

- Press the lock tabs and remove the cover.
- · Remove the lock ring, tap button, and spool.



- · Check the indexing teeth on the spool and hub for wear.
- Use a clean cloth to wipe the inner/outer surfaces of the spool and hub.
- Use only 0.080 inch (2 mm) diameter line.
- Cut two lengths of line approximately 20 feet (6 meters).
- Insert line into the small hole in the spool.



· Wind the line evenly and tightly onto the spool; wind indirection of arrow found on

spool. Leave 4-6 inches (10-15 cm) of line

- Insert line into the line exit hole in the hub.
 Push spool into hub. Press spool down,
- Push spool into hub. Press spool down, then turn it to catch spool tabs under gear tabs.
- · Re-install the tap button, lock ring, and cover.
- Pull the end of the line to set spool in the operating position.

SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps.

Carburetor adjustments is a complicated task. We recommend that you take your unit to an Authorized Service Dealer. Damage will occur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable.

SPARK PLUG

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is 0.025".
