Safety Instructions

Your OKIDATA printer has been carefully designed to give you years of safe, reliable performance. As with all electrical equipment, however, there are a few basic precautions you should take to avoid hurting yourself or damaging the printer:

- Read the setup instructions in this handbook carefully. Be sure to save it for future reference.
- Read and follow all warning and instruction labels on the printer itself.
- Unplug the printer before you clean it. Use only a damp cloth; do not use liquid or aerosol cleaners.
- Place your printer on a firm, solid surface. If you put it on something unsteady, it may fall and be damaged; if you place it on a soft surface, such as a rug, sofa, or bed, the vents may be blocked, causing the printer to overheat.
- To protect your printer from overheating, make sure all openings on the printer are not blocked. Don't put the printer on or near a heat source, such as a radiator or heat register. Keep it out of direct sunlight. Allow enough room around the printer for adequate ventilation and easy access to the paper trays.
- Do not use your printer near water, or spill liquid of any kind into it.
- Be certain that your power source matches the rating listed on the back of the printer. If you're not sure, check with your dealer or with your local power company.
- Your printer has a grounded, 3-prong plug as a safety feature, and it will only fit into a grounded outlet. If you can't plug it in, chances are you have an older, non-grounded outlet; contact an electrician to have the outlet replaced. Do not use an adapter to defeat the grounding.
- The printer must be installed near a power outlet which remains easily accessible.
- To avoid damaging the power cord, don't put anything on it or place it where it will be walked on. If the cord becomes damaged or frayed, replace it immediately.
- If you are using an extension cord or power strip with the printer, make sure that the total of the amperes required by all the equipment on the extension is less than the extension's rating. The total ratings of all equipment plugged into the outlet should not exceed 15 amperes.

- Do not poke anything into the ventilation slots on the printer; you could get a shock or cause a fire.
- Aside from the routine maintenance described in this handbook, don't try to service the printer yourself; opening the cover may expose you to shocks or other hazards.
- Do not make any adjustments other than those outlined in the handbook: you may cause damage requiring extensive repair work. See Section 5 for information on how to get your printer serviced by qualified OKIDATA technicians.

If anything happens that indicates that your printer is not working properly or has been damaged, unplug it immediately and follow the procedures in Section 5 for having your printer serviced.

These are some of the things to look for:

- The power cord or plug is frayed or damaged.
- Liquid has been spilled into the printer, or it has been exposed to water.
- The printer has been dropped, or the cabinet is damaged.
- The printer doesn't function normally when you're following the operating instructions.

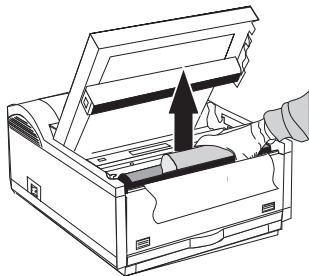
Section 1: Setting Up Your Printer

Remove the protective sheet

1. Press latches and open the cover.

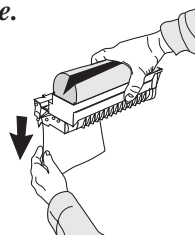


2. Remove the image drum.

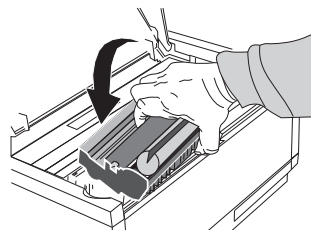


3. Remove the protective sheet.

✓ *Be Careful: do not touch the Image Drum's green surface.*

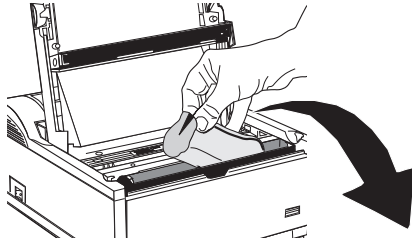


4. Replace the image drum.

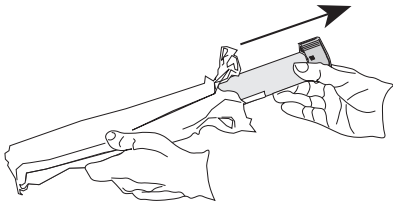


Installing Toner

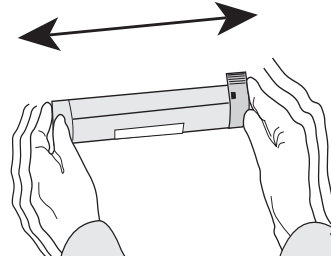
1. Remove the sponge and discard.



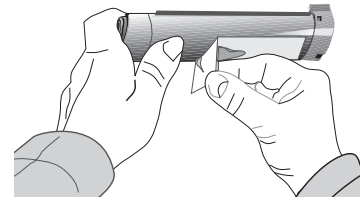
2. Unwrap the toner cartridge.



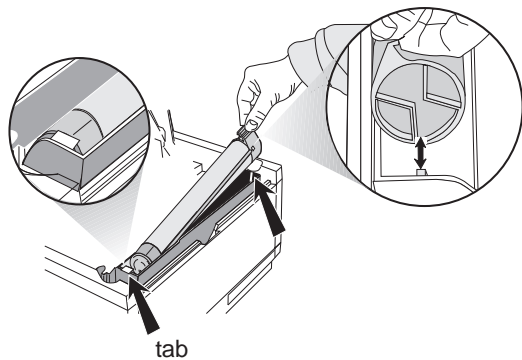
3. Shake the toner cartridge to evenly distribute toner.



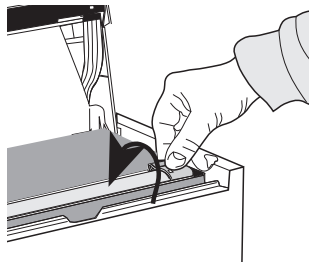
4. Remove the tape.



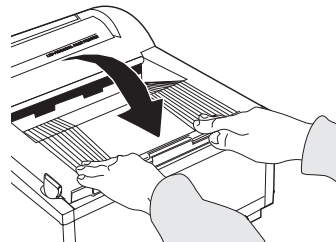
5. Place left side of toner cartridge under the tab, then lower cartridge into well matching groove and slot.



6. Push the blue lever forward.



7. Close the printer cover firmly.



✓ *If you get toner on your clothing, brush it off with a dry cloth. Wash clothing in cold water; hot water sets toner.*

Choosing Paper

- Use a paper weight of 16 to 24 lb. in the Paper Tray and 16 to 32 lb. for manual feed.
- For best results, use paper that is smooth and of high quality, such as copier paper or paper with a Sheffield rating of 250 or less.
- Store paper in its ream wrapper until you are ready to use it. Keep it away from moisture or other conditions that can cause it to wrinkle or curl.
- Preprinted forms must not scorch, melt, offset, or release hazardous emissions when heated to 392°F (200° C) for 0.1 second.
- Avoid printing on both sides of the paper for more than a few pages, or on preprinted documents that have been in a photocopier.
- Try paper before you buy it in quantity.

Using Recycled Print Media

Recycled paper should be restricted to 20% to 35% Post Consumer Content and not exceed 50%. Paper must be relatively stiff and have minimum edge curl. Paper should be white and bright for maximum

contrast. The surface should be smooth, clean, and stable electrically and dimensionally.

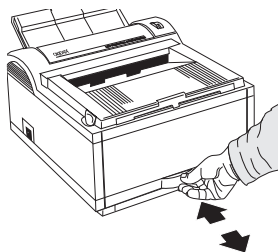
*Recycled paper used by OKIDATA printers must be specifically denoted by the paper manufacturer to be for laser printers, or laser guaranteed or compatible. **Using media outside these specifications may cause problems requiring service that will not be covered by OKIDATA warranty or service agreements.***

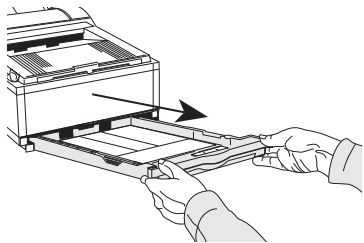

Installing Paper

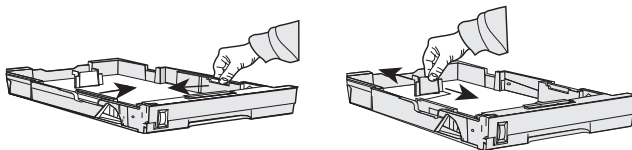
1. Push the paper tray handle to release the tray.



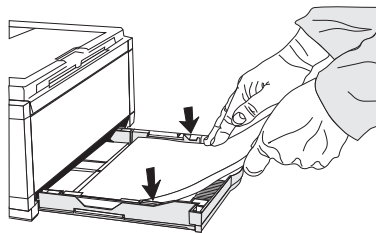
2. Remove the paper tray.



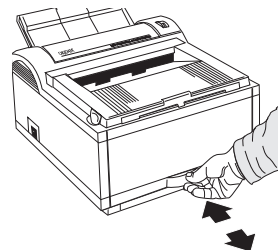
3. Adjust the paper guides.



4. Insert up to 100 sheets of 20 lb. paper.
✓ *Do not fill above PAPER FULL mark.*



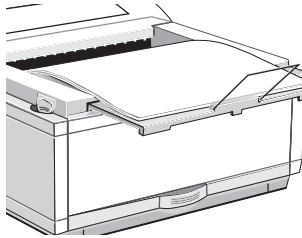
5. Re-insert the paper tray.



Paper Exit Paths

Top Paper Exit

- Printed pages exit face down.
- Pages are stacked in the order printed.
- Exit bin holds 100 sheets (20 lb. paper)

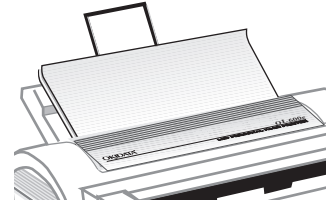


Pull the front exit extender forward. Lift out the metal support bar.

✓ *Do not change the paper exit path during printing—a paper jam may occur.*

Rear Paper Exit

- Always use rear exit for printing on heavy paper, envelopes, labels and transparencies.
- Printed pages exit face up in reverse order.
- Exit tray's maximum capacity is 50 sheets (20 lb. paper).

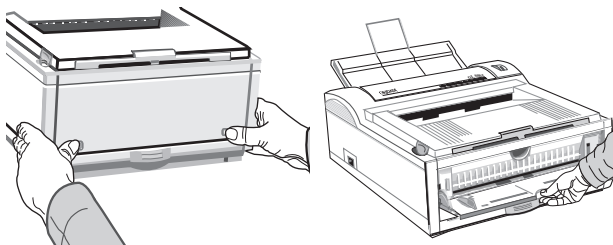


Pull out the rear exit extender until it locks into place. Lift out the metal support bar.

To return to top exit, fold in the metal support bar and push the rear exit extender in until it clicks into place.

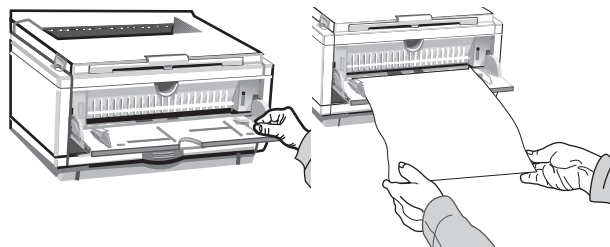
Manual Feed

Use manual feed for printing envelopes, transparencies, legal and odd size paper.



1. Press the push points on the front panel to release the manual feed tray. Pull the tray down.

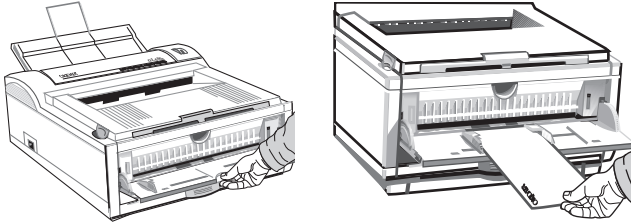
2. Adjust the tray guides. Insert a sheet of paper until the printer grips it. When using letterhead paper, insert letterhead edge in first, face up.
3. Set your software application for manual feed and paper size, then issue a print command.



Transparencies/Adhesive Labels

- Use Manual Feed.
- Use rear output.
- Should be specifically made for laser printers or photocopiers.
- Must be able to withstand 200°C for 0.1 sec.
- Labels should cover entire carrier sheet.
- sheet or adhesive **must not** be exposed to any part of the printer.

Printing Envelopes



1. Pull out the rear exit extender until it locks and lift out the support bar. Pull down the manual feed tray and adjust the paper guides.
2. Insert the envelope—flap down and on the left—until the printer grips it.
3. Set envelope size and landscape orientation in your software, then issue the print command.

Choosing Envelopes

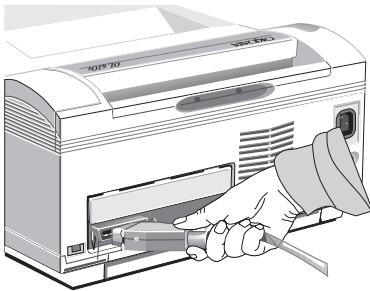
- Always use rear output.
- No windows or metal clasps.
- Paper no heavier than 28 lbs.
- Smooth even surface.
- No self-sealing flaps.
- Seams down the sides, not across the middle.
- Squared-off flaps that do not cover the print area.

Connecting Your Printer

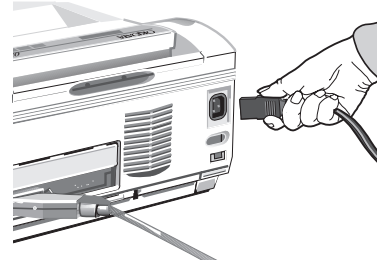
Make sure your printer is not plugged in and your computer is turned off.

The interface cable must be an IEEE 1284 compliant bidirectional parallel cable, and must be shielded and UL and CSA approved.

1. Plug the interface cable into the parallel socket in the printer. Plug the other end into your computer.



2. Plug the power cord into the printer, then into a grounded outlet.



3. Switch the printer on. The Ready light comes on.

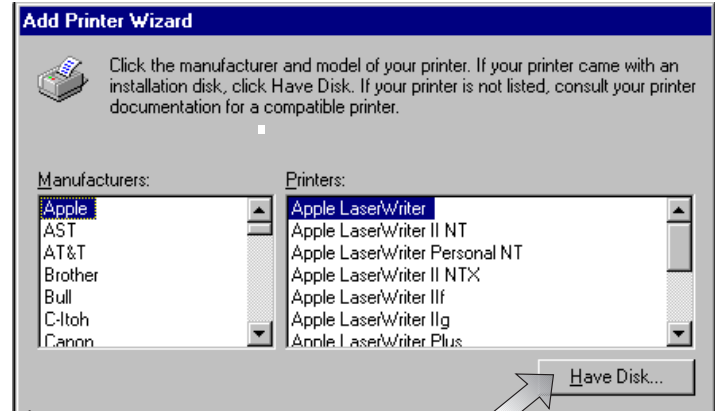


Section 2: Installing Printer Software

Installing the OKIPAGE 6e Software for Windows 95

1. Turn on your computer to start Windows.
✓ *If “New Hardware Found” prompt appears, click “Driver from disk provided by hardware manufacturer,” then click OK. Insert the OKIPAGE 6e CD into your CD-ROM drive and go to step 9, then follow the instructions on your screen.*
2. Close any open applications.
3. Insert the OKIPAGE 6e CD into your CD-ROM drive.
4. Click the **Start** button on the Windows taskbar, then choose **Settings**→**Printers**.
5. Double-click the **Add Printer** icon.
6. The Add Printer Wizard screen appears; click **Next** to begin the installation.
7. Select Local or Network printer, (depending on your configuration), then click **Next**.

8. Click **Have Disk**.



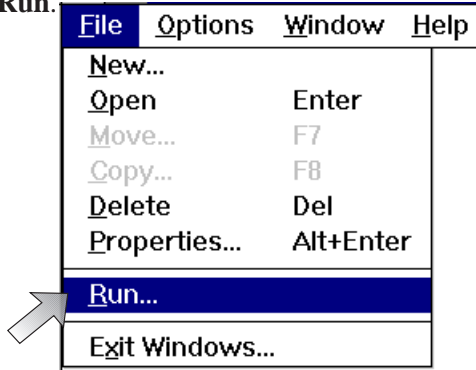
9. Enter d:\ (or the location of your CD-ROM drive), then click **OK**.
10. **OKIDATA Okipage 6e Hi-Per W** appears; click **Next**.
11. Click **LPT1 Printer Port**, then click **Next**.
12. Continue with the installation following the instructions on your screen.

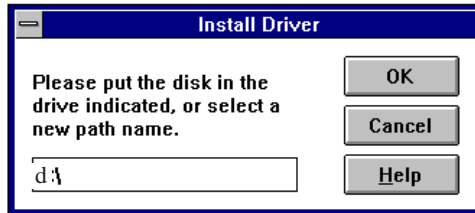

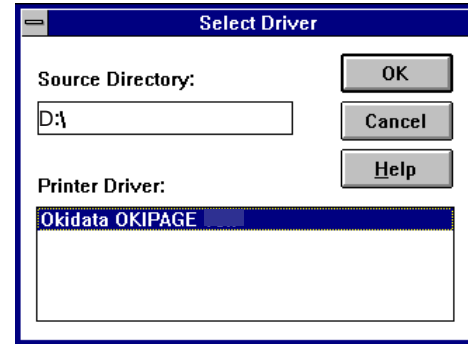

Installing the OKIPAGE 6e Software for Windows NT 4.0

✓ *Do not use Add Printer Wizard.*

1. Turn on your computer to start Windows. **Make sure the printer is turned off.**
2. Insert the disc into the CD-ROM drive.
3. Click **Start** button from the taskbar.



4. Click **Run**.
5. Type d:\setup (or the location of your CD-ROM drive), then click **OK**.
6. Follow the on-screen instructions to install the software.
7. Turn the printer on, then restart Windows to activate the software.

Installing the DOS Operator Panel

If you are running your printer from DOS, install the DOS Operator Panel:

1. Insert the disc into the CD-ROM drive.
2. At the DOS prompt (c:>) type d: <press Enter>.
3. Type d:\install <press Enter>.
4. Follow the on-screen instructions.

Using the Status Monitor

The printer software installs a real-time status monitor and online operator panel for the user. Click the Help button for more information.

Displays printer status in text.

Shows printer status using icon colors.

Displays progress of sending print data (Win 95 only).

Displays setup of printer driver.

Closes Detail Display Panel and sets minimized view display.

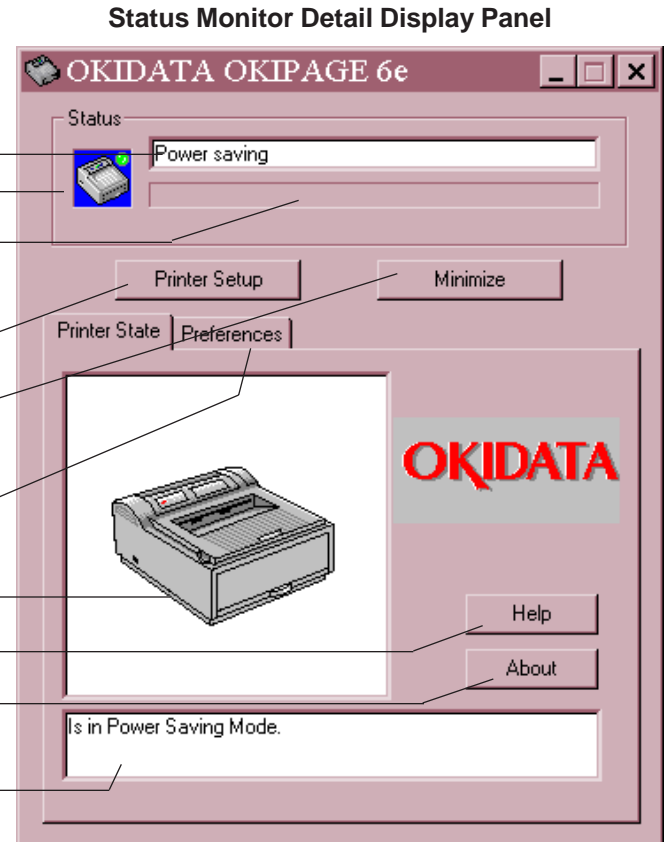
Displays Printer Menu dialog to change user default settings and set display format of the Status Monitor.

Displays graphic animation of printing status.

Displays Help.

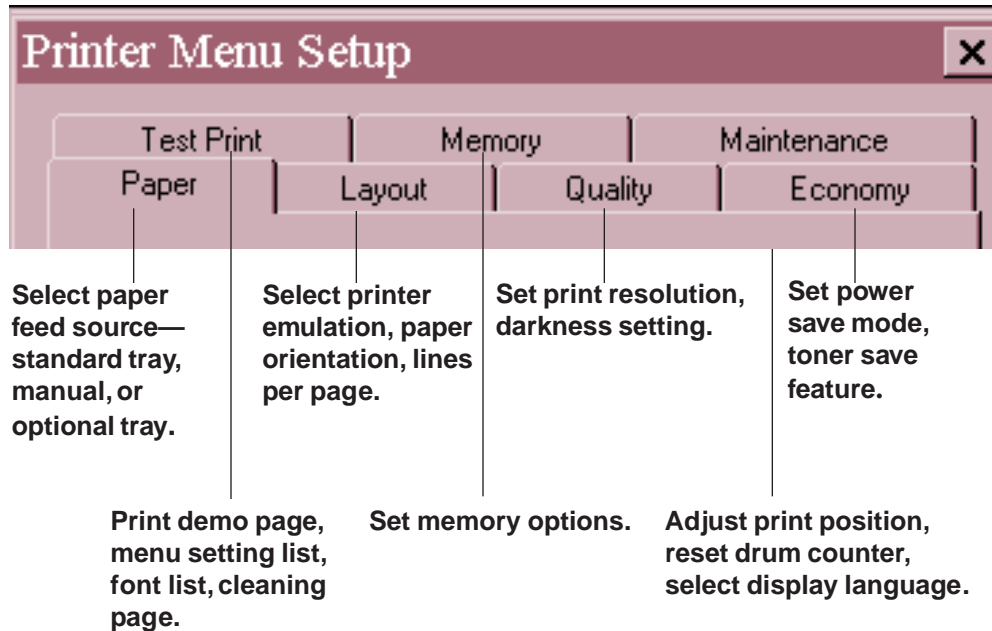

The printer menu displays printer defaults which you can modify. To change a default setting, select the appropriate tab. Point to any item on a display to see a pop-up explanation.



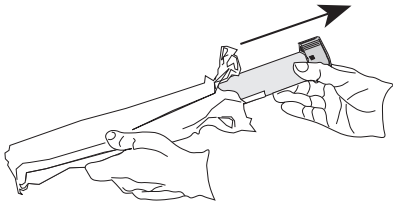

Replacing the Toner Cartridge

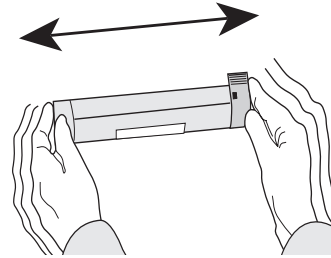
1. Open the cover and remove the used toner cartridge.



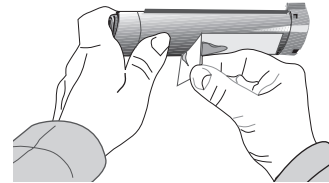
2. Unwrap the new cartridge (Part 52107201).



3. Shake the toner cartridge to evenly distribute toner.

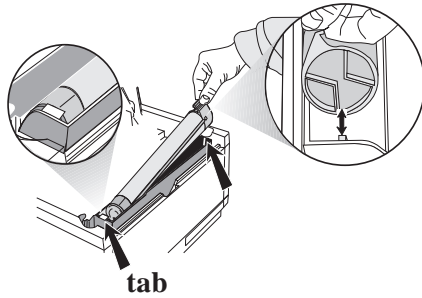


4. Peel tape off the bottom.

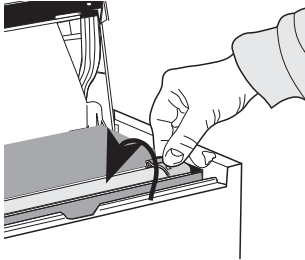


✓ *For highest print quality, we recommend using genuine Okidata consumable products in your page printer. We cannot control the manufacturing and operating characteristics of non-Okidata toner cartridges or assure the resulting print quality.*

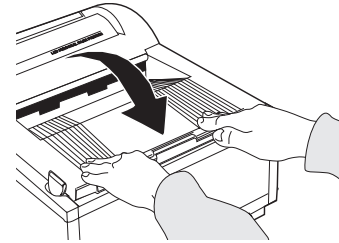
5. Place left side of toner cartridge under tab, then lower cartridge into well matching groove and slot.



6. When the cartridge is in place, push the lock lever forward until it stops.



7. Close the printer cover firmly.



Toner Cartridge Life

How long your toner cartridge lasts depends on the print density, the percentage of the page that prints black.

A typical letter has 3% to 5% print density; graphics usually have higher density. Higher print density means toner is used up faster.

At 5% print density, a toner cartridge will print an average of 2,000 pages. Remember, this is only an average: actual results may vary.

The first toner cartridge in your new printer has to fill the drum reservoir and saturate the developing roller with toner. It normally produces about 1,000 pages.

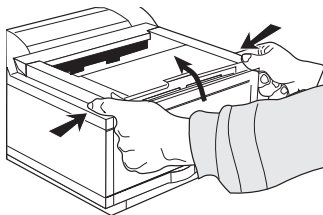
When to Replace the Toner Cartridge

Replace the toner cartridge when you see the TONER LOW message displayed on the Status Monitor. Order **Part Number 52107201**. You can continue printing until print quality deteriorates.

Drum and Toner are consumables and as such are subject to a 90-day warranty.

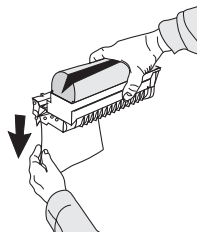
Replacing the Image Drum Cartridge

1. Open the cover and remove the used image drum cartridge.

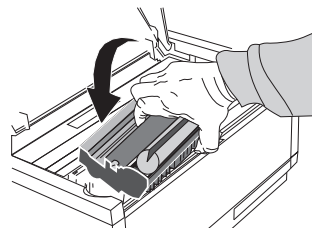


2. Unwrap the new image drum cartridge (Part 56116801). Remove the protective sheet.

✓ **Be Careful:** do not touch the *Image Drum's green surface.*



3. Replace the image drum.



4. Install a new toner cartridge.
5. Reset the Drum Counter. (See next page).

Resetting the Drum Counter

It is important to clear the drum counter after replacing the image drum. This enables the printer to display an accurate warning message when the drum has reached end of life. If the drum is not replaced after it has reached end of life, print quality becomes poor.

1. Maximize the printer Status Monitor Display
2. Click the **Printer Menu** button
3. Click the **Maintenance** tab
4. Click the **Drum Counter Reset** button.

Image Drum Cartridge Life

The life of an image drum depends on a number of factors, including temperature and humidity, the type of paper you use, and the number of pages per job.

The image drum cartridge should last about 12,000 pages at one page per job, 16,000 pages at three pages per job, 18,000 pages at seven pages per job and 20,000 pages at fifteen pages per job. These numbers are approximate, since you do not print the same number of pages each time, and environmental conditions and paper type used may vary.

When to Replace the Image Drum Cartridge

When the drum reaches 90% of its life, the Status Monitor displays CHG DRUM. At this point, be sure you have a new drum on hand (**Part 56116801**). Replace the old one as soon as the print quality becomes faint or starts to deteriorate.

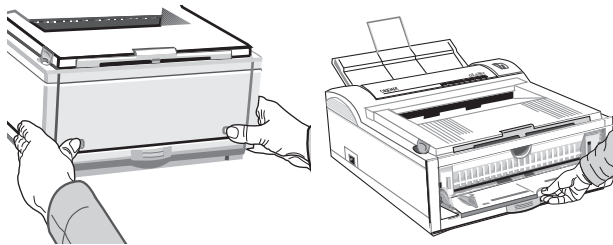
Running a Cleaning Page

The Cleaning Page process

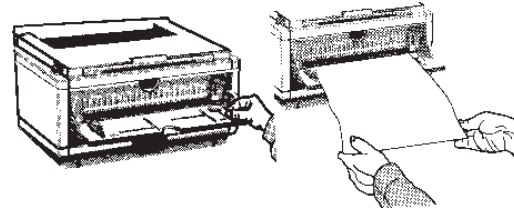
- Removes residual impurities from printing surfaces
- Reduces problems such as repeating marks, blotching, and shading.

To generate a Cleaning Page:

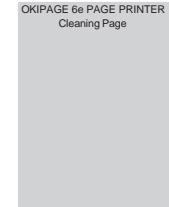
1. Maximize the Printer Status Monitor Display
2. Click the **Printer Menu** button
3. Click the **Test Print** tab
4. Click the **Cleaning** button.
5. Press the push points at the front of the printer to release the manual feed tray.



6. Pull the tray down.
7. Adjust the guides.
8. Insert a clean sheet of 8" x 11" paper.



The Cleaning Page prints.

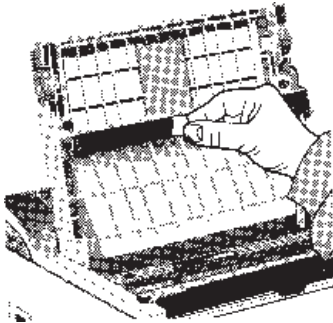


Cleaning the LED Array

Clean the LED array

- Whenever you install a new toner cartridge
- If you see faded vertical areas or light printing down a page

Wipe the LED array gently with the cleaning pad that came with your toner cartridge. You can also use a clean, soft cloth with a small amount of rubbing alcohol on it.



Expanding Memory

The optional 1 MB Memory Expansion Board (Part 70029701) will increase printer memory to 2 MB. The board also provides a socket for installation of an additional SIMM module for expanding memory up to 18 MB. A 1, 2, 4, 8, or 16 MB SIMM module can be installed.

The following SIMM modules have been tested and approved for use in the Okipage 6e printer.

1 MB x 32bit (70ns card type)	(Okidata Part 70019801)	Toshiba THM321020SG-70
2 MB x 32bit (70ns card type)	(Okidata Part 70019901)	Toshiba THM322020AS-70
4 MB x 32 bit (70ns card type)	(Okidata Part 70028801)	Toshiba THM324000S-70

Note: 8 and 16 MB SIMM modules are commercially available

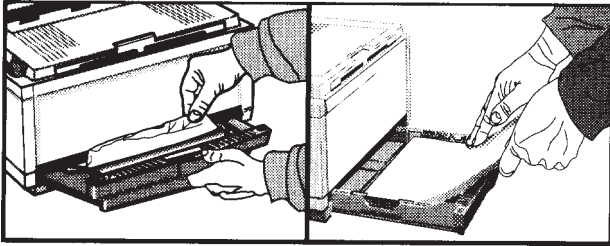

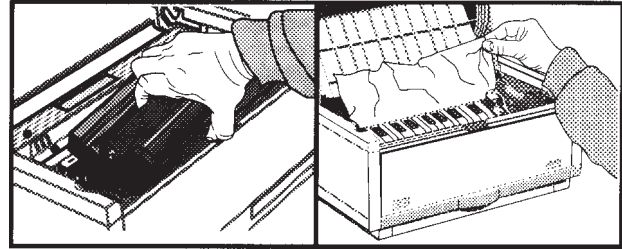
Clearing Paper Jams

“PAPER INPUT JAM”



Slide the paper tray out of the printer. Remove the sheet that did not feed. Check the remaining sheets to make sure they're not wrinkled or stuck together. Replace the tray, then open and close the cover to clear the message.

“PAPER FEED JAM” or “PAPER EXIT JAM” (top jam)



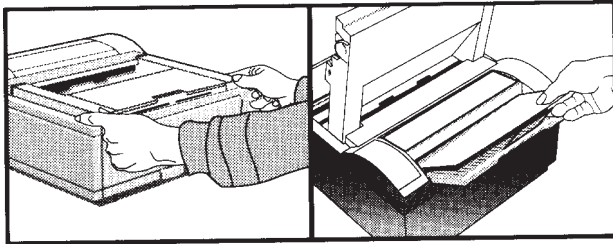
Open the cover. Lift out the image drum.

✓Be careful: the fuser unit at the back of the printer is hot!

Remove the jammed paper. Replace the image drum. Close the cover.

“PAPER EXIT JAM” (rear jam)

Lift the top cover. Pull the jammed paper out from the *back* of the printer. *Pulling from the front may damage the printer.* Remove the image drum and look to make sure the paper is cleared and no pieces are left. Replace the image drum and close the cover.



Print Quality Problems

Before consulting a service representative regarding a print quality problem, check the table below to see if there is a solution, or something you might have overlooked.

Symptom	Problem	Solution
Blank sheets printed.	Image drum cartridge not properly installed. Empty or missing toner cartridge.	Reinstall image drum cartridge. Install new toner cartridge.
Entire page prints faintly.	Pages get fainter when toner is used up. LED array is dirty.	Install new toner cartridge. Clean LED array.
Page has gray background.	Static electricity, generally from dry environments, causes toner to stick to background.	Change papers to a smoother laser bond or use a humidifier.
Page prints all black.	Hardware problem.	Contact your service representative.
Page has repetitive marks.	Damaged image drum cartridge causes repetitive marks every 1.6 inches due to surface nicks and scratches.	Generate a Cleaning Page, repetitive marks may be temporary. Install a new image drum cartridge.
An oblong area of faint print	“Dropout” caused by using paper exposed to high humidity. appears on each page	Change paper stocks, check paper storage environment or use a dehumidifier; check toner.
Vertical white streaking or faint print appears on the page	Toner is low and does not distribute properly, or the drum is worn out.	Replace toner cartridge. Check drum and replace if necessary. Contact service.

Vertical black lines.	LED array is dirty. Is toner low? Hardware problem.	Clean LED array. Replace toner cartridge. Contact service.
Fuzzy print	LED array is dirty.	Clean LED array.
Distorted print	Paper path, lamp assembly, or fusing unit problem.	Generate Cleaning Page. Contact service.
Faded print after installation.	Toner cartridge is not correctly installed.	Install toner cartridge correctly.
Smearred or blotched print	Dirty rollers; toner dropped inside printer or image drum problem.	Generate Cleaning Page. Contact service.
Printed page is light or blurred.	Is toner low? Is paper meant for laser printers? LED array is dirty.	Replace toner cartridge. Use recommended paper. Clean LED array.
Bold characters and dark lines are smearred.	Toner is low.	Install new toner cartridge.
Print is darker than usual.	Darkness setting is too high.	Change darkness setting.
Pages curl excessively	Printing on wrong side of paper. High humidity. Moisture in paper. High humidity.	Turn paper over in tray. (Note arrow on paper package). Install paper print side down in tray. Improper storage. Avoid storing paper in areas of excessive temperature changes and humidity. Store paper in protective wrapping. Recommended operating humidity: 20-80%

Software Problems

Your software (operating environment, applications and printer drivers) controls the printing process. Make sure you have selected the right driver for use with your printer. See your software documentation for more information.

Symptoms	Problem	Solution
Printing is “garbled.”	Incorrect driver is installed, or selected in your software.	Select the appropriate printer driver in your software application and in Windows control panel.
Printer’s output is below rated speed.	Much of the printing delays will be caused by your application. Hardware Problems

Symptoms

Graphic image prints partly on one page, partly on the next.

When you try to print nothing happens, but printer indicates it is ready to receive data.

“Garbage” prints.

Printer freezes or displays error message when computer is rebooted.

Odors.

Printer is on but must “warm up” before a job is printed.

Online Status Monitor indicates that there is a communications problem.

Problem

Insufficient printer memory for this image

Configuration error.

Check cable configuration, continuity, and length.

Booting the computer while the printer is on communications error.

Gases are given off by forms or adhesives passing through the hot fusing unit.

Power Save mode is set on to conserve energy. The fuser must heat up before you can begin printing the next job.

Incorrect interface cable being used.

Printer is not connected directly to the bidirectional parallel port.

Solution

Install more memory in your printer, change the resolution, reduce the image size.

Check cable connection. If more than one printer is available, make sure your printer has been selected.

Incorrect cable configuration. (Also, see “Software Problems.”)

Turn printer off before rebooting computer.

Make sure the forms you are using can withstand heating; provide adequate ventilation.

To eliminate warmup delay, change Power Save setting in printer's online operator panel.

Verify that the interface cable is bidirectional, conforming to IEEE-1284 standards.

Printer must be connected directly to port; no switching device, external print buffer, scanning device, etc. can be attached to port.
