



### **READ THIS FIRST**

We have designed your telephone to conform to federal regulations and you can connect it to most telephone lines. However, each device you connect to the phone line draws power from it. This power draw is the device's Ringer Equivalence Number, or REN. The REN is shown on the bottom of your

If you are using more than one phone or other device on the line, add up all the RENs. If the total is more than five (or three in rural areas), your phones might not ring. If ringer operation is impaired, remove one of the devices from the

If your phone causes problems on the phone line, the telephone company can disconnect your service. The phone company tries to notify you in advance. If advance notice is not practical, the telephone company notifies you as soon as possible and advises you of your right to file a complaint with

The phone company can also make changes to its lines, equipment, operations, or procedures that could affect the phone's operation. The phone company notifies you in advance, so you can take the necessary steps to prevent interruption of your phone service.

### **FCC STATEMENT**

Your telephone complies with Part 68 of FCC Rules. You must, upon request, provide the FCC registration number and the REN to your telephone company. These numbers are shown on the bottom of your phone.

**Note:** You must not connect your telephone to:

- coin-operated systems
- party-line systems
- most electronic key phone systems

This telephone has been ETL tested and complies with all FCC standards.

### **CARE**

- Keep the phone dry.
- Handle the phone carefully. Do not drop it.
- Use and store the phone in normal temperature environ-
- Keep the phone away from dust and dirt.








## **USING THE PHONE**

Press and hold down to disconnect a call. Press and release for special services such as Call Waiting.

**Note:** If you do not subscribe to any special services, pressing the switchhook might disconnect the call.



Adjust the handset volume


Use a paper clip or other pointed object to lift the plastic cover off the number plate. Then write your phone number on the number plate and replace the cover.

Press **REDIAL** to dial the last number dialed (up to 31 digits).

press **HOLD**. Then you can place the handset on the cradle without disconnecting the call. The indicator beside the button lights steadily when a call is on hold. To return to the call, lift the handset from the cradle or press the switchhook.

To put a call on hold,

Set the ringer for a high- or low-volume ring, or turn off the ringer. You can make calls with the ringer off, and you can receive calls if you hear another phone on the same line ringing.



Set to **TONE** or **PULSE** to match the type of service you have. If you have pulse (rotary) service, you can switch to **TONE** during a call to use tone services.
