
SAFETY INFORMATION ON THE UNIT

ADANGER: Never use blade, wire or flailing devices. This unit is designed for line trimmer use only. Use of any other accessories or attachments will increase the risk of injury.



WARNING: Trimmer line throws objects violently. You and others can be blinded/injured. Wear safety glasses and leg protection. Keep body parts clear of rotating line.

Safety glasses or similar eye protection



Keep children, bystanders, and animals 50 feet (15 meters) away. If approached, stop unit immediately.

If situations occur which are not covered in this manual, use care and good judgment. If you need assistance, contact your an authorized service dealer or call 1-800-554-6723.

OPERATOR SAFETY

- Dress properly. Always wear safety glasses or similar eye protection when operating, or performing maintenance, on your unit (safety glasses are available).
 Eye protection should meet the requirements of ANSI Z87.1.
- Always wear face or dust mask if operation is dusty.
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. Do not go barefoot or wear sandals. Stay clear of spinning line.
- Secure hair above shoulder length. Secure or remove loose clothing or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- Being fully covered also helps protect you from debris and pieces of toxic plants thrown by spinning line.
 Stay Alert. Do not operate this unit when
- Stay Alert. Do not operate this unit when you are tired, ill, or under the influence of alcohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.
- Never start or run inside a closed room or building. Breathing exhaust fumes can kill.
- Keep handles free of oil and fuel.

UNIT/MAINTENANCE SAFETY

- Disconnect the spark plug before performing maintenance (except carburetor adjustments).
- Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working condition.
- Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper length.
- Use only 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope, string, etc.
- Install required shield properly before using the unit. Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor adjustments.
- Use only recommended Weed Eater® accessories and replacement parts.
- Have all maintenance and service not explained in this manual performed by an authorized service dealer.

FUEL SAFETY

- · Mix and pour fuel outdoors.
- · Keep away from sparks or flames.
- Use a container approved for fuel.

- Do not smoke or allow smoking near fuel or the unit
- Avoid spilling fuel or oil. Wipe up all fuel spills.
- Move at least 10 feet (3 meters) away from fueling site before starting engine.
- Stop engine and allow to cool before removing fuel cap.
- Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage trimmer head and be thrown causing serious injury.

- Use only for trimming, mowing, and sweeping. Do not use for edging, pruning, or hedge trimming.
- Keep firm footing and balance. Do not overreach.
- Keep all parts of your body away from spinning line and muffler. Keep engine below waist level. A hot muffler can cause serious burns.
- Cutting with the line on left side of the shield will throw debris away from the operator.
- · Use only in daylight or good artificial light.

TRANSPORTING AND STORAGE

- Allow the engine to cool; secure unit before storing or transporting in vehicle.
 Empty the fuel tank before storing or
- Empty the fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting the engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by the tube.
- Store the unit out of the reach of children.

SAFETY NOTICE: Exposure to vibrations through prolonged use of gasoline powered hand tools could cause blood vessel or nerve damage in the fingers, hands, and joints of people prone to circulation disorders or abnormal swellings. Prolonged use in cold weather has been linked to blood vessel damage in otherwise healthy people. If you operate in a locale where such regulations exist, you are legally responsible for maintaining the operating condition of these parts. Failure to do so is a violation of the law. For normal homeowner use, the muffler and spark arresting screen will not require any service. After 50 hours of use, we recommend that your muffler be serviced or replaced by your Authorized Service Dealer.

ASSEMBLY

WARNING: Make sure your unit is properly assembled and all fasteners are secure.


ADJUST THE HANDLE

- Loosen wing nut on handle.
- Rotate handle to upright position and tighten in a comfortable position between the trigger and the safety label on the tube. Tighten handle securely.

ATTACH THE SHIELD

AWARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line to the proper length. The line limiter blade (on underside of shield) is sharp and can cut you.

• Insert bracket into slot in shield. Tighten wing nut securely.



FUEL YOUR UNIT

WARNING: Remove fuel cap slowly when refueling.

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality synthetic 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater brand synthetic oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.


STARTING

HOW TO STOP YOUR UNIT

To stop the engine, push and release the engine STOP switch. The switch will automatically return to the ON position. Wait 5 seconds before attempting to restart unit to allow switch to reset.

HOW TO START YOUR UNIT





WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

STARTING A COLD ENGINE (or a warm engine after running out of fuel)

- Set unit on a flat surface.
 Slowly press the primer bulb 6 times.
 Move choke lever to FULL CHOKE position. Squeeze the throttle trigger fully and hold through all remaining steps.
- Pull starter rope handle sharply 6 times.
- Move choke lever to HALF CHOKE position.
- Pull starter rope handle no more than 6 pulls, until engine runs.
- Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

STARTING A WARM ENGINE

- Move choke lever to OFF CHOKE position. Pull starter rope handle until engine runs.
- If engine does not start in 5 pulls, follow instructions in STARTING A COLD ENGINE.

USING YOUR UNIT

It is recommended that the engine not be operated for longer than 1 minute at full throttle.

OPERATING POSITION




Cut from your right to your left.

ADVANCING THE CUTTING LINE

Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. A metal blade attached to the shield will cut the line to the proper length

REPLACING THE LINE

- · Remove spool by firmly pulling on tap button.
- Clean entire surface of hub and spool.
- Replace with pre-wound spool, or cut a length of 20 feet of 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
- Insert one end of line about 1/2 inch (1 cm) into the small hole on the inside of the spool.



- Wind line evenly and tightly onto spool. Wind in the direction of the arrow on the spool.
- Push the line into the notch, leaving 3 to 5
- inches (7 12 cm) unwound.

 Insert the line into the exit hole in the hub as shown in the illustration.
- Align the notch with the line exit hole.
- Push spool into hub until it snaps into place.
- Pull the line extending outside of the hub to release it from the notch.

SERVICE

AWARNING: The muffler on this product contains chemicals known to the State of California to cause cancer.

We recommend all service and adjustments not listed in this manual be performed by an an authorized service dealer.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Adjusting the carburetor is a complicated task. We recommend that you take your unit to an an authorized service dealer. Damage will occur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable.

SPARK PLUG

Replace the spark plug yearly using a Champion RCJ-7Y plug. Spark plug gap is 0.025".
