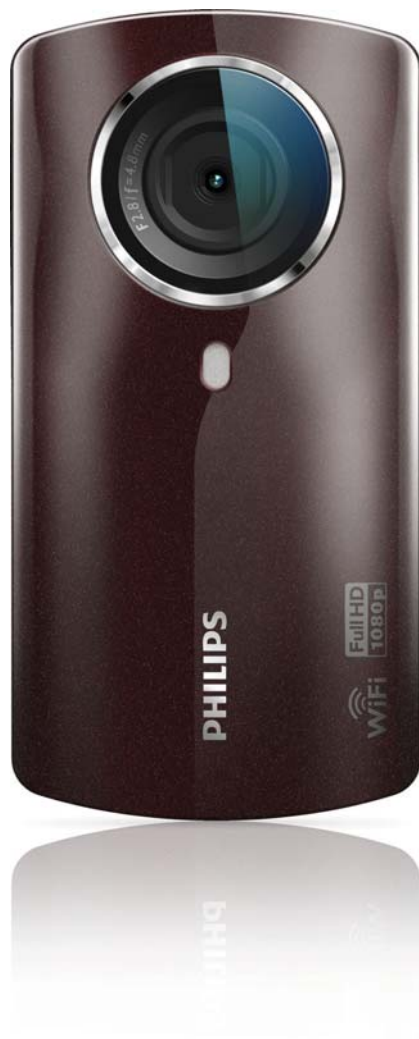

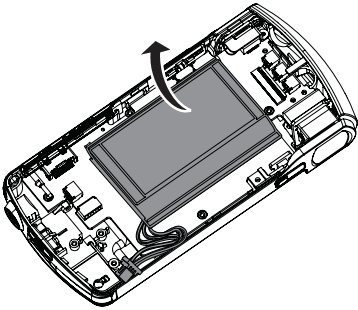

- play recorded movies or pictures on the large screen of a TV wirelessly or through HDMI connection
- upload recorded movies or pictures to the Internet wirelessly or through a PC/Mac

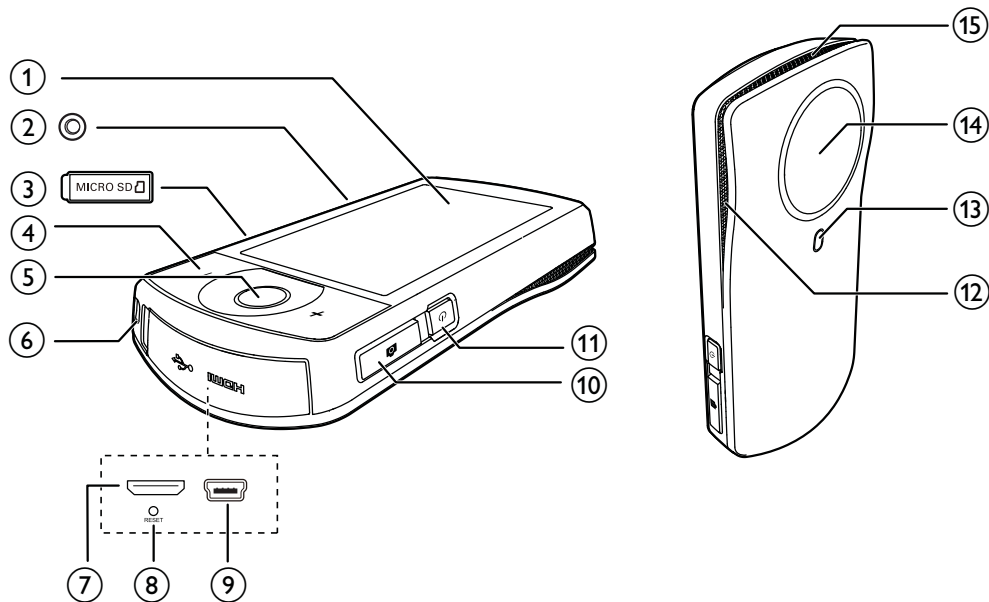

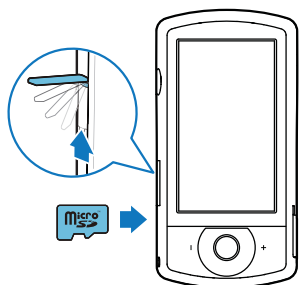
## Functional overview



- ① Touch screen
- ② Tripod socket
- ③ MICRO SD
  - Load a Micro SD card.
- ④ +/-
  - In viewfinder mode, zoom in/out.
  - During video play, change the volume.
- ⑤ Video shutter button (red)
  - In picture viewfinder mode, switch to video viewfinder mode.
  - In video viewfinder mode, start/stop video recording.
  - In play mode, switch to video viewfinder mode.
- ⑥ Hand strap hole
- ⑦ Mini HDMI socket
  - Connect to a TV through an HDMI cable with a mini HDMI connector (type C).
- ⑧ RESET
  - Restore default settings.
- ⑨ Mini USB socket
  - Connect to a PC/Mac through the supplied USB cable.
- ⑩ Picture shutter button (  )
  - In video viewfinder mode, switch to picture viewfinder mode.
  - In picture viewfinder mode, take a picture.
  - In play mode, switch to picture viewfinder mode.
- ⑪ 
  - Turn on/off the camcorder.
- ⑫ Built-in microphones
- ⑬ Flashlight
- ⑭ Lens
- ⑮ Built-in speaker

## 3 Get started

### Load the Micro SD card



- 1 Flip open the protective cover on the Micro SD card socket.
- 2 Insert a Micro SD card (not supplied) into the socket.
  - Make sure that the Micro SD card is not write-protected.
  - Make sure that the metal contact of the card faces down.
- 3 Close the protective cover securely.

### Turn on

- Press .
  - ↳ For first-time users, a menu for OSD language selection is displayed (see 'First-time setup' on page 8).



Tip

- To save energy, the camcorder turns off automatically after being idle for 3 minutes. To turn on the camcorder again, press .

#### To turn off the camcorder:

- Press again.
  - ↳ The backlight on the touch screen turns off.

### First-time setup

More setting options are described in the 'Adjust settings' section (see 'Adjust settings' on page 14).

When you turn on the camcorder for the first time, a menu for OSD language selection is displayed.

- 1 On the touch screen, tap the scroll bar ( / ) to move upward/downward.
- 2 Tap a language to highlight it.
- 3 Tap **[Done]** to confirm.
  - ↳ A date setting menu is displayed.
- 4 Tap / to set the day, month, and year successively.
- 5 Tap **[OK]** to confirm the date setting.
  - ↳ A time setting menu is displayed.
- 6 Tap / to set the hour and minute successively.
- 7 Tap **[OK]** to confirm the time setting.
  - ↳ The first-time setup is complete.
  - ↳ The camcorder enters video viewfinder mode.
  - ↳ A settings bar is displayed at the bottom of the touch screen.



Tip

- To hide the settings bar, tap any blank area on the touch screen. To show the settings bar again, tap at the bottom right corner of the touch screen.




### Select a resolution

- 1 In viewfinder mode, tap to access the settings menu.
- 2 Tap **[Resolution]**.
- 3 Tap **[Video]** or **[Photo]**.
- 4 Tap a video or photo resolution you like to highlight it.
- 5 Tap **[Done]** to confirm the setting.






## Select a special effect

You can select one of the following special effects: **[Normal]**, **[Black & White]**, **[Sepia]** and **[Color filter]**.


- 1 In viewfinder mod, tap  to access **[Effects]** setting.
- 2 Tap  /  to select a special effect you like.
- 3 Tap **[OK]** to confirm the setting.

## Select a scene


You can select one of the following scenes: **[Auto]**, **[Skin]**, **[Snow/Beach]**, **[Night]**, **[Backlight]** and **[Sunset]**.

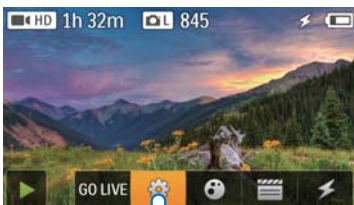
- 1 In viewfinder mode, tap  to access **[Scene]** setting.
- 2 Tap  /  to select a scene you like.
- 3 Tap **[OK]** to confirm the setting.

## Select a flash mode

- In viewfinder mode, tap  repeatedly to select a flash mode:
  - (picture) auto flash, flash on or flash off
  - (video) flash on or flash off

## Set up Wi-Fi connection

- 1 In viewfinder mode, tap  to access the settings menu.




- 2 Tap **[Connectivity]** -> **[WiFi]** to access Wi-Fi setting.



- 3 Tap **[On]** to highlight the option, then tap **[Done]** to confirm.
  - ↳ The camcorder starts to detect Wi-Fi networks available.
  - ↳ After a while, a list of detected Wi-Fi networks is displayed.



- 4 Tap your home Wi-Fi network in the list.
- 5 Tap **[OK]** to confirm.
- 6 Enter your Wi-Fi password (if set).
- 7 Tap **[OK]** to confirm your setting.
  - ↳ After successful connection, a signal icon (  ) is displayed at the top right corner of the touch screen.

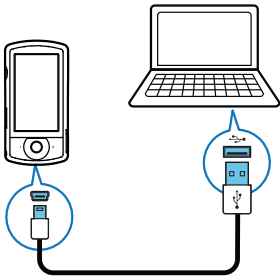


### Tip

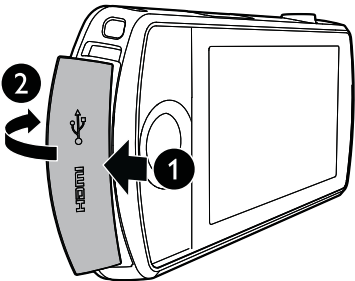
- When the camcorder is powered off and then powered on again, the camcorder is connected to the same Wi-Fi network automatically.
- To switch to another Wi-Fi network, repeat the above procedures.

## Charge the built-in battery

- 1 Open the protective cover at the bottom of the camcorder.
- 2 Connect the camcorder to a PC through the supplied USB cable.
  - ↳ The charge status is shown on the touch screen of the camcorder.



- 3 When the battery is full, disconnect the USB cable and close the protective cover.



### Tip

- The camcorder is fully charged for first-time use.
- It takes about 3 hours to fully charge the built-in battery through a PC.

You can also charge the camcorder through a USB adaptor (not supplied) connected to mains power. The charge time is about 2 hours.

# 4 Use your camcorder




## Record video

### Note



- By default, the camcorder enters video viewfinder mode automatically after power-on.

- 1 Hold the camcorder steadily and aim the lens as needed.
- 2 Press the video shutter button (red) to start recording.
  - ↳ A red time indicator is displayed at the top left corner of the touch screen.
- 3 Press +/- to zoom in/out if necessary.
- 4 Press the video shutter button again to end recording.
  - ↳ **[Video saved]** is displayed briefly.


## Take pictures

- 1 Press the picture shutter button (  ) to switch to picture recording mode.
- 2 Hold the camcorder steadily and aim the lens as needed.
- 3 Press +/- to zoom in/out if necessary.
- 4 Press  down halfway to adjust the focus.
- 5 Press  down completely to take a picture.
  - ↳ **[Picture saved!]** is displayed briefly.


## Play

- 1 In viewfinder mode, tap  on the touch screen to switch to play mode.
  - ↳ The last recorded media is displayed.
  - ↳ An option menu is displayed at the bottom of the touch screen.
- 2 Swipe to the left/rights to select a picture or video clip for play.
- 3 If the selected file is a video clip, tap  in the middle of the screen to start play.
  - To pause play, tap any place of the swivel touch screen.


## Preview

- In play mode, tap .
  - ↳ The thumbnails of 12 files are displayed on each page.
    - To select a file, tap the file directly.
    - Swipe the screen upward/downward to view the previous/next page.


## Delete a file

- 1 In play mode, swipe to the left/right on the touch screen to select a file.
- 2 Tap  to access the window for deletion confirmation.
- 3 Tap **[Yes]** to confirm the deletion operation.
  - ↳ **[Deleted!]** is displayed briefly.
    - To exit the operation, tap **[No]**.

You can also delete files in batches.



- 1 During preview, tap .
- 2 Tap a file.
  - ↳ A check mark is displayed in the middle of the file image.
- 3 Repeat step 2 to select more files.
- 4 Tap **[Selected]**, then tap **[Yes]** to delete the selected files.


### To delete all files:

- 1 During preview, tap .
- 2 Tap **[All]** (all), then tap **[Yes]** to delete all files.

---

### Tag a file


- 1 In play mode, tap a file.
  - 2 Tap  to tag the file.
    - To untag the file, tap  again.
  - 3 Repeat steps 1 to 2 to tag more files.
- You can also tag files in batches during preview.

- 1 During preview, tap .
- 2 Tap files you want to tag.
  - ↳ The tagged files are highlighted in yellow.
  - To untag a file, tap the file again until the file is not highlighted.
  - To untag all files, tap **[Remove all]** at the bottom of the touch screen.

- 3 Tap **[Done]** at the bottom of the touch screen to confirm.

---


### Play tagged files

- 1 During preview, tap 
  - ↳ A tag operation menu is displayed.
- 2 Tap an option to highlight it, then tap **[Yes]** for confirmation.

Menu option	Description
<b>[Play all]</b>	Play all files.
<b>[Play tagged]</b>	Play tagged files only.
<b>[Clear all tags]</b>	Untag all files.

---

### Trim a video clip

- 1 In play mode, swipe to the left/right on the swivel touch screen to select a recorded video clip.
- 2 Tap  to access the trim window.
  - ↳ A bar for video trimming is displayed at the top of the window.

- 3 Tap the left ruler and move to the right to set the starting point you want.
- 4 Tap the right ruler and move to the left to set the starting point you want.
- 5 Tap **[Preview]** to preview the edited video clip.
- 6 After confirmation, tap **[Save New]** to save the edited video clip as a new file.

---

### Zoom in a picture

- 1 In play mode, swipe to the left/right on the swivel touch screen to select a picture.
- 2 Press **+** to zoom in the picture.
- 3 Tap the screen to pan through the enlarged picture.
  - To return to normal view, press **-** repeatedly or tap the cross mark on the left.

---

### Adjust volume level during video play

- During video play, press **+/-**.

---

### Share your movies or pictures wirelessly

With the Wi-Fi connection of CAM200, you can:

- broadcast what you are recording to UStream in real time;
- share your videos/pictures to YouTube, Facebook, Twitter or Picasa;
- share your videos/pictures to a DLNA-certified display device with a simple swipe.

---

### Share to the Internet wirelessly

#### Note

- Make sure that your Wi-Fi router is connected to the Internet.

## Broadcast to UStream

### Note

- If you do not have a UStream account, register one at the UStream website.
- Make sure that the Wi-Fi connection is good enough for successful broadcast. Otherwise, the video streaming may not be able to stay on air.



- 1 In viewfinder mode, tap **GO LIVE**.
- 2 Enter your UStream account name and password for login.
- 3 After successful login, start video recording on your camcorder.
  - ↳ The video is broadcast to UStream in real time.

## Share to YouTube, Facebook, Twitter or Picasa

### Note

- If you do not have a YouTube, Facebook, Twitter or Picasa account, register one at the respective website.

- 1 Select a recorded picture or video clip (see 'Play' on page 11).

Online service	Size limitation to file to be uploaded
YouTube	Up to 15 minutes
Facebook	Up to 10 minutes of video with the size less than 100M
Twitter (Twitvid)	Up to 2G video files
Picasa	Up to 1G video and photo files

- 2 Tap 
  - ↳ An option menu is displayed.

- 3 Tap **YouTube, Facebook, Twitter** or **Picasa** in the list.




- 4 Enter your account name and password for login.
  - ↳ After successful login, a progress window is displayed until upload of the selected file is complete.

## Share to a display device wirelessly

### Note

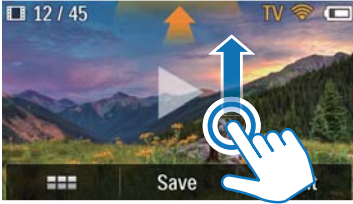
- Make sure that your display device is connected to the same Wi-Fi network as the camcorder.

- 1 Select a recorded picture or video clip (see 'Play' on page 11).
- 2 Tap 
  - ↳ An option menu is displayed.




- 3 Tap **[Device]**.
- 4 Tap a display device (for example, a DLNA-certified TV, photo frame, and so on) in the shown list of available devices.
  - ↳ After successful connection, the selected picture or video clip is uploaded automatically.

- To share more files, select another recorded picture or video clip, then swipe the screen upward.
  - ↳ After a while, you can view the selected file on your display device.



## Adjust settings

- In viewfinder mode, tap  to access the settings menu.
- Tap an item to show its subitems.
- Tap a subitem to show the options available.
- Tap the option you prefer.
- Tap **[Done]** or **[OK]** (for date/time setting) to confirm the setting.

### [Resolution]

Select the video or picture resolution.

- [Video]** - Select the video resolution: **[Full HD]** (for best video quality), **[Sports HD]** (for filming of fast moving objects), **[Share HD]** (minimum video file size for easy sharing) or **[Standard]** (reduced video file size).
- [Photo]** - Select the picture size. The larger the size, the higher the resolution: **[5M]**, **[8M]** or **[10M]**.

### [Connectivity]

Set parameters related to Wi-Fi connection.

- [WiFi]** - Enable and set up Wi-Fi connection (see 'Set up Wi-Fi connection' on page 9), or disable Wi-Fi connection.
- [Ustream]** - Enable or disable real-time broadcast to UStream (see 'Broadcast to UStream' on page 13).

- [Account Management]** - Set your user account of **YouTube**, **Ustream**, **Facebook**, **Picasa** or **Twitvid**.
- [Expose to Network]** - Expose or hide the camcorder in the available DLAN network.

### [Record settings]

- [Capture sound]** - Turn on/off the capture sound.

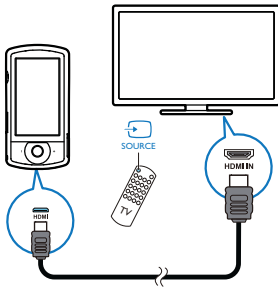
### [System settings]

Change system settings.

- [Date and Time]** - Set the date and time (see 'First-time setup' on page 8).
- [Language]** - Select your desired menu language (see 'First-time setup' on page 8).
- [Format SD card]** - Clear contents from the micro SD card.
- [TV system]** - Change this setting if the output video does not appear correctly on your TV.

# 5 Use more of your camcorder

## View video or pictures on TV through HDMI



- 1 Connect an HDMI cable (not supplied) to:
  - the **HDMI** socket on the camcorder (requiring a mini HDMI connector)
  - the HDMI input socket on an HDTV

↳ An inquiry box for output mode selection is displayed.
- 2 To output the exact camcorder display with menu options to the TV screen, tap **[TV]** on the touch screen.
  - To output the camcorder display without menu options to the TV screen, tap **[Live CAM]** on the touch screen.
- 3 On the camcorder, select a file and start play.

## Install and use the camcorder software

With the software (ArcSoft MediaImpression HD Edition) available in the internal memory of the camcorder, you can import, edit, archive or upload your pictures/videos to the Internet easily.

### Note

- The software supplied only works on PCs that operate Microsoft® Windows® XP, Vista and Windows 7.
- When you connect the camcorder to a Mac, use the iMovie software to import and edit your pictures/videos directly.

## Install the camcorder software

- 1 Connect the camcorder to a PC (see 'Charge the built-in battery' on page 10).
- 2 If the software does not install automatically, find and click the **Setup** icon at **My Computer\CAM200**.
- 3 Follow the on-screen instructions to finish installation of the software.

## Install and use the camcorder software

- 1 On your PC, click **Start\ (All) Programs\ ArcSoft MediaImpression HD Edition**.

↳ The main screen of the software is displayed.



- 2 Click an option to select the corresponding operation.
- 3 Follow the on-screen instructions to complete the operation.

---

## Transfer video/pictures to a PC/Mac

- 1 Connect the camcorder to a PC/Mac (see 'Charge the built-in battery' on page 10).  
↳ It may take some time for the PC/Mac to recognize the camcorder.
- 2 Find your video/pictures at **My Computer\CAM200\DCIM\100MEDIA** or **My Computer\CAM200 SD\DCIM\100MEDIA**.
- 3 Copy any video/pictures you want to your designated folder in the PC/Mac.



### Tip

- You can also import the video/picture files with the camcorder software (for PC) or iMovie (for Mac).

# 7 Frequently asked questions (FAQ)

## Why is there no response when I use the camcorder?

- The camcorder is in power-off mode. Turn on the camcorder (see 'Turn on' on page 8).
- The built-in battery may be drained. Charge the battery (see 'Charge the built-in battery' on page 10).


## Why is [Memory full!] displayed when I try to record?

- Make sure that the Micro SD card has been inserted correctly (see 'Load the Micro SD card' on page 8).
- The memory is used up. Save your video/pictures to a computer (see 'Transfer video/pictures to a PC/Mac' on page 16). Then delete files from your camcorder or clear the memory.

## How much memory is needed for 1 hour of Full HD recording?

- The camcorder uses 4GB on average for 1 hour of Full HD video. For a more complex video recording (e.g. with lots of motions in the video, or a lot of panning), the camcorder will use more memory. This is done to maintain the video quality, but will increase the usage of memory.

## Why do I have no access to folders on the camcorder from my computer?

- Make sure that the USB connection is correct.
- The camcorder turns off automatically 15 minutes after it is connected to a computer. You can press  to turn it on again.

## Why do my video/pictures look blurry?

- Hold the camcorder steady in your hands during shooting.
- During video capture, do not move the camcorder too fast.
- Use a tripod (not supplied) if necessary.

## Why do my video/pictures look distorted on a TV screen?

- Select the correct TV system.

## How do I charge the camcorder?

- You can charge the camcorder via the supported USB cable. When you connect it to your PC/laptop it will automatically charge. You can also connect the camcorder to a USB charger via the supplied USB cable.

## How long do I have to charge the camcorder?

- The camcorder is fully charged for first usage. The camcorder charge time when connected to your PC/laptop is 3.5 hours. When you charge it via USB adaptor, the charge time is 2 hours.

## Where can I find an adaptor for CAM200 to charge the battery?

- CAM200 can be charged via regular USB adaptors, which are readily available in electronic stores. CAM200 is compliant to the iPhone 4 adaptor.

## Camcorder stopped responding?

- In the unlikely event that your camcorder stops responding, you can manually reset it. The reset button is located under the protective cover at the bottom of the camcorder. There you see a small opening above the HDMI connection. Please use a small prying object (like a pen) to insert and press gently for resetting. After you have reset the camcorder, please turn on the camcorder again, and set-up will start again.

### **Why does the camcorder sometimes not record the right color?**

- To record both indoors and outdoors, and not having to change any settings, the camcorder has an automatic white-balance correction. This enables you to record both indoors and outdoors where the amount of light in the environment changes. If you move fast from outdoors to indoors, the camcorder might need some time to correct that, and in extreme cases the colors might seem a bit unnatural. However, after a few seconds this will be corrected automatically by the camcorder.

### **How do I connect it to a Windows PC/laptop?**

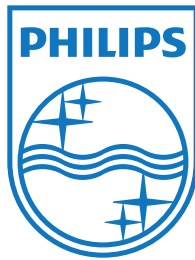
