

 Plug the correct size Adaptaplug onto the jack at the end of the adapter's cord.



- If your device's DC input jack is marked
  ● ⊕, align TIP on the adapter's jack with + on the Adaptaplug (shown).
- If the DC input jack is marked <sup>⊕</sup> , align **TIP** on the adapter's jack with on the Adaptaplug.

CAUTION: Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.

- 2. Plug the Adaptaplug into your device's DC input jack.
- **3.** Plug the AC adapter into an easily accessible power outlet located near the equipment.
