


For printer setup, you will need:

- A computer with a CD-ROM drive and USB port
- A USB cable (such as Lexmark P/N 12A2405), purchased separately
- A4 or letter size paper




Step 3: Connect the power supply

- 2 Press the power button.




Step 4: Connect the USB cable




Note: The location and orientation of the USB port on your computer may be different from the one shown. Look for this symbol:

Note: The cartridge carrier moves to the loading position when you open the front cover.


Setup

You can print with:

- Both a color cartridge (P/N 10N0227 or 10N0026) in the left carrier and a black cartridge (P/N 10N0217 or 10N0016) in the right carrier
- Only a color cartridge (P/N 10N0227 or 10N0026) in the left carrier
- Only a black cartridge (P/N 10N0217 or 10N0016) in the right carrier





Step 6: Load up to 100 sheets of plain paper




Make sure you fully extend the paper support and the paper exit tray.

To avoid paper jams, squeeze and slide the paper guide to the left edge of the paper.



Note: A4 size paper should extend beyond the top of the paper support. Letter size paper should align with the top of the paper support.

Statement of Limited Warranty

Lexmark International, Inc. Lexington, KY

This limited warranty applies to the United States. For customers outside the U.S., refer to the country-specific warranty information that came with your product.

This limited warranty applies to this product only if it was originally purchased for your use, and not for resale, from Lexmark or a Lexmark remarketer, referred to in this statement as "Remarketer."

Limited warranty

Lexmark warrants that this product:

- Is manufactured from new parts, or new and serviceable used parts, which perform like new parts
- Is, during normal use, free from defects in material and workmanship

If this product does not function as warranted during the warranty period, contact a Remarketer or Lexmark for repair or replacement (at Lexmark's option).

If this product is a feature or option, this statement applies only when that feature or option is used with the product for which it was designed. To obtain warranty service, you may be required to present the feature or option with the product.

If you transfer this product to another user, warranty service under the terms of this statement is available to that user for the remainder of the warranty period. You should transfer proof of original purchase and this statement to that user.

Limited warranty service

The warranty period starts on the date of original purchase as shown on the purchase receipt. The warranty period ends 12 months later.

To obtain warranty service you may be required to present proof of original purchase. You may be required to deliver your product to the Remarketer or Lexmark, or ship it prepaid and suitably packaged to a Lexmark designated location.
