#### 1. Introduction

The Tributaries HX1RG6 HDMI 1.3 Transmitter (Tx) and Receiver (Rx) over one RG6/U coaxial cable is a system designed to extend an HDMI signal over a long distance without loss. By converting HDMI to 3GSDI Tributaries HX1C6 is able to deliver Deep Color (12 bits/color) video and new lossless compressed (Dolby® TrueHD, Dolby® Digital Plus and DTS®-HD Master Audio) digital audio, with a bandwidth up to 225MHz (6.75Gbps).

#### 2. Features


- Extends 1080p/12bit color up to 120 meters (393ft) over single RG6/U coax cable
- Extends 1080i up to 150 meters (492ft) over single RG6/U coax cable
- Compliant with HDMI 1.3c, HDCP 1.2 and DVI 1.1 standards.
- Supports PCM L/R Audio, 5.1/7.1 Channel Surround/Digital Audio/DTS-HD
- Supports equalization and recovery of incoming TMDS data before retransmitting with optimal quality regardless of the incoming signal quality.
- Supports xvYCC Color Space
- Supports IR signal transmission from remote source to display over same RG6 Coax
- Receiver can be cascaded up to 4 times for multiple display locations

## 4. Operation Controls and Functions


#### 4.1 Transmitter (Tx) Unit



- **1) HDMI INPUT:** Connect to the HDMI output of your source equipments such as a DVD player or Set-top-box with an HDMI cable.
- 2 POWER INDICATOR LIGHT: illuminates when unit is plugged into 5VDC power supply
- 3 DC 5V: Connect the 5V DC power supply to the HX1RG6. Then connect the adaptor to an AC wall outlet
- 4 IR EMITTER: Connect IR emitter cable (included) to this input. Place the eye of the emitter in front of the source equipment.
- **5 OUTPUT:** Connect the output of the Transmitter to the INPUT of the Receiver using a 75 ohm RG6/U cable that has been terminated with 75 ohm BNC male connectors.

**Note:** Do not use BNC connectors that require screws or clamps to secure the connector to the cable. For best results only use BNC plugs that are secured using a Linear Compression Crimping Tool.

#### 4.2 Receiver (Rx) Unit



- 1 DC 5V: Connect the 5V DC power supply to the HX1RG6. Then connect the adaptor to an AC wall outlet
- 2 INPUT: Connect the OUTPUT of the transmitter to the INPUT of the receiver using an RG6 cable terminated with 75 ohm BNC connectors.


Note: Do not use BNC connectors that require screws or clamps to secure the connector to the cable. For best results only use BNC plugs that are secured using a Linear Compression Crimping Tool or soldering.


- 3 OUTPUT: Connect the output to a 2nd HX1RG6-RX Receiver for cascading up to 4 times to multiple displays
- 4 IR EXTENDER: Connect an IR receiver cable (included) to this input. Place the eye in front of the display, then use the existing remote to control the source equipment.
- 5 HDMI OUTPUT: Connect an HDMI cable to the display
- **6** IR: To use this built-in IR receiver, simply place the receiver in front of the display and use the existing remote to control the source equipment.
- **7 Power LED:** This LED indicator will activate once the included 5V DC power adapter has bee properly connected between the Receiver unit and an open wall power socket.


