



3 Install

Microsoft[®] Windows Vista, XP, 2000, ME, MAC OS 9.0 or higher:

The device driver is installed automatically when the drive is connected to a USB port of the computer. However, with some USB 2.0 cards or boards, you may need to initiate installation manually. In this case, follow the on-screen instructions to search for a suitable driver. Refer to the operating system's Help file if you need any help.

Windows 98SE:



- When a message appears, indicating that the USB flash drive can be safely removed, remove the USB flash drive from the computer's USB port.

Windows[®] Vista, XP

- 1 Double-click the Safely Remove Hardware icon in the task bar in the lower right part of the screen.
- 2 In the window that appears, select the name of the device that is to be removed, then click the **STOP** button.
- When the Stop a hardware device screen appears, make sure the correct information is displayed, then click the OK button.
- 4 When the message **Safe to Remove Hardware** appears, remove the the USB flash drive from the computer's **USB port**.
