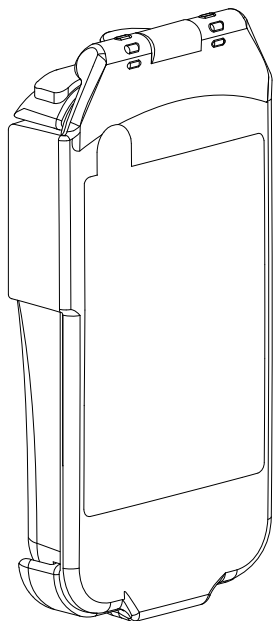

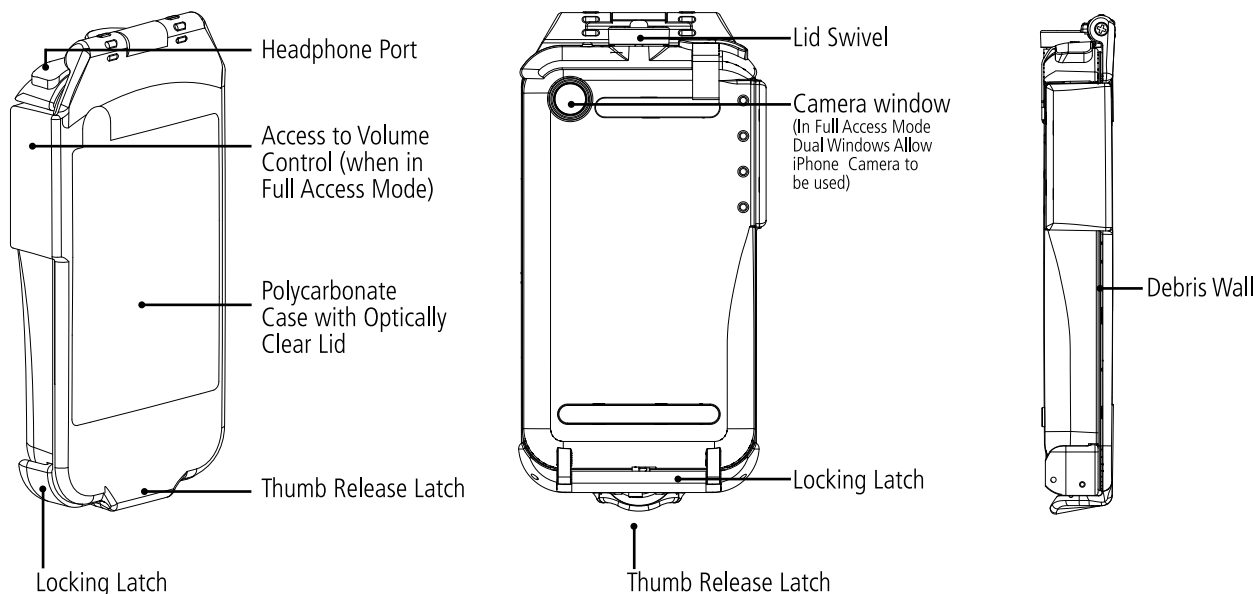

## 3. Introduction

The H2O Audio iFR Case is designed to protect the Apple iPhone from impact and abuse during most sport activities.

The case features the Locking Latch System which keeps the iPhone secure during operation or storage. The H2O Audio case allows for functional control of the iPhone when in Full Access Mode.

While it provides protection from environmental conditions, there are openings in the case for the stereo jack and exterior controls that make the iPhone susceptible to water. The iFR is Not Waterproof, **Do Not Submerge in Water.**

The iFR Case was designed with active, land based, sports in mind, where impact and environmental resistance are required. Sports like:

## 4. Sport Armband

The iFR Case for the Apple iPhone comes with a Neoprene Sport Armband suitable for most active land based sports.

The Sport Armband with iFR Case provides maximum protection from most environmental conditions including rain and snow.

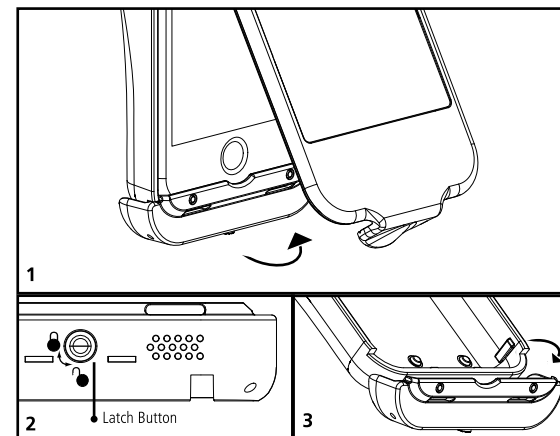

## 5. Opening the iFR Case

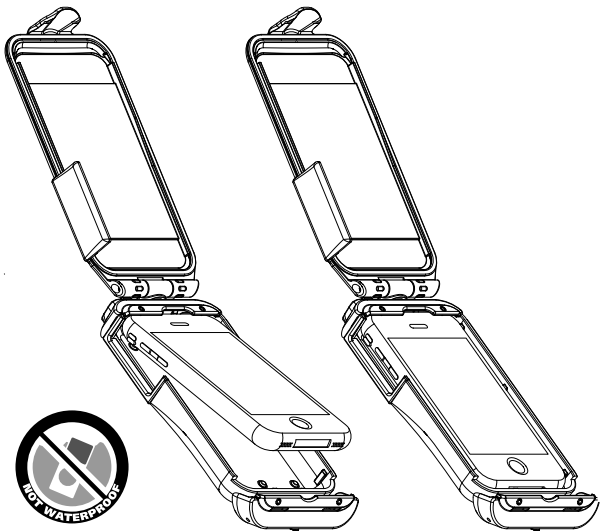
### Opening the Case

1. The lid is held closed by the Thumb Release Latch at the bottom of the case. Use the Thumb Release Latch to flip the lid open.
2. Rotate latch button counter clockwise towards the unlock icon until button stops and latch releases.
3. Open Locking Latch.



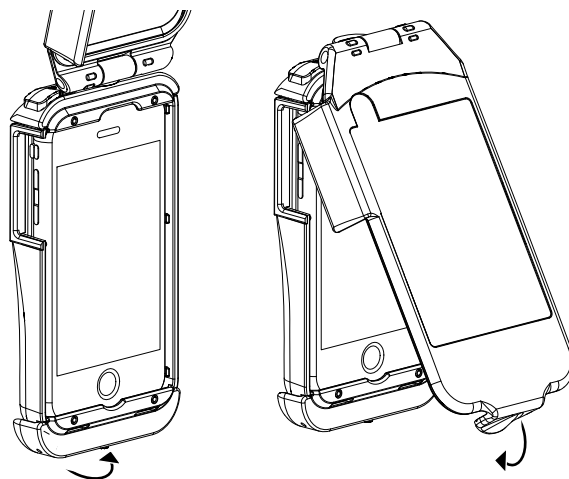
## 6. Installing the iPhone

Once the Locking Latch is open you can install the iPhone into the case. With the screen facing up, and stereo jack oriented towards the top of the case with the volume controls to the side (as shown)

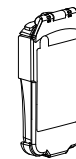


## 7. Closing / Locking the iFR

1. Close the Locking Latch by snapping it back into place.
2. Verify that the Locking Latch is closed and the latch button is in the locked position.
3. Close lid.



## 8. Access to iPhone



**Protection Mode** - The iFR Case in the Protection Mode provides maximum protection from impacts and most sport activities.



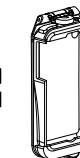
**Full Access Mode** - The iFR Case in the Full Access Mode allows the lid to be stowed away by rotating the lid 180 degrees counter clockwise giving the user full access to all the iPhone controls in or out of the Sport Armband.

## 9. General Storage

For long-term storage, keep out of direct sunlight. Long term UV exposure is not recommended for any materials used in the construction of the case.

**CAUTION:** Do not store case in following environments:

- \* Solvents or other chemical fumes
- \* High humidity
- \* High Ozone
- \* Extreme temperature fluctuations

Storage in such conditions may lead to case damage.

The iFR can be cleaned with soap and warm water. Air dry fully prior to installing the iPhone.

Sport Armband should be hand washed with soap in warm water and allowed to air dry. Do not iron or use bleach.
