General safety guidelines

Always observe the following precautions to reduce the risk of injury and property damage.

Service

Do not attempt to service a product yourself unless instructed to do so by the Customer Support Center. Use only a service provider who is approved to repair your particular product.

Note: Some parts can be upgraded or replaced by the customer. These parts are referred to as Customer Replaceable Units, or CRUs. Lenovo expressly identifies CRUs as such, and provides documentation with instructions when it is appropriate for customers to replace those parts. You must closely follow all instructions when performing such replacements. The Off state of a power indicator does not necessarily mean that voltage levels inside a product are zero. Always make sure that the power is turned off and that the product is unplugged from any power source before you attempt the replacement. If you have any questions or concerns, contact the Customer Support Center.

Power cords and power adapters

Use only the power cords and power adapters supplied by the product manufacturer.

Never wrap a power cord around the power adapter or other object. Doing so can stress the cord in ways that can cause the cord to fray, crack or crimp. This can present a safety hazard.

Always route power cords so that they will not be walked on, tripped over, or pinched by objects.

Protect the cord and power adapters from liquids. For instance, do not leave your cord or power adapter near sinks, tubs, toilets, or on floors that are cleaned with liquid cleansers. Liquids can cause a short circuit, particularly if the cord or power adapter has been stressed by misuse. Liquids can also cause gradual corrosion of the power cord terminals and/or the connector terminals on the adapter which can eventually result in overheating.

Always connect power cords and signal cables in the correct order and ensure that all power cord connectors are securely and completely plugged into receptacles.

Do not use any power adapter that shows corrosion at the ac input pins and/or shows signs of overheating (such as deformed plastic) at the ac input or anywhere on the power adapter.

Do not use any power cords where the electrical contacts on either end show signs of corrosion or overheating or where the power cord appears to have been damaged in any way.

Extension cords and related devices

Ensure that extension cords, surge protectors, uninterruptible power supplies, and power strips that you use are rated to handle the electrical requirements of the product. Never overload these devices. If power strips are used, the load should not exceed the power strip input rating. Consult an electrician for more information if you have questions about power loads, power requirements, and input ratings.

Plugs and outlets

If a receptacle (power outlet) that you intend to use with your computer equipment appears to be damaged or corroded, do not use the outlet until it is replaced by a qualified electrician.

Do not bend or modify the plug. If the plug is damaged, contact the manufacturer to obtain a replacement.

Some products are equipped with a three-pronged plug. This plug fits only into a grounded electrical outlet. This is a safety feature. Do not defeat this safety feature by trying to insert it into a non-grounded outlet. If you cannot insert the plug into the outlet, contact an electrician for an approved outlet adapter or to replace the outlet with one that enables this safety feature. Never overload an electrical outlet. The overall system load should not exceed 80 percent of the branch circuit rating. Consult an electrician for more information if you have questions about power loads and branch circuit ratings.

Be sure that the power outlet you are using is properly wired, easily accessible, and located close to the equipment. Do not fully extend power cords in a way that will stress the cords.

Connect and disconnect the equipment from the electrical outlet carefully.

Batteries

All personal computers manufactured by Lenovo contain a non-rechargeable coin cell battery to provide power to the system clock. In addition many mobile products such as notebook PCs utilize a rechargeable battery pack to provide system power when in portable mode. Batteries supplied by Lenovo for use with your product have been tested for compatibility and should only be replaced with Lenovo approved parts.

Never attempt to open or service any battery. Do not crush, puncture, or incinerate batteries or short circuit the metal contacts. Do not expose the battery to water or other liquids. Only recharge the battery pack strictly according to instructions included in the product documentation.

Battery abuse or mishandling can cause the battery to overheat, which can cause gasses or flame to "vent" from the battery pack or coin cell. If your battery is damaged, or if you notice any discharge from your battery or the buildup of foreign materials on the battery leads, stop using the battery and obtain a replacement from the battery manufacturer.

Batteries can degrade when they are left unused for long periods of time. For some rechargeable batteries (particularly Lithium Ion batteries), leaving a battery unused in a discharged state could increase the risk of a battery short circuit, which could shorten the life of the battery and can also pose a safety hazard. Do not let rechargeable Lithium-Ion batteries completely discharge or store these batteries in a discharged state.

Heat and product ventilation

Computers, AC power adapters, and many accessories can generate heat when turned on and when batteries are charging. Always follow these basic precautions:

- Do not leave your computer, AC power adapter, or accessories in contact with your lap or any part of your body for an extended period when the products are functioning or when the battery is charging. Chapter 1. About the ThinkPad DVD Burner Ultrabay Serial ATA Drive

This manual provides information on registering, installing, and using the ThinkPad[®] DVD Burner Ultrabay[™] Serial ATA Drive, and is available on the *Software and User Guide CD*.

The appendices of this guide contain warranty information and legal notices.

Product description

Your drive is compatible with the DVD-Multi Recorder specification, and can record as well as read DVD-RAM, DVD-RW, and DVD-R (for General, 650 nm) media. Your drive can also record CD-R, CD-RW, and High-Speed CD-RW media, and uses buffer underrun prevention technology for reliable CD burning. Your CD/DVD Burner can read many other formats including DVD+R, DVD+RW, DVD Video, Video CD, audio CD, multiple-session, extended architecture (XA) CDs, and Kodak Photo CD. (Some DVD+R and DVD+RW media brands may not be compatible.) The drive is designed for installation in your Ultrabay Serial ATA Drive Bay or Ultrabay Enhanced Drive Bay.

In addition to this Software and User Guide CD, your option package includes the following:

- ThinkPad DVD Burner Ultrabay Serial ATA Drive
- · Carrying case
- Quick Reference Guide
- · Laser Safety Guide

Software description

Your Software and User Guide CD contains the following software:

MyDVD

This software enables you to create DVD-RAM, DVD-RW, DVD-R, DVD+RW, and DVD+R media that can be played in most stand-alone DVD players. You can add your own videos and create custom menus for DVD videos that you create. You can also use this software to edit and modify your own video assets prior to recording. If you have an analog, USB, or IEEE 1394 capture device installed in your computer, you can use this software to record video from a camera.

• Drag-to-Disc (DLA)

This software enables you to write directly to CD and DVD media using the drive letter as you would if you were writing to a disc. You can also format DVD-RAM, DVD-RW, DVD-R, DVD-R DL, DVD+R DL, DVD+RW, and DVD+R media. With DLA, you can drag-and-drop files, create new directories, or save files from almost any application directly to your CD/DVD Burner. Drag-to-Disc is installed as part of the Creator Business Edition.

UDF Reader

This software enables you to install software for reading DVD-RAM, DVD-RW, DVD+RW, DVD-R DL, DVD+R DL, and CD-RW media on other computers with DVD drives.

Creator Business Edition

This software enables you to copy CDs, create audio CDs, create MP3 CDs, and author data CDs. You can also use Creator Business Edition to write data to DVD-RAM, DVD-RW, DVD-R, DVD-R DL, DVD+RW, DVD+R DL, and DVD+R discs for use in other computers or compatible consumer

electronics products. You can also create bootable CDs and save CD images for later recording. With the Express Labeller that is included in the Creator Business Editions, you can print paper labels or label LightScribe discs.

· Intervideo WinDVD

This software enables you to play back DVD videos on your computer or to play video files from your hard disk drive.

Note: Some graphics adapters such as the ATI FireGL[™], Intergraph, and 3DLABS do not support DVD video playback.

Installation requirements

To install the ThinkPad DVD Burner Ultrabay Serial ATA Drive, your ThinkPad computer must meet the following requirements:

- · A ThinkPad system with an Ultrabay Serial ATA Drive Bay or Ultrabay Enhanced Bay
- A ThinkPad X200 Ultrabase Dock or Dock II
- Microsoft® Windows 2000, Microsoft Windows® XP, or Microsoft Windows Vista® operating system


Note: Lenovo offers limited support for computers with Microsoft Windows 95, Windows 98, or Microsoft Windows Millennium Edition (Me) desktop operating systems.

Installing the drive

Your ThinkPad computer includes a help system, Access ThinkPad, which provides drive installation instructions specific to your computer. To correctly install the drive into the Ultrabay Serial ATA Drive Bay or Ultrabay Enhanced Bay, follow the instructions provided in the Access ThinkPad help system.

Locating the drive controls

The following diagram shows the location of the controls on the front of the drive.



- 1 Power light: This light is visible when the drive is in use.
- **2** Eject button: Press this button to eject a DVD or CD.
- Manual eject hole: Use this emergency release to eject a DVD or CD when the Eject button does not work. For more information on manually ejecting a DVD or CD, see "Manually ejecting a disc" on page 4.

Chapter 2. Using the ThinkPad DVD Burner Ultrabay Serial ATA Drive

This section provides information on how to handle, load, and care for DVDs and CDs, and how to care for your drive.

Before you begin

For best results, review the following guidelines before using the drive:

- Do not move your ThinkPad computer while formatting or writing to a disc as this might cause data errors. Also, minimize typing while formatting or writing to a disc, as this might also cause data errors.
- Keep your ThinkPad computer on a flat surface when writing to a disc.
- Make sure your ThinkPad computer is plugged into an AC outlet when using the drive. The disc might be damaged if the battery runs out while writing to a disc.
- Turn screen savers off. Using a screen saver might interrupt the formatting and writing process.
- · Do not put your ThinkPad computer into hibernation or suspension mode while writing to a disc.


Note: The read and write results of the drive depend upon the quality and characteristics of the DVD or CD media used.

Caring for the drive

To protect your drive during operation, follow the precautions as following:

- Remove the disc from the drive before moving the drive.
- · Do not insert foreign objects into the drive.
- · Do not stack objects on the drive.
- Do not remove the drive cover or attempt to service the drive.
- Do not operate the drive under any of these conditions:
 - High temperature, high humidity, or direct sunlight
 - Excessive vibration, sudden shock, or inclined surface
 - Excessive dust

Loading a disc



- 1. Press the Eject button. The tray slides out of the drive.
- 2. Place a disc in the tray with the label facing up.

3. Close the tray by gently pushing the tray in until it latches.


Attention: Do not use force or insert foreign objects to open the tray. If your tray does not open when you press the Eject button, see "Manually ejecting a disc" for more information.

Securing a disc in a vertically mounted drive

The drive has four retainers molded into the loading tray for vertical mounting operation. To insert a disc, place it in the lower two retainers before closing the tray. To remove a disc, open the tray and lift the disc from the two lower retainers.

Manually ejecting a disc

If you press the Eject button and the tray does not slide out, turn off the computer and straighten a large paper clip to form a tool, as shown in the figure below. The straightened end must extend at least 45 mm (1.8 inch). Insert the extended end into the manual-eject hole on the front of the drive. Push the paper clip until the tray opens. Gently pull out the tray until you can remove the disc.



Using media

This section contains information on using media.

Handling and caring for a disc


Carefully handle and clean discs, especially writable media types such as CD-R and CD-RW discs, so that they remain readable. You can prolong the life of your discs by following the precautions below:

- Always store discs in their original packaging.
- · Always store discs out of direct sunlight.
- · Always store discs away from direct heat sources.
- Remove discs from the computer when not in use.
- · Check discs for cracks before each use.

IMPORTANT: Do not use discs that are cracked.

- Do not force discs into the computer or packaging.
- · Do not bend or flex discs.
- Do not use commercial cleaners to clean discs.
- · Do not write on the surface of discs.
- Handle discs by the edges or the center hole.
- · Do not touch the surface of discs.
- · To remove dust or fingerprints, wipe discs from the center to the edge with a soft, lint-free cloth.

Attention: Wiping a disc using a circular motion can cause data loss.




Your drive can use many different types of media. Not all media are used in the same way. The following sections describe what you can do with the different media types.

Using DVD-RAM media

DVD-RAM media are available in bare-disc or cartridge form. To use cartridge media in your drive, you must first remove the disc from the cartridge.

Removing the disc from the cartridge




Using the tip of a ball point pen, push and break the lock pin tab 1. To remove the disc, use a ball point pen to push down on the cartridge lid lock 2 and pull the cartridge lid out 3. When the cartridge lid is open, the disc can be removed.

Note: The cartridge lid lock and the cartridge lid tab are located on the side of some cartridges, as shown in 2a and 3a above.

Attention: Do not touch the recording area of the disc when handling bare media.

Returning the disc to the cartridge



To return the disc to the cartridge, align the label side of the disc **1** with the DVD-RAM cartridge label side. Insert the disc and close the cartridge lid **2**. A clicking sound will occur when the lid closes.

Precautions for handling

Be careful when handling the removed disc. Debris, dust particles, fingerprints, smears, or scratches may impair recording and playback of the media. To clean dust or other debris, use a CD Cleaning Kit. Use a soft, dry cloth to clean the disc. Do not use solvents to clean the disc surface. When labeling a disc, write only on the printed label side or the cartridge using a soft felt-tip marker. Keep out of direct sunlight, high temperatures, and humidity. Do not attach labels to either side of the disc.

Using single and double-sided DVD-RAM media

DVD-RAM media are available in single-sided and double-sided versions.

The 2.6 GB and 4.7 GB versions are single-sided. The 9.4 GB version is double-sided. To access the data on both sides of the media, you must remove the media from the drive, turn it over, and re-insert it into the drive.

Using CDs and DVDs

Complete these steps to read a data disc:

- 1. Turn on the computer.
- 2. Press the Open or Close button on the front of the drive.
- 3. Insert a disc or cartridge in the tray with the label facing up.
- 4. Close the tray by pressing the Open or Close button or by gently pushing in the loading tray. **Attention:** Do not use force or insert foreign objects to open the loading tray.
- 5. Wait until the drive busy indicator turns off, and then double-click **My Computer**.
- 6. Double-click the CD-ROM or DVD-RAM/DVD-R/DVD-RW icon.

Using CD-Rs and CD-RWs

The drive can write to both CD-R and CD-RW discs. CD-R discs cannot be erased, but can be used with standard CD-ROM drives and CD players.

You can use CD-R discs to record audio tracks, store data, archive files, and copy files from another CD.

CD-RW discs can be erased and rewritten, but can be used only with newer CD-RW-compatible CD-ROM and DVD-ROM drives. You can use CD-RW discs to back up, store, and update files or to copy files from another CD.

Notes:

- 1. CD-R discs are playable on audio CD players. CD-RW discs are not playable on most audio CD players.
- 2. The software included with this drive does *not* enable the drive CD-recording capabilities with DOS, Windows 3.x, or OS/2[®] operating systems.

For more information on using the software, refer to "Using Drag-to-Disc (DLA)" on page 8 and "Using Creator Business Edition" on page 9.

Using DVD-Rs and DVD-RWs

The drive can write to both DVD-R and DVD-RW discs. DVD-R discs cannot be erased, but can be used with standard DVD-ROM drives and DVD players.

You can use DVD-R discs to record audio tracks, store data, archive files, and copy files from another DVD.

DVD-RW discs can be erased and rewritten, but can be used only with newer MR- and DVD-RW-compatible DVD-ROM drives. You can use DVD-RW discs to back up, store, and update files or to copy files from another DVD.

For more information on using the software, refer to the Multimedia Center for Think Offerings and DLA help information on the Software and User Guide CD.

Installing software

After you have connected the Multi-Burner Drive, you can install application software from the Software *User Guide CD.* There are four software packages on the CD as following:

- Creator Business Edition and MyDVD: Install this software to record CDs, edit videos, and author DVD videos
- WinDVD: Install this software to play DVD videos
- Drag-to-Disc: Install this software if you want to use your Multi-Burner Drive as a floppy drive
- · UDF Reader: Install this software on your Windows operating system computers to read discs created with Drag-to-Disc.

Note:

- Creator Business Edition and MyDVD are installed and uninstalled together.
- Do not install both Drag-to-Disc and UDF Reader on the same computer.
- DLA and UDF Reader have both 32 and 64 bit versions. Install the one that matches your operating system.

Complete these steps to install software:

- 1. Insert the Software and User Guide CD into the CD/DVD Burner drive.
- 2. If the CD automatically starts, continue with Step 5.
- 3. If the CD does not automatically start, click Start, and then click Run.
- 4. In the Run box type *x*:\launch.bat, where *x* is the drive letter of the ThinkPad DVD Burner Ultrabay Serial ATA drive.
- 5. If you get a warning from Internet Explorer® about malicious scripts, right-click the warning bar, and select Allow Blocked Content.
- 6. Select **Software** from the left-hand navigation bar.
- 7. Check the boxes by the software that you wish to install.
- 8. Click **Go**. The software you selected will install silently.
- 9. Restart the computer after the completion message.

Note: If the software fails to install silently, you can select the individual packages for each software from the bottom line of the installation page.

Using Intervideo WinDVD player

This section describes how to use and customize the Intervideo WinDVD player. You can find current information on Intervideo WinDVD player in the readme file on the Software and User Guide CD.

Using WinDVD

When you insert a DVD video disc into the drive, the Intervideo WinDVD player will automatically start and begin to play the video disc. If the DVD disc contains both video and program content, the program content will automatically play.

To view the video content of a video or DVD disc, go to the **Start** menu, launch **WinDVD**, and click **Play**.

With Microsoft Windows XP, you can also play DVD Video content by using the Windows Media Player application.

Changing the DVD region code

Regionalization and Copy Protection (the DVD region code) uses the content scramble system (CSS) standard to prevent unauthorized duplication of the intellectual property rights distributed on DVDs. It was originally requested by the Motion Picture Association of America (MPAA) to address video piracy, but is applicable to any content. CSS works by inhibiting the transmission of unencrypted data without proper authorization. Playback systems must license CSS to decode the encrypted data.

The CSS specification divides the world into seven unique regions. Content designated for one region cannot be read by playback systems in another region. While CSS is used to prevent digital copies of the DVD content, another technology devised by Macrovision is used to prevent analog copies of the DVD content. The Macrovision standard is a scrambling system widely used by the movie industry to prevent unauthorized duplication of video content using commercial VCRs. DVD playback systems must support both CSS and Macrovision copy protection standards.

The first time that you insert a DVD video disc into the drive, you will be prompted to set the region. If you relocate to a different region of the world, you can use the DVD player software to change the region code.

Note: You can change the DVD region code only five times. After you make five region code changes, the drive can play only MPEG-2 video titles that are associated with the fifth region code that you set.

To change the region code, complete these steps:

- 1. Turn on your computer and start your operating system.
- 2. Click Start.
- 3. Select Programs.
- 4. Click Intervideo WinDVD.
- 5. Click Intervideo WinDVD.
- 6. Click the **Properties** icon to open the Properties window.
- 7. Click the **General Properties** tab.
- 8. Insert a single region DVD of the new region.
- 9. Select the correct region code for your country.
- 10. Click OK.

Using Drag-to-Disc (DLA)

Drag-to-Disc (DLA) is provided so that you can write data to DVD-RAM, DVD-RW, DVD+RW, DVD+R, CD-R, and CD-RW media. DVD-RAM, DVD-RW, DVD+RW, and CD-RW media can be written to many times, while DVD-R, DVD+R, and CD-R media can only be formatted and written to once.

To format and write to DVD-RAM, DVD-RW, DVD-R, DVD+RW, DVD+R, CD-R, or CD-RW media:

- 1. Insert a disc into the drive.
- 2. Double-click **My Computer**. Right-click the CD/DVD Burner drive letter.
- 3. Click Format. Formatting a DVD can take up to 90 minutes.
- 4. After formatting is complete, you can drag-and-drop files to the CD/DVD Burner drive icon, or you can move files in Windows Explorer.

To make CD-R and DVD-R media compatible in other computers, complete these steps:

1. Double-click **My Computer**. Right-click the CD/DVD Burner drive letter.

2. Click Make Compatible.

A UDF Reader is included on the Software and User Guide CD. To use the UDF Reader to read UDF formatted CD-RW media, complete the following steps:.

To use the UDF Reader, complete these steps:

- 1. Insert the Software and User Guide CD into the CD or DVD drive of the computer you want to use the UDF formatted discs with. The CD will play automatically.
- 2. Select **Software** from the navigation menu.
- 3. Select the proper UDF Reader for your operating system. Both 32 and 64 bit versions are included in the installer list.

Notes:

- 1. The UDF Reader is only needed on systems that do not have another DLA program installed.
- 2. If the "Use with DLA" menu item is not selected in Windows XP, the Windows XP CD recording will be used.

Using Creator Business Edition

You can use the Creator Business Edition application to burn data, audio, video, CD and DVDs. You can also access tools and utilities for working with rewritable media. The Creator Business Edition application also has projects to manage disk images and create file backups.

To start the Creator Business Edition application in Windows XP, click Start -> All Programs -> Roxio Creator Small Business Edition -> Creator Home.

When Creator Business Edition first starts, you are taken to a Quick Links page. This page shows the four frequently used tasks for your convenience. To make an audio or data disc, select the appropriate tab and select the task you want to perform. To copy a disc, make a disc image, or burn a previously saved image, select the Copy tab. To use Drag-to-disc (DLA), select the Data tab. To erase a rewritable disc, select the Tools tab.

To make a bootable CD or DVD, begin a data project and click the bootable CD button in the upper right corner of the project window. You will be prompted to select a boot image from your hard disc or make a boot image from a floppy disc.

For detailed instructions on using Creator Business Edition, consult the on-line helps.

Copying and imaging discs

You can use the Creator Business Edition application to make copies and save images of your CDs. You can also create CDs from images that you have previously saved on your hard disk drive. The Creator Business Edition can only save images in ISO and GI formats. ISO formats can only be used for data CDs. All other disc formats require GI images.

Saved CD images can be as large as 730 MB, and saved DVD images can be as large as 8.6 GB. Ensure that you have adequate hard disk drive space before proceeding.

To make a CD image, complete the following steps:

- 1. Start the Creator Business Edition application.
- 2. Click the **Copy** page.
- 3. Click the task Save Image to Hard disk.
- 4. The application creates a random name for you. Rename the image file.
- 5. Insert the disc that you are imaging.
- 6. Click the Record button.

Notes:

- 1. DLA CDs cannot be saved as image files.
- 2. Protected commercial CDs cannot be imaged.

To burn a previously saved image, complete the following steps:

- 1. Start the Creator Business Edition application.
- 2. Click the Copy page.
- 3. Click the task Burn Image to CD or DVD.
- 4. Use the Browse button to navigate to the image that you want to burn.
- 5. Insert a blank or erasable disc.
- 6. Click the **Record** button.

To copy a disc, complete the following steps:

- 1. Start the Creator Business Edition application.
- 2. Click the **Copy** page.
- 3. Click the task Copy a disc.
- 4. Insert the disc that you want to copy.
- 5. Click the **Record** button.
- 6. When prompted, insert the target disc.

Notes:

- 1. Protected CDs cannot be copied.
- 2. Copying or imaging discs without the copyright owner's permission can result in legal penalties. For more information on copyright law, consult your legal advisor.

Using MyDVD

With MyDVD, you can edit and record video and audio files. You can also use MyDVD to create and record DVD videos using your own video and audio files. You can start MyDVD from the **Start** menu or from the video tasks in the Creator Business Edition.

When you start the MyDVD program, you enter a workspace where you can add your own videos and make a menu layout for your DVD. Use the **Add Movie** button to import your own videos into your DVD. By selecting a video clip and choosing Edit Movie, you can change your video's length, add subtitles, add effects, and change the movie format. You can also add transitions, audio tracks, and chapters to the DVD. You can import your own still images as menu backgrounds or select one of the sample images. You can also preview your video during the authoring process. When your movie is ready, you can save the output as files on your hard disc, burn to a disc, or save as a disc image for later burning.

To capture media from a camera, select the **Capture** task in the Creator Business Edition, or select the **Roxio Media Import** item in the **Start** Menu.

Chapter 3. Troubleshooting

Computer problems can be caused by hardware, software, or user errors. The information in this section might be useful to help you solve problems or to gather helpful information you can pass on to a service technician. You might also need to refer to your computer, operating-system, or sound-adapter publications.

Review the following list for any problem descriptions that might fit your situation.

You cannot create a multi-session disc.

Be sure that there is enough space left on the disc for another session. Writing a session requires lead-in and lead-out space (about 15 MB) in addition to the data that is recorded.

You cannot successfully write to a CD-R, CD-RW, DVD-R, DVD-RW, or DVD-RAM disc.

Complete these steps:

- 1. Verify that the process is not being interrupted by a screen saver, an antivirus program, an Internet or e-mail program, or other software. Disable the functions that might interrupt the write operation.
- 2. Verify that the hard disk drive has been defragmented.
- 3. Consult the hard disk drive manufacturer or vendor if an older hard disk drive is conducting a thermal recalibration during a write operation.
- 4. Replace the CD if it is bad or scratched.
- 5. Disable the Windows Auto Insert Notify function on your CD-ROM and CD-RW drives.

You cannot eject a CD or DVD disc.

Complete these steps after ensuring that the drive is not in the process of writing to a disc:

- 1. Eject the CD through software.
- 2. Use the Eject button.
- 3. Turn off the computer. Wait 45 seconds, then turn on the computer and try using the Eject button again.
- 4. If other methods do not work, use the manual-eject hole. Refer to the instructions in "Manually ejecting a disc" on page 4.

You cannot read from the CD or DVD disc after successfully writing to it.

Complete these steps:

- 1. If you can read the CD or DVD Disc in another CD or DVD player or you can see previous sessions, the directory information might be damaged on the volume, making it unreadable. To get ideas for troubleshooting, check the documentation that comes with the software.
- 2. You might have a damaged CD-R, CD-RW, DVD-R, DVD-RW, or DVD-RAM disc. Try a new disc or another brand of CD or DVD disc.
- 3. If you can read from a CD-RW, DVD-RW, or DVD-RAM disc in the writing drive, but not in another CD drive, be sure that a UDF Reader program is installed in the computer.
- 4. Avoid writing at the slower 1X speed unless required by your computer.

You suspended your system and DVD playback will not resume.

This is normal with some device drivers. Playback will continue after you exit and restart WinDVD.

Unable to Create Overlay Window message appears when you use WinDVD with Windows 2000.

Complete these steps:

- 1. Your video device driver needs an update to enable overlay support. Contact the manufacturer of your video adapter or your computer for updates.
- 2. The resolution of your screen might be too high. Try setting the resolution to 800 x 600 x 16 bpp at 60 Hz.

DVD movies do not start automatically when inserted into the drive.

Complete these steps:

- 1. Under Windows 2000, DVDs that contain both programs and DVD Video content will autoplay the program content. To view the video content, start WinDVD manually.
- 2. Under Windows XP or Windows Vista, you have chosen to always start data discs in file only mode. Refer to the Windows online manual for information on restoring program defaults.

Video appears to be choppy or is dropping frames.

The resolution of your screen might be too high. Try setting the resolution to 800 x 600 x 16 bpp at 60 Hz.

DVD-R DL media cannot be read in other computers after burning.

Complete these steps:

- 1. Check with your manufacturer to be sure that the drive can read DVD+R DL and DVD-R DL media.
- 2. Complete these steps to enable IMAPI for Windows XP:
 - a. Double-click My Computer.
 - b. Right-click on the DVD reader drive.
 - c. Select **Properties**.
 - d. Click Recording.
 - e. Check the Enable CD Recording on this drive checkbox.
 - f. Click Apply.
- 3. Try installing the UDF reader in another computer.

A direct-to-disc media occurred and you cannot eject the disc or shut down the computer.

Complete these steps:

- 1. Wait for a few minutes until the drive light flashes and goes out, then try again.
- 2. Eject the disc. Open Task Manager and end the task DLAWCRTL.EXE.
- 3. Turn off the computer.

THIS WARRANTY IS YOUR EXCLUSIVE WARRANTY AND REPLACES ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES APPLY ONLY TO THE EXTENT REQUIRED BY LAW AND ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION ON DURATION MAY NOT APPLY TO YOU.

How to Obtain Warranty Service
