
PROPANE CONSTRUCTION HEATER OWNER'S MANUAL

The heater is designed for use as a construction heater in accordance with ANSI Z83.7•CGA2.14. Other standards govern the use of fuel gases and heating products for specific uses. Your local authority can advise you about these. The primary purpose of construction heaters is to provide temporary heating of buildings under construction, alteration or repair. Properly used, the heater provides safe economical heating. Products of combustion are vented into the area being heated.

We cannot foresee every use which may be made of our heaters. **Check with your local fire safety authority if you have questions about heater use**.

Other standards govern the use of fuel gases and heat producing products for specific uses. Your local authorities can advise you about these.

Carbon Monoxide Poisoning: Some people are more affected by carbon monoxide than others. Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness, and/or nausea. If you have these signs, the heater may not be working properly. **Get fresh air at once!** Check for proper ventilation and have heater serviced.




Propane Gas: Propane gas is odorless. An odor-making agent is added to propane gas. The odor helps you detect a propane gas leak. However, the odor added to propane gas may fade. Propane gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this heater.

- Install and use heater with care. Follow all local ordinances and codes. In the absence of local ordinances and codes, refer to the *Standard for Storage and Handling of Liquefied Petroleum Gas, ANSI/NFPA 58* and the *Natural Gas Installation Code, CAN/CGA B149.2*. This instructs on the safe storage and handling of propane gases.
- Use only the hose and factory preset regulator provided with the heater.
- Use only propane gas set up for vapor withdrawal.
- Provide adequate ventilation. Before using heater, provide at least a 2.5-squarefoot opening of fresh, outside air. This heater produces carbon monoxide, which is listed by the State of California as a reproductive toxin under Proposition 65.
- For indoor use only. Do not use heater outdoors.
- Do not use heater in occupied dwellings or in living or sleeping quarters.
- Do not use heater below ground level. Propane gas is heavier than air. If a leak occurs, propane gas will sink to the lowest possible level.
- Keep appliance area clear and free from combustible materials, gasoline, paint thinner, and other flammable vapors and liquids. Do not use heater in areas with high dust content.
- Minimum heater clearances from combustibles: Sides: 4 Ft. Top: 6 Ft.
- Keep heater at least six feet from propane tank(s). Do not point heater at propane tank(s) within 20 feet.
- Keep propane tank(s) below 100° F.
- Check heater for damage before each use. Do not use a damaged heater.
- Check hose before each use of heater. If highly worn or cut, replace before using heater.
- Locate heater on stable and level surface if heater is hot or operating.
- Not intended for use on finished floors.
- Never block air inlet (bottom) or air outlet (top) of heater.
- Keep heater away from strong drafts, water spray, rain, or dripping water.
- Do not leave heater unattended.
- Keep children and animals away from heater.
- Never move, handle, or service a hot, operating, or plugged-in heater. Severe burns may result. Wait 20 minutes after turning heater off.
- To prevent injury, wear gloves when handling heater.
- Never attach duct work to heater.
- Do not alter heater. Keep heater in its original state.
- Do not use heater if altered.
- Turn off propane supply and unplug heater when not in use.
- Use only original replacement parts. This heater must use design-specific parts. Do not substitute or use generic parts. Improper replacement parts could cause serious or fatal injuries.



UNPACKING	 Remove all packing items applied to heater for shipment. Keep plastic cover caps (attached to inlet connector and hose/regulator assembly) for storage. Remove all items from carton. Check all items for shipping damage. If heater is damaged, promptly inform dealer where you bought heater.

PROPANE SUPPLY	You must provide propane gas and propane tank(s). Use this heater only with a propane vapor withdrawal supply system. See Chapter 5 of the <i>Standard for Storage and Handling of Liquefied Petroleum Gas,</i> <i>ANSI/NFPA 58</i> and/or <i>CAN/CGA B149.2.</i> Your local library or fire department will have this booklet.						
	This heater will operate with a 20-pound propane tank. However, you can only operate it in the LOW position during mildly cool weather. At higher heat settings or during colder weather, you must use larger tanks.

	Provide at least a 2.5 square foot opening of fresh, outside air while running heater. If proper fresh, outside air ventilation is not provided, carbon monoxide poisoning can occur. Provide proper fresh, outside air ventilation before running heater.

5. Check all connections for leaks. Apply mixture of liquid soap and water to gas joints. Bubbles forming show a leak that must be corrected.

Never use an open flame to check for a leak. Apply a mixture of liquid soap and water to all joints. Bubbles forming show a leak that must be corrected. Correct all leaks at once.

6. Close propane supply valve.

OPERATION

Review and understand the warnings in the Safety Information section, pages 2 and 3. They are needed to safely operate this heater. Follow all local codes when using this heater.

To Start Heater

- 1. Follow all installation, ventilation, and safety information.
- 2. Locate heater on stable and level surface. Make sure strong drafts do not blow on heater.

WARNING

Fully close main burner valve before lighting pilot. If not, severe burns can occur. Do this by turning valve handle towards the OFF position until it stops.

- 3. Open propane supply valve on propane tank(s) slowly. *Note:* If not opened slowly, excess-flow check valve on propane tank may stop gas flow. If this happens, close propane supply valve and open again slowly.




Figure 4 - Main Burner Valve Handle, Automatic Control Valve Button, and Piezo Ignitor Button Locations

- 4. Push in and hold automatic control valve button (see Figure 4). Push piezo ignitor button (see Figure 4). You may need to push piezo ignitor button 3-8 times until the pilot lights. When pilot lights, keep automatic control valve button pushed in. Release after 30 seconds.

Note: If pilot fails to light, hose may have air in it. If so, keep automatic control valve button pressed and wait 20 seconds. Release automatic control valve button and wait 20 seconds for unburned fuel to exit heater. Repeat step 4.

- 5. If pilot light goes out, repeat step 4.
- 6. When pilot remains lit, fully open main burner valve. Do this by turning valve handle to the HIGH position. You can now position the handle to any setting between HIGH and LOW.

ACAUTION


Only use the main burner valve handle to adjust the burner flame. Always turn handle pointer to the HIGH position before turning it to a lower position. Never set handle pointer between the LOW and OFF positions.

Flame Patterns


Figure 5 shows a correct flame pattern. The burner flame is mostly blue with a slight yellow coloring on the ends.

Figure 6 shows an incorrect flame pattern. The flame is mostly yellow. The incorrect flame pattern results from running heater below the LOW position or from flashback.

Running heater below specified input rating may cause flashback. During flashback, the burner flame is mostly yellow. The flame will burn inside the burner tube, causing a roaring noise. If flashback occurs, turn heater off. After burner tube cools, restart the heater.


