


9VDC • 1500mA AC-to-DC Compact Power Adapter

Using Your Adapter

 Plug the correct size Adaptaplug onto the jack at the end of the adapter's cord.



- If your device's DC input jack is marked
 ● ⊕, align TIP on the adapter's jack with + on the Adaptaplug (shown).

CAUTION: Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.

- Plug the Adaptaplug into your device's DC input iack.
- Plug the AC adapter into an easily accessible power outlet located near the equipment.

- If this adapter is not compatible with the voltage and current requirements of your portable device, it can result in PERMANENT DAMAGE to the device.

- The power adapter's current (1500mA) must be equal to or more than the current needed by your portable device.
