



Battery Installation

- Locate the battery compartment on the bottom of the toy.
- Loosen the screws in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door.
- Insert three "C" (LR14) alkaline batteries.

Hint: We recommend using alkaline batteries for longer life.

- Replace the battery compartment door and tighten the screws with a Phillips screwdriver. Do not over-tighten.
- When sounds, or motions from this toy become faint or stop, it's time for an adult to change the batteries!

Battery Safety Information

Batteries may leak fluids that can cause a chemical burn injury or ruin your toy. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated on the battery compartment door.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the toy. Dispose of batteries safely. Do not dispose of batteries in a fire. The batteries may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the toy before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.



Spin & Learn




• Place any of the eight special blocks upright in the center of the carousel and press down. Hear about what's inside of each block followed by a fun sound effect!

• Press the action button to hear a fun tune and see the carousel spin around with flashing lights.


Five Sides of Busy Play!

- Press the lever and watch the blocks spill out!


Drop & Tumble

- Store up to 30 Peek-a-Blocks inside the large compartment.


Plug & Play
