

## **DESCRIPTION**

The LDC100 converts a DC drive auto iris lens to a video drive auto iris lens. The LDC100 has a built-in amplifier that increases the video signal to automatically operate the open/close commands of the lens.


# **INSTALLATION**

To install the LDC100 refer to Figure 1 and do the following:

- 1. Connect the LDC100 to the lens connector on the camera.
- Connect the video drive lens to the connector on the LDC100.
- 3. If the iris mode selector on the camera is set to DC, switch the selector to VIDEO.
- 4. Use a screwdriver and adjust the ALC and LEVEL settings for the best picture.

**ALC**—Allows a variable selection of light metering between average and peak levels.

**Level**—Adjusts the brightness of the image projected on the monitor.

#### WARRANTY

Pelco will repair or replace, without charge, any merchandise proved defective in material or workmanship for a period of one year after the date of shipment

Exceptions to this warranty are as noted below:

- · Five years on FT/FR8000 Series fiber optic products.
- Three years on Genex® Series products (multiplexers, server, and keyboard).
- Three years on Camclosure® and fixed camera models, except the CC3701H-2, CC3701H-2X, CC3751H-2, CC3651H-2X, MC3651H-2, and MC3651H-2X camera models, which have a five-year warranty.
- · Two years on standard motorized or fixed focal length lenses.
- Two years on Legacy®, CM6700/CM6800/CM9700 Series matrix, and DF5/DF8 Series fixed dome products.
- Two years on Spectra®, Esprit®, ExSite™, and PS20 scanners, including when used in continuous motion applications.
- Two years on Esprit® and WW5700 Series window wiper (excluding wiper blades).
- Eighteen months on DX Series digital video recorders, NVR300 Series network video recorders, and Endura™ Series distributed network-based video products.
- . One year (except video heads) on video cassette recorders (VCRs). Video heads will be covered for a period of six months.
- Six months on all pan and tilts, scanners or preset lenses used in continuous motion applications (that is, preset scan, tour and auto scan modes).

Method of return shipment shall be the same or equal to the method by which the item was received by Pelco.
