Tool required for battery replacement: Phillips screwdriver (not included).





### **Crib Attachment**

### **A** CAUTION


Always attach all provided fasteners (straps) tightly to a crib or playpen according to the instructions. Check frequently.



**Note:** If you are attaching this toy to a crib side rail that can be lowered and raised, make sure the crib side rail is in the raised (locked) position.

- Position the toy inside the crib.
- Wrap one of the toy's attachment straps around the crib rail.
- Fasten the attachment strap slot to the button on the back of the toy.
- Repeat this procedure to secure the other attachment strap.


**Note:** This toy should be snug against the crib rail and spindles. Use the strap slot that provides the tightest fit.



• Tie the toy's strings to a crib spindle. **Note:** It is better to tie the strings in a knot than a bow, since a bow may be easily untied.

## **Battery Replacement**

For best performance, we recommend replacing the batteries that came with this toy with three, new alkaline "C" (LR14) batteries.




- Locate the battery compartment on the back of the toy.
- Loosen the screws in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door.
- Insert three "C" (LR14) alkaline batteries.

Hint: We recommend using alkaline batteries for longer life.

- Replace the battery compartment door and tighten the screws with a Phillips screwdriver. Do not over-tighten.
- When sounds or lights from this toy become faint or stop, it's time for an adult to change the batteries!




Batteries may leak fluids that can cause a chemical burn injury or ruin your toy. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated on the battery compartment door.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the toy. Dispose of batteries safely. Do not dispose of batteries in a fire. The batteries may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the toy before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

# **Gentle Music or Upbeat Tunes!**




- To change modes, slide the switch to one of the three positions: soothe ]; amuse ]]; or off •.
- Set the volume switch on the back of the toy to low or high volume. **Hint:** If your child is not actively playing with this toy, it turns off automatically (sleep mode).
- $\bullet$  When your child is finished with this toy, slide the mode switch to the off position  $\bullet$  .



#### Soothe Mode

- Slide the mode switch to the soothe position **!**.
- Mom can press the triangle button to active 10 minutes of calming music, soft lights and a soothing rotating spiral.



#### Amuse Mode

- Slide the mode switch to the amuse position **II**.
- Baby can press the triangle button for lights, upbeat music and a shiny spinning spiral.

### Care

- Wipe this toy with a clean cloth dampened with a mild soap and water solution.
- Do not immerse this toy.
